INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of The Seeing Eye, Inc. Matched Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Seeing Eye, Inc. Matched Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of The Seeing Eye, Inc. Matched Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan, also known as a tax-sheltered annuity plan, covering all employees of The Seeing Eye, Inc. (the "Organization"), excluding leased employees or employees who normally work fewer than 20 hours per week. Employees are immediately eligible to enter the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective February 1, 2023, the Plan was amended to allow employees who work fewer than 20 hours per week to participate in elective deferrals.

The Plan is funded by one or more investment arrangements, including custodial accounts ("mutual funds") held by VALIC Trust Company Inc., as custodian, and fixed and variable annuity contracts issued by the Variable Annuity Life Insurance Company ("VALIC"), selected by the employer. Participants may no longer contribute their employee deferrals or employer match into the annuity contracts, with the exception of VALIC Fixed-Interest.

[2] Contributions:

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In no event may a participant's pre-tax contribution exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Matching contributions are made at a rate equal to a uniform percentage of the elective deferrals of each employee who is eligible for employer contributions. An employee in the eligible class shall be eligible for employer contributions upon the completion of one year of service. The Organization has discretion to vary the contribution rate and percentage. In 2024 and 2023, the Organization matched 100% of the participant pre-tax contributions of the first 3% of salary contributed, and 50% of the participant pre-tax contributions for the next 3% of salary contributed. Participants may change their contribution percentages at any time, subject to the limitations of biweekly payroll processing of elective deferrals. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

[3] Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contributions and (b) Plan earnings, and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[4] Vesting:

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the employer matching contribution portion of their account, plus actual earnings thereon, is as follows:

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

The Plan has assets invested in variable annuities and mutual funds. Loans are allowed from both.

Loans from the mutual fund investments are notes receivable from participants, and the loan funds are paid from the participant's account. Principal and interest are paid ratably through payroll deductions at an interest rate of prime plus 1%, as defined. As of December 31, 2024 and 2023, the prime rate was 7.5% and 8.5%, respectively. The interest rate on outstanding loan balances range from 4.25% to 9.50%, as of December 31, 2024 and 2023.

[6] Policy loans:

Participants may borrow from VALIC, the insurance company, and use their Plan account balance invested in the fixed annuity contract as collateral for the loan. The collateral must be 100% of the loan at the time the loan is originated, and payments on the loan are made outside of the Plan. As of December 31, 2024 and 2023, approximately \$26,000 and \$51,000, respectively, of Plan assets were pledged as collateral for such loans made by the insurance company. Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance, subject to annuity contract and Plan provisions. Loan terms range from one to five years in one-year increments, or longer for the purchase of the participant's primary residence, as defined.

During 2024, \$6,000 of Plan assets was distributed from the Plan, included as distributions, representing payout of collateral for defaulted loans of this type, which consists of employer and rollover components of participants' accounts for participants who are still employed by the Organization. Principal and interest are paid quarterly directly by the participant and each payment reduces the amount collateralized. The interest rate charged is based on Moody's Corporate Bond Yield Average. While the loan is outstanding, the amount held as collateral earns interest at the contractual minimum rate of 3%. The difference, or "spread," between the rate established by Moody's Corporate Bond Yield Average and the contractual minimum is retained by VALIC. Loans are reviewed annually at the loan anniversary date and the interest rate is adjusted if the rate is more than 0.5% different.

[7] Payment of benefits:

On termination of service including due to death, disability, or retirement, a participant or beneficiary may elect to receive a lump-sum amount, partial payments, installment payments or purchase an annuity contract equal to the value of the participant's vested interest in his or her account.

[8] Forfeitures:

Forfeited non-vested accounts may be used to reduce future employer contributions or pay Plan expenses, as defined. During the year ended December 31, 2024, \$1,163 of forfeitures were used to reduce employer contributions. Forfeited non-vested accounts available to reduce future employer contributions or pay Plan expenses at December 31, 2024 and 2023 were approximately \$4,492 and \$60, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

[2] Investment valuation and income recognition:

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[3] Payment of benefits:

Benefits are recorded when paid.

[4] Plan expenses:

Certain expenses other than participant investment advisor fees, and participant loan fees incurred in connection with the administration of the Plan, are paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements.

[5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Variable Annuity Life Insurance Company and VALIC Trust Company Inc. have certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - INVESTMENTS AT CONTRACT VALUE

The VALIC fixed funds, which include the Fixed Account Plus Fund of \$534,227 and \$642,581 as of December 31, 2024 and 2023, respectively, Short-Term Fixed Fund of \$311,970 and \$408,725 as of December 31, 2024 and 2023, respectively, and VALIC Fixed-Interest Fund of \$3,508,651 and \$3,561,471 as of December 31, 2024 and 2023, respectively, are fixed annuity contracts that are fully and unconditionally guaranteed by VALIC. During the accumulation phase, they provide a guarantee of principal and a guaranteed minimum rate of interest.

The fixed funds are reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the contract less any withdrawals.

VALIC Fixed-Interest – The VALIC Fixed-Interest contract provides a guarantee of principal and previously credited interest, as well as a minimum guaranteed rate for the life of the contract. At a minimum, the interest rate is declared annually and is guaranteed for that full year; however, rates may be declared from time to time during the year which are in excess of both the annual and lifetime guarantees. Participant transactions are affected solely at contract value.

The Plan may withdraw a portion of the accumulation value to provide participant benefits or transfers requested by participants to specific Plan-maintained investment facilities, excluding competing options. If the Plan includes a competing option, participant-requested transfers may be made only if the transfer amount remains in the receiving option for at least 90 days (equity wash provision).

Fixed Account Plus and Short-Term Fixed – The surrender value of the fixed interest options will never be less than the amount of the purchase payments allocated to the fixed interest options, less any amounts transferred to the variable investment options or withdrawn.

Fixed Account Plus – The participant may transfer up to 20% of the accumulated value allocated to Fixed Account Plus during each Certificate Year. If multiple transfers are made in a Certificate Year, the percentage of the accumulation value transferred each time will be added together to determine the 20% transfer limit for the Certificate Year. For each transfer, the percentage transferred is the ratio of the amount transferred to the portion of the accumulation value allocated to Fixed Account Plus immediately prior to the transfer. However, if following a 20% transfer, the remaining amount would be less than \$500; the participant may transfer the remaining amount.

After a transfer to the Short-Term Fixed Account, the participant may not make any transfer from the Short-Term Fixed Account for 90 days.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE E - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Unit Value Calculation Detail for Variable Annuity Products – The VALIC unit value calculations are performed by the Variable Product Accounting Department ("VPA"). VPA uses the Princeton Financial Systems application, Unit Value Trade System ("UVT"), to perform all unit value calculations on a nightly basis. The calculation is as follows:

The unit value calculation begins with the collection of the daily net asset value ("NAV") for each investment option offered to the VALIC Separate Account policyholders, as defined by each respective product prospectus. A fund accountant reviews the daily NAV, comparing the prior daily NAV to the change percentages of certain markets indices for reasonableness. UVT calculates the unit value by first creating a net investment factor ("NIF") for each mutual fund and price band (Mortality and Expense, less any reimbursements ("M&E")) offered. The NIF is derived by taking the current day NAV plus any per share amounts of reinvested dividends, short, or long-term capital gains, divided by the prior day NAV to come to a Gross Investment Factor ("GIF"). The daily M&E rate (defined by the prospectus) is then subtracted from the GIF to come to the NIF. The final step is completed by taking the prior day unit value, multiplied by the new NIF to determine the current day unit value, which is used as a practical expedient to measure fair value.

The above methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(B) The strategy of these investments is generally embedded in the name of the particular investment as shown on the supplemental schedule of assets held for investments. The Stock Index Fund seeks long-term capital growth through investment in common stocks that, as a group are expected to provide investment results closely corresponding to the performance of the S&P 500® Index. It normally invests at least 80% of assets in stocks that are in the index. The Mid Cap Index Fund seeks to provide growth of capital through investments primarily in a diversified portfolio of common stocks that, as a group, are expected to provide investment results closely corresponding to the performance of the S&P Mid Cap 400® Index. It normally invests at least 80% of assets in stocks that are in the index. The Science and Technology Fund seeks long-term capital appreciation. The fund normally invests at least 80% of assets in the common stocks of companies that are expected to benefit from the development, advancement, and use of science and/or technology. It may invest up to 50% of assets in foreign securities. The fund may invest up to 30% of assets in companies organized or headquartered in emerging market countries, but no more than 20% of assets may be invested in any one emerging market country. The Vanguard Windsor II Fund seeks to provide long-term capital appreciation and income. The fund invests mainly in large and mid-capitalization companies whose stocks are considered by an advisor to be undervalued. Undervalued stocks are generally those that are out of favor with investors and that the advisor feels are trading at prices that are below average in relation to measures such as earnings and book value. These stocks often have above-average dividend yields. It uses multiple investment advisors.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE F - TAX STATUS

The Plan has adopted a Volume Submitter 403(b) Plan sponsored by VALIC Retirement Services Company. On April 5, 2018, the Internal Revenue Service stated in an advisory letter that the Volume Submitter 403(b) Plan adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related accounts are exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related accounts are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are annuity contracts managed by VALIC and shares of mutual funds managed by VALIC Trust Company. VALIC and VALIC Trust Company are the Plan's insurance company and Custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the individuals in the Plan were \$62,935 for the year ended December 31, 2024.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, economic and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE I - MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE K - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Loans to participants per the statements of net assets available for benefits differ from loans to participants per the Form 5500 as of December 31, 2024 and 2023, because certain conditions apply to certain loans which cause the loans to be reported as a deemed distribution for tax purposes. These loans are properly reported as a Plan asset for financial statement purposes, as determined by the written terms of the Plan document, related Plan policies and procedures, and the loan document. The distributions per the statement of changes in net assets available for benefits differ from the distributions per Form 5500, because these loans were deemed distributed for tax purposes.
