## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Pension Committee  
G. O. Carlson, Inc. Employees' 401(k) Plan  
Oil City, Pennsylvania

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of G. O. Carlson, Inc. Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of G. O. Carlson, Inc. Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D, to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit

#### **NOTE A - PLAN DESCRIPTION**

The following description of the G. O. Carlson, Inc. Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all full-time employees of G. O. Carlson, Inc. (the Company) with at least two (2) months of service. Each employee becomes eligible on the first day of the month coinciding with or following the date on which they meet the eligibility requirements. The Plan has no age requirement. The Plan is subject to the provisions of ERISA.

The Plan sponsor has appointed an independent investment manager under Section 3(38) of the Employee Retirement Income Security Act of 1974 to manage the Plan's investment options.

As a designated ERISA Section 3(38) investment manager, the appointed fiduciary has been granted full discretionary authority and responsibility to select, monitor, and replace the Plan's investment options, including mutual funds and collective investment trust funds, consistent with the Plan's investment policy statement. This investment manager acknowledges its fiduciary status and responsibility in writing as required under ERISA.

The Plan sponsor and 401(k) Committee retains fiduciary responsibility for the prudent selection and ongoing monitoring of the Section 3(38) investment manager but does not make individual investment decisions within the Plan. All investment transactions are executed at the direction of the Section 3(38) investment manager and are reflected in the accompanying financial statements at fair value.

The Plan changed trustees from Fidelity Management Trust Company to Charles Schwab Trust Bank and adopted a non-standardized adoption agreement through EPIC Advisors, Inc. as of June 3, 2024.

##### Contributions

Eligible participants may defer up to 100% of their annual compensation, not to exceed the limits defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers) and voluntary after-tax contributions as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan sponsor has agreed to make a matching contribution of 100% of the first \$1,350 and \$1,200 contributed by participants for 2024 and 2023, respectively. Additionally, the Plan sponsor may also make a discretionary contribution on an annual basis.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested at a rate of 20 percent each year after two years of service, and is 100 percent vested after six years of credited service.

##### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The

loan interest rate, determined monthly, is set at prime rate, as defined by the Plan. Principal and interest is paid ratably through payroll deductions.

##### Payment of Benefits

On termination of service, participants will receive a lump-sum distribution or installment distributions of the amount equal to the value of the participants' vested interest in their account.

##### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,157 and \$22,163, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In 2024 and 2023, employer contributions were reduced by \$17,591 and \$39,127 and fees of \$15,991 and \$0 were paid from forfeited nonvested accounts, respectively.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The designated ERISA Section 3(38) investment manager determines the Plan's valuation policies utilizing information provided by the custodians. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded for Form 5500 purposes.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

---

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

#### Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

#### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* The Plan's investments include the Federated Capital Preservation Fund (the Fund), a stable value fund. The units of the collective investment trust are valued daily. The fund will attempt to maintain a stable value of \$10 per unit. The value of the unit is determined by subtracting total liabilities from total assets and dividing the remainder by the number of units outstanding. The Fund's underlying investments include guaranteed investment contracts ("GICs"), separate account GIC's, synthetic GIC's, and money market investments.

**NOTE D - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES (CONTINUED)**

by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank for the period June 4, 2024 to December 31, 2024 and Fidelity Management Trust Company for the period January 1, 2023 to June 3, 2024 (the trustees of the Plan).

**NOTE E - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Plan investments are invested in funds that were managed by Charles Schwab Trust Bank and Fidelity Management Trust Company during 2024 and 2023. They were custodians and recordkeepers as defined by the Plan, therefore, these transactions qualify as party in interest transactions. Fees paid for the administration of notes receivable from participants, benefits paid to participants and recordkeeping amounted to \$40,715 and \$26,297 for the years ended December 31, 2024 and 2023, respectively.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE G - TAX STATUS**

The Plan operated under a non-standardized adoption agreement in connection with a pre-approved retirement plan sponsored by EPIC Advisors, Inc. This pre-approved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
