Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Empire Die Casting Company 401(k) Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available as of January 1, 2025, December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the period and years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Empire Die Casting Company 401(k) Retirement Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for one-day period ended January 1, 2025, and as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:



NOTE 1 DESCRIPTION OF PLAN

The following description of Empire Die Casting Company 401(k) Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective October 1, 1988. The Plan has been amended throughout the years to comply with tax legislation and most recently was restated on January 1, 2022. The Board of Directors are responsible for the oversight of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors and the Plan administrator are responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2025, the Trustee of the Plan made the decision to merge the Plan with Kay Manufacturing Company, LLC 401(k) Profit Sharing Plan.

Eligibility

All full-time employees of Empire Die Casting Company (the Company) are eligible to enter the Plan upon attaining age 21 and after thirty days of service, as defined by the Plan document. In addition, the Plan entrance dates are the first day of each calendar month. Union and Nonunion employees' entry date are the first day of the month coinciding with or next following one month of service. Participants are eligible for the match component and profit sharing contribution if they meet the eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of eligible compensation as pre-tax 401(k) or Roth contributions, as defined by the Plan. However, contributions are subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. The Plan has an automatic increase feature where participants' deferral percentage will increase by 1% until the max of 10% is reached.

Contributions (Continued)

For each participating nonunion employee, the Company makes a matching contribution equal to the sum of 100% of the amount of the participants deferred compensation that is not in excess of 4% of the participants compensation, plus 50% of the participants deferred compensation that exceeds 4% of the participants compensation but not in excess of 6% of the participants total compensation. For the one-day period ended January 1, 2025 and years ended December 31, 2024 and 2023, the nonunion employee matching contribution totaled \$0, \$57,142 and \$122,952, respectively.

The Company may make discretionary profit sharing contributions and allocate these contributions at their discretion to certain employee groups. For the one day period ended January 1, 2025 and years ended December 31, 2024 and 2023, the Company made a union profit sharing contribution equal to \$0.35 per hour for each hour worked per week for union employees. For the one-day period ended January 1, 2025, and years ended December 31, 2024 and 2023, the profit sharing contribution to union employees totaled \$0, \$58,720 and \$58,374, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, profit sharing contribution, and an allocation of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions, matching contributions, if applicable, plus actual earnings thereon. Vesting in the discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service and vest 20% per year beginning in year two. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime plus 1.00%. Loan terms range from one to five years except for loans used for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, retirement, or separation of service, a participant or beneficiary may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment immediately. The Plan allows hardship distributions subject to plan provisions.

Forfeited Accounts

As of January 1, 2025, December 31, 2024 and 2023, forfeited nonvested accounts totaled \$47,507, \$47,507, and \$104,313, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. During the one-day period ended January 1, 2025, there were no forfeitures used to reduce employer contributions or to pay plan expenses. In 2024, employer contributions were reduced by \$57,380 and plan expenses paid were \$7,500, from forfeited nonvested accounts. In 2023, no forfeitures were used to reduce employer contributions or to pay plan expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors and Plan administrator determine the Plan's valuation policies utilizing information provided by the trustee, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and benefit payments are charged directly to the participant's account. Investment related expenses are included in the net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

On December 31, 2020, Empower acquired the retirement business of Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual, under a power of attorney granted to Empower, with respect to Empower's role as the administrator of this retirement business. Pursuant to certain reinsurance and administration agreements entered into between Empower Annuity Insurance Company of America (Empower) and Massachusetts Mutual Life Insurance Company (MassMutual), MassMutual has appointed Empower as MassMutual's administrative agent and attorney-in-fact to perform all necessary administrative services for group variable annuity and funding agreements issued by MassMutual.

Empower Annuity Insurance Company of America, and Empower Trust Company, LLC (Empower), the qualified institutions, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of January 1, 2025, December 31, 2024 and December 31, 2023, the statements of changes in net assets available for benefits for the one-day period ended January 1, 2025, and years ended December 31, 2024 and December 31, 2023, and the supplemental schedule of assets (held at the end of the year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units, as determined by the Insurance Company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 PLAN MERGER

Effective January 1, 2025, the Trustee of Empire Die 401(k) made the decision to merge the Empire Die 401(k) Plan with Kay Manufacturing Company, LLC 401(k) Profit Sharing Plan. Plan Assets of approximately \$4,260,000 were transferred out of the plan on January 6, 2025.

NOTE 6 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with MassMutual, who was acquired in 2020 by Empower (collectively, the insurance company). The insurance company maintains the contributions in a general account. These accounts are credited with earnings, based on the daily balance and the interest rate in effect, and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers but may not be less than 1%. The crediting rate is reviewed at the discretion of the issuers for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are not any events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle an amount different than contract value paid either within 90 days or over time.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by the Plan's insurance company. Therefore, investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

The Plan has investments in a collective trust fund (see note 4 regarding the pooled separate accounts). For the one-day period ended January 1, 2025 and years ended December 31, 2024 and 2023, the pooled separate accounts did not file a Form 5500 for the direct filing entity; therefore, the underlying assets have been reported on the Form 5500 Schedules D and H.
