## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Boys Electrical Contractors, LLC 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

Boys Electrical Contractors, LLC ("the Company") is the Plan Sponsor. The Plan is a defined contribution plan covering all eligible employees (except a resident of Puerto Rico or a signatory to a contract, letter of agreement or other document with the status of independent contractor are not entitled to benefits) of the Company who have completed three months of service, are age twenty-one or older with enrollment available the first day of each month once conditions are met. If the participant terminates employment after the eligibility requirements are met, and are later re-employed will be eligible to participate in the plan after one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Assets of the Plan are held by a plan trustee selected by the plan sponsor. The Company acts as plan sponsor.

**Contributions**

Each year, participants may contribute the lesser of \$23,000 (in 2024; thereafter as adjusted by the Secretary of the Treasury) or 90% of their pretax eligible annual compensation as defined in the Plan, provided the amounts do not exceed the annual limits imposed by the Internal Revenue Code. The plan also contains an automatic enrollment feature that will notify participants 30 days prior to eligibility and will begin to automatically deduct 3% of pay on a pre-tax basis as a deferral contribution to the plan. Participants may create an annual increase program to gradually raise the contribution rate each year until a contribution maximum of 6% is reached. Also, Participants are eligible to designate some or all of the deferred contributions as a Roth deferral contribution. The Roth contribution election is irrevocable (that is, Roth contribution cannot later be re-characterized as pre-tax deferral contributions). The Roth contribution amount will be included in taxable income for federal & state income tax purposes.

Participants may make additional deferral contributions during the payroll period(s) designated by the employer. The participant can defer a whole percentage between 1 and 100% of eligible compensation into the Plan by completing a special election form. The total of the additional, bonus, and regular deferral contribution for the year may not exceed 90% of the eligible compensation or other applicable IRS limits. Participants may also defer up to 1% to 100% of any bonus designated by the employer into the Plan subject to 90% of eligible compensation or IRS limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 (in 2024; thereafter as adjusted by the Secretary of the Treasury). Participants may also make after-tax contributions, money is held in a frozen account, and these funds can no longer be contributed to the deferred contribution account but

will remain invested in the Plan and any earnings grow tax-deferred. The Plan also accepts Employer Safe Harbor Matching and non-elective contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Plan provides for the Company to make a matching contribution only if the participant makes contributions. The matching contribution will include age 50 and over catch-up contributions and the employer match must be allocated to the participants account in the plan within the prescribed legal limits. Non-discretionary matching contribution will be computed based on the eligible compensation contributed to the Plan for each payroll period.

The Company has elected to make a safe harbor matching contribution of 100% of the participant's first one percent of eligible compensation, and 50% of the next five percent of the eligible compensation, contributed to the plan as deferred contributions.

The employer may designate all or a portion of any nonelective contribution for a plan year as "qualified nonelective contributions" and allocate to non-highly compensated employees to help the plan pass one or more annually required IRS code non-discrimination test(s). The participant will be 100% vested in these contributions.

Participants can roll over part or all of an eligible rollover distribution received from an eligible retirement plan (a "rollover contribution") into the Plan even if the participant has not yet satisfied the age and service eligibility requirements but the participant will not become a participant in the plan until eligibility and entry date requirements.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions, (b) plan earnings, and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are always 100% vested in rollover contributions, after-tax contributions, qualified nonelective contributions, deferred contributions and any earnings thereon. Participants receive vesting credit for the number of years worked for the employer. If participants terminate employment, they may be able to receive a portion or all of the account based on vested percentage.

Vesting under the Plan is based upon the elapsed time method. Hours of service are not counted and instead periods of services are computed. A period of service starts with the participants’ date of employment and, generally, ends on the date of termination. Only whole years of service with the employer will be counted to complete years of service for vesting purposes. If participants are less than 100% vested in the employer account, they will forfeit the non-vested portion. A forfeit will occur in the plan year that the participant receives a distribution of the entire vested account, or if the participant does not receive a distribution after five consecutive one year breaks in service. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan.

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive the vested account balance of either:

- Non-rollover distribution - A single lump-sum payment, subject to federal income tax withholding 20% of the taxable distribution and remaining amount paid to the participant
- Direct rollover distribution – a rollover directly into a Fidelity IRA, a non-Fidelity IRA, or to a new employer’s qualified plan. Federal income taxes will not be withheld on any direct rollover distribution
- Combination non-rollover distribution or direct distribution
- Partial withdrawals following termination

**Payment of Benefits**

Participants may defer receipt of a distribution until a later date except when the vested account balance is \$5,000 or less in which case the Plan administrator will direct the trust that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (“IRA”) for the participant’s benefit. If the vested account balance is \$1,000 or less the Trustee will distribute a lump sum payment to the participant, or if the participant elects, will be rolled-over to a different IRA provider, or another retirement plan eligible to receive the rollover contribution. Benefit payments include in-service, hardship withdrawals, and participant loans benefits are recorded when paid.

**Forfeitures**

For plan years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,782 and \$5,612, respectively. These accounts are used to reduce employer contributions and/or administration fees.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Date of Management’s Review**

Plan management has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued and has determined that no material transactions have occurred that would require recognition or disclosure in the financial statements.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management and the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

The Plan's administrative expenses that are directly related to the value of the investments under management are paid by the Plan and allocated to the individual participant accounts either proportionately or based on the value of the account balances or as an equal dollar amount based on the number of participants, depending on the nature of the expense.

**Income Taxes**

The Internal Revenue Service (IRS) has determined and informed the Third Party Administrator of the template plan adopted by the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. Management believes that no uncertain tax positions have been taken.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for the investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The following valuation methods and assumptions were used by the Plan in estimating the reported values for the investments described below:

*Mutual Funds* - The fair value of mutual funds is based on quoted net asset values of the shares reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. Mutual funds are classified as Level 1.

**NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The December 31, 2024 and December 31, 2023, Statement of Net Assets, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and accompanying notes to the financial statements were prepared in part or entirely from information certified by Fidelity Management Trust Company (the Trustee) in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$4,925,461 and \$3,620,676 at December 31, 2024 and 2023, respectively.

**NOTE 5 – LOANS RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts, up to 50% of their vested account balance, reduced by the highest outstanding loan balance during the preceding 12 months, or \$50,000 and limited by certain restrictions in the Plan document. Loan terms shall not be more than ten years, except certain loan transfers shall continue in effect until paid off or defaulted under the terms of the loan instruments. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by Plan administrator. Participants can have one outstanding loan at a time. Upon execution of the loan, the participant's account is deducted for a loan set up fee of \$75 per loan and an annual loan maintenance fee of \$25 for each loan. Principal and interest are paid ratably through payroll deductions. In the event of a default or termination of employment, the entire outstanding principal and accrued interest will be immediately due and payable. Any default in repayment to the Plan will result in treating of the balance due from the loan as a taxable distribution.

The loans receivable from participants amounted to \$118,808 and \$93,196 for plan years ended December 31, 2024 and 2023, respectively. Interest rate charged to participants range from 4.25% and 9.50% with interest income on loans receivable from participants of \$8,322 and \$4,537 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
