Therefore, instances that the Plan is not operating in accordance with plan provisions or deficiencies in internal control, including material weaknesses or significant deficiencies, may exist that were not identified.

Instances where the Plan is not operating in accordance with plan provisions may be indicative of a deficiency in internal control. A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A deficiency in design exists when (a) a control necessary to meet the control objective is missing, or (b) an existing control is not properly designed so that, even if the control operates as designed, the control objective would not be met. A deficiency in operation exists when a properly designed control does not operate as designed or when the person performing the control does not possess the necessary authority or competence to perform the control effectively.

A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected, on a timely basis.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Following are descriptions of other identified deficiencies in internal control that we determined did not constitute significant deficiencies or material weaknesses:

Ineligible Employees Participating in Plan

The Plan's internal controls for setting up and reviewing employee and union coding within the payroll system were not operating effectively in the current year, resulting in one union employee who was ineligible to be a participant in the Plan contributing in the current Plan year. This employee was identified in the year-end compliance testing and the contributions were refunded subsequent to year-end.

Omission of Participating Employer in Plan Documentation

Plan management did not have controls in place to ensure that all participating employers were listed in the Plan's governing documents. A new participating employer was added to the Plan in the current Plan year, but the Plan's governing documents were never formally amended to add this entity as a participating employer. The Plan submitted a request for this company code to be added as a participating employer, however, the Plan's recordkeeper only added this company code as a participating employer to the Plan site and did not formalize it in an amendment.
