Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jack in The Box EasySaver Plus Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i Schedule of Assets (Held at Year End) as of December 31, 2024 is presented for purposes presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following brief description of the Jack in the Box Inc. EasySaver Plus Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective April 1, 1983, most recently amended January 1, 2024, for the purpose of enabling employees to enhance their long-range financial security through regular savings with the benefit of Jack in the Box Inc. (the Company or Plan Sponsor) contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor makes contributions to the Plan and pays a portion of the administrative costs. Subject to certain restrictions, the Plan Sponsor has the authority and responsibility for the general administration of the Plan. The Chairperson of the Company's Board of Directors is authorized to appoint the members of the Administrative Committee (the Committee). The Charles Schwab Trust Company (Schwab or Trustee) serves as the trustee, and has the authority to hold, manage and protect the assets of the Plan in accordance with the provisions of the Plan. The recordkeeping administrative services are performed by Schwab Retirement Plan Services, Inc. (SRPS).

Effective January 1, 2024, the Del Taco Savings Plan merged into the Jack in the Box Inc. EasySaver Plus Plan. The net assets of the Del Taco Savings Plan totaling \$13,288,473, including loans of \$198,877, were transferred into the Jack in the Box Inc. EasySaver Plus Plan on January 14, 2024.

Eligibility

The Plan covers all employees of the Company, except for leased, non-resident alien, and union employees, who have attained age 21. Participation by eligible employees is voluntary and employees opt into the Plan should they decide to participate. Participants may enter the Plan quarterly on the first day of the first, fourth, seventh or tenth month following their date of hire for purposes of deferrals and safe harbor matching contributions.

Contributions

Participants can elect to contribute to the Plan any amount from 1% to 30% of their eligible compensation in 1% increments through payroll deductions not to exceed Internal Revenue Service (IRS) limits. Contributions can be made on both a pre-tax and/or Roth basis. The Company safe harbor contribution is 100% of the first 4% eligible of compensation, as defined by the Plan, that a participant contributes to the Plan. Participants who are or will be at least 50 years of age by the end of a calendar year are eligible to make additional catch-up contributions to the Plan subject to IRS limits. The Plan also allows for participants in a former employer's qualified plan to contribute direct rollovers to this Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and earnings thereon. Participant accounts are charged with administrative expenses paid by the

Plan based on specific participant transactions, as defined. The benefit to which the participant is entitled to the vested portion of their accounts.

Vesting

Participants have a fully vested interest in their contributions and Company contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the highest outstanding loan balance in the previous 12 months, if any. All loans must be repaid within five years or up to ten years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Committee. Interest rates range from 8.75% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of employment, or upon retirement, death, disability, a participant or beneficiary may elect to (a) receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or (b) roll over the value of the participant's vested interest in his or her account into another qualified plan or Individual Retirement Account (IRA). When a participant terminates employment and the value of the vested portion of a participant's account exceeds \$5,000, the Plan must receive the participant's consent to the receipt of the distribution. If, upon termination of employment, the value of the vested portion of a participant's account is \$5,000 or less, it will automatically be distributed as soon as administratively feasible. The Plan allows for in-service withdrawals upon attainment of age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan, with the exception of fully benefit-responsive investment contract, are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market

participants at the measurement date (the exit price). The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit Response Investment Contract

Net assets available for benefits attributable to the fully benefit-responsive investment contract are reported at contract value as the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Administrative expenses recorded in the Plan represent amounts incurred for recordkeeping services and other administrative type services, including expenses related to the processing of participant loans and distributions which are directly paid from each respective participant's account as permitted by the service agreement with the trustee, and are paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments on the Statement of Changes in Net Assets Available for Benefits.

Due to and Due from Brokers

Due to brokers and due from brokers include the amounts due to and from brokers for the settlement of purchase and sale transactions. These balances are not considered cash and short-term investments of the Plan. The recorded amounts for due from brokers and due to brokers approximate fair value due to their short-term nature.

Payment of Benefits

Payments to participants and beneficiaries are recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted process for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs or other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes to the methodology used as of December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and Schedule H, Line 4i, Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Company, the trustee, and the Standard Insurance Company, the insurance company, qualified institutions.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and ERISA-Required supplemental schedule.

5. Investment Contract with the Standard Insurance Company

The Standard Stable Asset Fund (SSAF) represents an investment contract entered into by the Plan with the Standard Insurance Company (Standard). Standard maintains the contributions in an unallocated fund, whose assets are invested with other assets in the general account of Standard. The account is credited with contributions and earnings on the underlying investments and charged for Plan withdrawals and administrative expenses by Standard. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for the credit risk of contract issuer or otherwise.

The Standard investment contract is considered fully benefit-responsive, and as such, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Participants may make direct withdrawals and transfers at contract value daily. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. The crediting interest rate is declared in advance and locked in for the calendar quarter, but it may not be less than 1%. Because the contract crediting rate is reset

quarterly at the current portfolio rate basis, the appropriate discount rate used in the calculation of the fair value of the deposit administration contracts equals the contract crediting rate.

Certain events limit the ability of the Plan to transact at contract value with the Standard. Such events include termination of the contract, spin-offs, divestitures, corporate relocations, layoffs, retirement incentive programs, partial or total Plan terminations, or the liberalization of Plan withdrawal or transfer rules. The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause. The Plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

6. Tax Status

The Plan uses a pre-approved plan document sponsored by Schwab Retirement Services (Schwab). Schwab received an opinion letter from the IRS, dated September 21, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Company believes that the Plan is qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023. Accordingly, no provision for taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their company contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by Charles Schwab Trust Company, the trustee of the Plan. Charles Schwab Trust Company receives payments of investment fees from the Plan assets for services rendered. The Plan also pay fees to Schwab Retirement Plan Services, Inc. for record-keeping services. Participant loan processing fees are paid to Charles Schwab Trust Company by participants. These transactions are considered to be exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.
