**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Beazley USA Services, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan, established by Beazley USA Services, Inc. (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (the “IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan was amended effective November 1, 2019 to include new participating employers Lodestone Security LLC and BHI Digital LLC.

***Eligibility***

Employees of the Company aged 21 and over are eligible for plan participation effective upon three consecutive months of service after the employee’s employment commencement date.

***Administration***

The Plan has multiple investment options for eligible employees. The board of directors of the Company makes decisions regarding plan administration. Fidelity Management Trust Company (“Fidelity”) provides trustee and discretionary recordkeeping, compliance, and administrative services and provides investment management services to the Plan. Arthur J. Gallagher & Co. provides plan review and coordinates plan changes with vendors.

***Contributions***

Participant Contributions

Each participant may contribute pre-tax contributions up to a maximum of \$23,000 and \$22,500 for the 2024 and 2023 tax years, respectively, in accordance with the IRC qualified retirement plan limits. Participants age 50 and older are eligible to make catch-up contributions of a maximum of \$7,500 in 2024 and 2023.

Participants must elect to participate in the Plan and are not automatically enrolled upon becoming eligible.

Participants may contribute amounts representing eligible rollover distributions from other qualified plans or individual retirement accounts (“IRAs”).

Employer Contributions

After completion of three consecutive months of service, the Company provides a match of 100% of participant contributions up to a maximum matching contribution of 5% of eligible pay (\$17,250 for the year ended December 31, 2024 and \$16,500 for the year ended December 31, 2023). Compensation eligible for deferral to the Plan is based on W-2 wages.

Participant pre-tax contributions and employer contributions, and earnings thereon, are not taxed until withdrawn. The maximum dollar amount of contributions may vary from year to year, based on the IRC limitations.

***Participant Investment Elections***

Participants may direct their deferral contributions and employer contributions among various investment options offered by the Plan. These investment options consist of mutual funds and a money market fund. Participants are allowed to change their investment options subject to certain restrictions. For example, the trustee may decline to follow a participant's investment direction to the extent that such direction would result in a prohibited transaction. Participants can elect to allow the investment manager to direct their investments, in which case the investment manager allocates employee and employer matched contributions among the available funds at their discretion.

***Participant Accounts***

On a bi-weekly basis, each contributing participant's account is credited with the participant's contribution and the Company match. Net income or loss attributable to the investments made by a directed account is allocated to the account in a manner that reasonably reflects the investment experience of the account and is credited daily. Investment fund earnings are reported net of expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are fully vested in their deferral contributions plus actual earnings thereon. Participants are 100% vested in the Company's matching contributions, plus earnings, upon electing to participate in the Plan after completion of three consecutive months of service.

***Notes Receivable from Participants***

A participant may apply for a loan to be made from their vested account balance in the Plan, not to exceed the lesser of (i) \$50,000 or (ii) 50% of the participant's vested account balance in the Plan. Repayments are made by semi-monthly deductions of fixed amounts from the participant's salary. All loans except those to purchase a primary residence must be repaid within five years. Loans to purchase a primary residence must be repaid within 10 years. Upon termination, participants are required to repay loans in full. Loans carry interest at prevailing rates. Loans outstanding as of December 31, 2024 and 2023 bear interest rates ranging from 4.25% - 9.5%. As of December 31, 2024, loan maturity dates range from March 2025 to February 2032.

***Payment of Benefits***

Upon termination of service, a participant with a vested account greater than \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's account, or various installment payout options, or may defer payment to a later date or elect to rollover their balance to other eligible plans. Participants with a vested interest less than \$5,000 may elect to take a lump-sum distribution or rollover their account balance to another qualified plan or IRA. The Plan allows for automatic distribution of a terminated participant's account balance totaling less than \$1,000. Participants must make an election of payout option on the distribution form. Distributions made to individuals who have not attained the age of 59½ may be subject to an early withdrawal penalty. Minimum required distributions begin when a participant reaches age 72.

The Plan's management also adopted a provision that permits eligible Plan participants to request penalty-free distributions within a year from the birth or adoption of a child up to \$5,000.

***Early Withdrawals***

Under certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, the employee contribution portion of their account balance. These conditions include unreimbursed medical expenses, the purchase of a principal residence, the payment of postsecondary tuition or to prevent eviction from or foreclosure on a principal residence. A participant's right to make deferrals to the Plan will be suspended for six months after the receipt of the hardship withdrawal. A participant may also make a withdrawal from their account when the participant attains age 59½ or incurs financial hardship.

***Participant Forfeitures***

Because participants are eligible for a matching contribution immediately upon eligibility for participation in the Plan, the effect is that such contributions are immediately vested when made, and thus participants' distributions are not subject to forfeiture of nonvested balances.

***Plan Expenses***

Certain investment management fees are netted with investment income, such as a one-time fee for establishing a loan. The Plan administrator may charge an individual participant a reasonable charge to offset the cost of making a distribution to the participant, beneficiary, or alternate payee. Plan administrative fees cover day-to-day expenses of the Plan including recordkeeping, accounting, legal and trustee services.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from reported results using those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Acquisition costs are included in the cost of investments purchased, and sales are recorded net of selling expenses.

***Notes Receivable from Participants***

Participant loans are required to be classified as notes receivable from participants for all periods presented in the financial statements. The loans are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan has included participant loans as notes receivable from participants in the statements of net assets available for plan benefits. Delinquent participant loans are reclassified as a distribution when a distributable event is deemed to have occurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Payment of Benefits***

Benefits are recorded when paid.

***Risks and Uncertainties***

The Plan invests almost entirely in mutual funds. Underlying investment securities that comprise mutual funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The disclosed fair value of assets has been classified based on a hierarchy defined by U.S. GAAP. The hierarchy gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest ranking to fair values determined using methodologies and models with unobservable inputs (Level 3). An asset's or liability's classification is based on the lowest level input that is significant to its measurement. For example, a Level 3 fair value measurement may include inputs that are both observable (Levels 1 and 2) and unobservable (Level 3).

The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's financial assets measured at fair value:

*Money Market Fund* - Investments in the money market fund are valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual Funds* - Mutual funds invest in securities, otherwise known as the underlying securities. Shareholders receive an equity position in the fund and, in effect, in each of its underlying securities. A share of the Plan's interest in the mutual fund is based on the values of the underlying assets of the fund minus its liabilities divided by the number of shares outstanding. The underlying assets consist of U.S. Treasury, agency, corporate, mortgage-backed, commercial mortgage-backed, and asset-backed securities, U.S. and international stocks, bonds and cash and cash equivalents. Investments in the mutual funds are valued at their respective exchange-traded net asset value per share/unit on the valuation date.

**NOTE 5 - PLAN TERMINATION**

Although the Company has expressed no intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Company shall make no further contributions. The Plan makes provisions for distribution and transfer to a successor plan in the event of termination; however, the Plan will terminate at the merger, liquidation, or dissolution of the employer.

**NOTE 6 - TAX STATUS**

The Plan is based on a prototype plan. The Internal Revenue Service informed the prototype plan sponsor, in an opinion letter dated June 30, 2020, that the form of the Plan is acceptable under the requirements of the IRC. An employer may rely on a favorable opinion letter issued to a prototype sponsor as evidence that the Plan is qualified under IRC Section 401(a) as provided in Revenue Procedure 2015-36. Although the prototype plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and being operated in compliance with applicable requirements of the IRC so that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of funds managed by Fidelity. Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as party in interest transactions. Certain legal and administrative expenses are paid by the Company. Administrative fees relating to accounting, benefits

administration and investment advisory services are paid by the Company. In addition, the Company pays certain legal fees related to the Plan design and administration. Notes receivable from participants also qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Other than described above or pursuant to certain trust agreements, the Plan does not have agreements or transactions with parties in interest.

**NOTE 8 - NONEXEMPT TRANSACTIONS**

As reported on the Schedule H, line 4a - schedule of delinquent participant contributions, certain Plan contributions related to the 2023 and 2022 Plan year were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company.

**NOTE 9 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

There were no subsequent events requiring adjustment to, or disclosure in, the Plan's financial statements.
