Years ended December 31, 2024 and 2023

1. Description of Plan

The Eastern, Velvac & Big 3 401(k) Plan (the Plan) is a defined contribution plan of The Eastern Company (the Company). The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan covers all full-time United States of America employees of the Company, except those covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 1, 2023, the Velvac, Inc. 401(k) Savings Plan and the Big 3 Precision Products, Inc. 401(k) Profit Sharing Plan were merged into the Plan and the Plan's name was changed from The Eastern Company Savings and Investment Plan to The Eastern, Velvac & Big 3 401(k) Plan.

Contributions

Participants may contribute any portion of their compensation up to the maximum allowed by the Internal Revenue Code (IRC).

Effective January 1, 2015, the Plan was amended to add a discretionary employer profit sharing contribution for eligible participants who were not eligible to participate in the Company's Salaried Retirement Plan. The Company may contribute a percentage of eligible compensation.

Effective June 1, 2016, the Plan was amended to increase the Company match to 50% of the first 6% of eligible compensation, up to a maximum of 3% of eligible compensation. In addition, the Company extended the discretionary employer contribution to all eligible participants of the Plan, and also added a transitional credit for all participants who were impacted by the freezing of benefits under the Company's Salaried Retirement Plan. This transitional credit is 0% to 4% based on the eligible participant's age on June 1, 2016. Finally, the Company instituted automatic enrollment whereby all new participants to the Plan would automatically be enrolled for 3% of eligible compensation on the 1st of the month following completion six months of employment. Employees have the ability to opt out of automatic enrollment.

The Eastern, Velvac & Big 3 401(k) Plan Notes to Financial Statements (continued)

1. Description of Plan (continued)

Contributions (continued)

Effective January 1, 2017, the Plan was amended to adopt a Qualified Automatic Contribution Agreement (QACA) applicable to all participants except those who have in effect a Salary Reduction Agreement as of January 1, 2017 regardless of the elective deferral amount under the agreement.

Effective April 1, 2023, the Plan was amended to allow participants to make Roth 401(k) contributions to their account.

Effective April 1, 2023, the Plan was amended to allow employees to become eligible to participate immediately upon hire date.

For the years ended December 31, 2024 and 2023, the Company made non - discretionary employer contributions of \$1,270,536 and \$988,756 and matching employer contributions of \$315,783 and \$290,765, respectively.

Participant Accounts and Forfeitures

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions and administrative expenses.

During the years ended December 31, 2024 and 2023, there were forfeitures and earnings thereon of \$149,887 and \$106,516, respectively, and the Company used \$74,166 and \$33,934 forfeitures to reduce employer contributions or administrative expenses, respectively. At December 31, 2024 and 2023, there were unallocated forfeitures of \$179,101 and \$103,380, respectively.

Vesting

Participants are immediately vested in their voluntary contributions. Vesting in the Company contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, 40% vested after three years, 60% vested after four years and 100% vested after five years.

Effective April 1, 2023, vesting in the Nonelective and Matching Company Contribution portion of participant accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year of credited service, 40% vested after two years, and 100% vested after three years. The Safe Harbor match is 100% vested after two years of service.

1. Description of Plan (continued)

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in 1% increments to any of the investment options. Participants may elect to change their investment options at any time throughout the Plan year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 1 to 5 years, however if the loan is for the purchase of a primary residence, the Plan administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear interest at the prime rate (as published in the *Wall Street Journal*) plus one percent, or such other rate as may be determined by the Plan Administrator to be a reasonable rate of interest. At December 31, 2024, outstanding loans bear interest at rates ranging from 4.25% to 9.50% and have maturities through 2031. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, the participant's beneficiary may elect to receive annual installments over a two-year period. In-service distributions are permitted after age 59 ½. Hardship distributions are also allowed for Plan participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles.

2. Significant Accounting Policies (continued)

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America, and as such, requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The shares of mutual funds are valued at quoted market prices.

The pooled separate account is valued at fair value based on the net asset value (NAV) of units held by the Plan. The NAV is based on the fair values of the underlying real estate investments which requires significant judgment and the use of unobservable inputs.

The fair value of the guaranteed investment contracts is based on the underlying inputs used by the insurance company to determine the contract's market value, including discount rates for contracts with similar duration and credit quality, and other observable market data.

The Plan's investment in the stable value fund is measured using the NAV per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*.

Fair Value Measurements

The Plan follows ASC 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

Fair Value Measurements

In addition to defining fair value, ASC 820 expands the disclosure requirements around fair value and establishes a fair value hierarchy for valuation inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety.

These levels are:

Level 1 - Inputs are based upon unadjusted quoted prices for identical instruments traded in active markets.

Level 2 - Inputs are based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The fair values are therefore determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

3. Summary of Information Certified by Trustees

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, and dividends and interest for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Trustees, as of and for the years ended December 31, 2024 and 2023, respectively.

4. Fair Value Measurements

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Investment Contracts

The Plan invests in guaranteed investment contracts with Principal Life Insurance Company. The guaranteed investment contracts are group annuity contracts that guarantee a principal and interest amount for a set period of time. The GIC does not meet the definition of a fully benefit-responsive investment contract (FBRIC) under ASC 962 and, accordingly, is reported at fair value in the financial statements.

The fair value of the guaranteed investment contracts is based on the underlying inputs used by the insurance company to determine the contract's market value, including discount rates for contracts with similar duration and credit quality, and other observable market data. As such, the guaranteed investment contracts are classified within Level 2 of the fair value hierarchy.

4. Fair Value Measurements (continued)

Pooled separate account

The Plan holds an investment in a pooled separate account that invests primarily in commercial real estate properties and related real estate investments. The pooled separate account is valued at fair value based on the net asset value (NAV) of units held by the Plan, as reported by Principal Life Insurance Company. The NAV is based on the fair values of the underlying real estate investments, which are determined using appraisals and other valuation techniques that incorporate significant unobservable inputs, including capitalization rates, discount rates, rental income assumptions, and comparable sales data.

Because the valuation of the underlying real estate investments requires significant judgment and the use of unobservable inputs, the pooled separate account is classified within Level 3 of the fair value hierarchy.

5. Income Tax Status

Effective January 1, 2009, the Plan formalized a new Plan Document related to a non-standardized 401(k) profit sharing plan, and received an IRS determination letter dated March 31, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

Effective April 1, 2023, the Plan adopted a new Plan Document in the form of a Fidelity Pre-Approved Plan Document. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Party-in-Interest and Related Party Transactions

Section 3(14) of ERISA defines party-in-interest transactions to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants, interest income from participant loans, administrative expenses paid by the Company and transactions with investment funds managed and held by the Trustee are considered party-in-interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities, such as mutual funds and a stable value fund. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan has evaluated events occurring between December 31, 2024 and October 6, 2025, the date the financial statements were available to be issued.
