Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bank of Luxemburg Employees' Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

Note 1: Description of Plan

The following description of the Bank of Luxemburg Employees' Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan established by Bank of Luxemburg, Inc. (the "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Directors is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring of investment performance.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility

Eligible employees include all employees over the age of 21 that have been employed with the Sponsor for a minimum of three months. Employees enter the Plan on the first day of each calendar quarter immediately following three months of service.

Contributions

Pretax and Roth deferrals up to 100% of eligible compensation are permitted, subject to the maximum amount allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. At the beginning of each plan year, automatically enrolled participants have their deferral percentage increased by 1% up to a maximum of 15%, unless an alternate election is made by the participant.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

The Sponsor contributes a safe harbor matching contribution of 100% of the first 3% of deferrals that a participant contributes to the Plan, plus 50% of the next 2% of contributions. The Sponsor may also make discretionary contributions at the option of its Board of Directors. To be eligible to receive a discretionary contribution, a participant must have at least 1,000 hours of service in the Plan year and be employed on the last day of the Plan year. There were no discretionary contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor safe harbor matching contributions and allocations of discretionary contributions and plan earnings or losses. Participant accounts are reduced by withdrawals and are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Sponsor safe harbor matching contributions plus actual earnings thereon. Vesting in the Sponsor's discretionary contribution portions of their accounts, plus earnings thereon, is based on the number of years of continuous service subject to a five-year schedule. Participants vest at a rate of 20% per year, beginning with the first year, and become fully vested after five years. In addition, participants become 100% vested upon reaching normal retirement age, death, or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have a maximum of two notes outstanding at one time. Note terms shall not exceed five years unless the note proceeds are used to purchase a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates of prime plus 1%. The interest rate on notes receivable from participants at December 31, 2024, range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions or through payments made directly by participants.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account as a lump-sum distribution or in installment payments. Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes and penalties) from their account balance. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

Note 1: Description of Plan (Continued)

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's discretionary contributions. There were no forfeited nonvested amounts at December 31, 2024 and 2023.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant notes are reclassified as benefit payments based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to withdrawals and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income. All other administrative expenses are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common/collective trusts: Fair value is estimated using net asset value ("NAV") as a practical expedient. NAV is determined by using the estimated fair values of the underlying assets held in the Funds at year-end. The use of NAV as fair value is deemed appropriate since the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

Pooled separate accounts: Carried at NAV per share or its equivalent and valued as a practical expedient. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV's share price is quoted on a private market that is not active; however, the share price is based on underlying investments, which are traded on an active market. These funds can have one transfer per 30 days with no other redemption restrictions. There were no unfunded commitments as of December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by Principal, the Trustee of the Plan and therefore, transactions with Principal qualify as party-in-interest transactions. Administrative and investment expenses paid by the Plan to Principal amounted to \$29,268 in 2024. Certain other fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment.

Spectrum Investment Advisors ("Spectrum") is the investment advisor for the Plan and, therefore, transactions with Spectrum qualify as party-in-interest transactions. Fees for investment management services paid to Spectrum were \$36,512 in 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Sponsor discretionary contributions.

Note 7: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
