(1) Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of Cactus Feeders, Inc. 401(k) Plan (the Plan) have been prepared utilizing the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair Value of Investments

The Financial Accounting Standards Board, Accounting Standards Codification number 820 (FASB ASC 820) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(1) Summary of Significant Accounting Policies, Continued

Fair Value of Investments, Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts Valued at the net asset value of units of the pooled separate account. The net asset value of the pooled separate account (PSA) is not publicly quoted, but is available to current investors. The net asset value is the basis for current transactions and the PSA can be redeemed at the net asset value as of the measurement date; providing for a readily determinable fair value. Participant transactions (purchases and sales) may occur daily.

Mutual Funds Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value of the collective investment trust is not publicly quoted, but is available to current investors. The net asset value is the basis for current transactions and the collective investment trust can be redeemed at the net asset value as of the measurement date; providing for a readily determinable fair value. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

All valuations of plan investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments are stated at fair values per data prepared and certified to by the custodian or reported by the broker holding such investments (see note 3).

Pervasiveness of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See above for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement. Notes receivable from participants data has been prepared and certified as complete and accurate by Principal Trust Company, the custodian of the Plan.

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan's sponsor. Expenses that are paid by the Plan's sponsor are excluded from these financial statements. Investment related expenses are included in net realized and unrealized gains on investments.

Revenue Recognition

Revenue recognition is the method used to determine if income has met the conditions of being earned and realized or is realizable. This balance can be a combination of earned dividends, interest and the gain or loss of earnings from individual investments into financial instruments such as common/collective trusts, the pooled separate accounts, and the master trust accounts.

Date of Trustee Evaluation

Trustees have reviewed events occurring subsequent to October 31, 2024 through October 8, 2025 for potential impact on the accompanying financial statements and disclosures herein.

(2) Description of the Plan***General***

The following description of the Cactus Feeders, Inc. 401(k) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was established by Cactus Feeders, Inc. for the benefit of eligible employees. Employees are eligible for participation after completing twelve months and 1,000 hours of service and reaching 18 years of age. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

Under the trust agreement, participants may elect to defer a portion of their eligible compensation, limited to certain annual maximums, and the employer will contribute such to the Plan. In addition, the employer will make matching contributions to an existing employee stock ownership plan (ESOP) on behalf of each participant based upon his elective deferrals. The employer may make additional discretionary contributions as well.

Also, as directed by the trust agreement, forfeitures by former participants of any employer contribution amounts will be available to reduce employer matching or discretionary contributions or administrative expenses of the plan (none available at October 31, 2024).

Net investment earnings or losses are allocated to the participants' accounts in the amounts actually earned or lost from investment options chosen by the participants.

Distributions

The trust agreement provides for benefits to be payable to participants or their beneficiaries (1) upon the retirement date of the participant, (2) in the event of the participant's death, or (3) in the event of termination of employment under all other circumstances. The trust agreement also provides for hardship and in-service withdrawals under certain conditions. Amounts allocated to participants who are no longer active but have not been paid at October 31, 2024 aggregated \$2,065,714.

Vesting

Participants are immediately 100% vested in salary deferred amounts, rollover contributions and matching contributions. Vesting in employer discretionary contributions begins after two years of service and participants become 100% vested after six years of service. Participants also become 100% vested in employer contributions upon normal retirement or becoming totally disabled.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined by the loan administrator, is set at a rate available for similar loans from commercial lending institutions. Principal and interest are paid ratably through payroll deductions over a maximum of five years. Payments are due at least quarterly.

Termination of the Plan

The trust agreement provides that the Plan may be terminated at any time by the employer. Upon termination of the Plan, each participant becomes fully vested and the balance of the funds allocated to each participant shall be distributed to the participants or their beneficiaries.

Related Party Transactions and Party-in-Interest Transactions

The Plan's sponsor paid certain administrative expenses, aggregating \$98,955 on behalf of the Plan in 2024. The expenses are not included in these financial statements. As the Plan sponsor these transactions qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Although the Plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified for tax-exempt status.

(5) Transfer from Cactus ESOP Plan

During the year ended October 31, 2024, the Plan received a transfer of \$41,729 of interest-bearing cash from an Employee Stock Option Plan established for the benefit of the same individuals who are participating in the 401(k) plan. The amounts transferred are available for self-directed investment at the discretion of the participants.
