### Opinion

## 1. Description of Plan

The following description of the Glenn O. Hawbaker, Inc. Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan provides health and other benefits covering all full-time employees of Glenn O. Hawbaker, Inc. and Hawbaker Engineering, LLC (collectively, the Company), and covered dependents. Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

The Company includes an option for medical benefits with a high deductible and health savings account. The health savings accounts are excluded from the Plan as outlined in the plan documents.

### Benefits

The Plan provides the following benefits: health benefits (medical, dental, vision, and prescription drugs) and life, accidental death and disability insurance coverage and an employee assistance insurance program to all full-time employees and their covered dependents. Health benefits to participants during periods of unemployment are continued provided they have met certain eligibility requirements. The Plan provides long term care benefits to full-time salary employees and a long-term disability insurance to full-time salary employees with six months of service. The Plan also provides a short-term disability insurance to all full-time employees with six months of service. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act.

Effective March 31, 2024, the Plan offers paid time off (PTO) benefits for full-time, hourly employees beginning on their hire date. The PTO benefits include days for the observance of holidays, designated by the Company.

### Insured Benefits

The Plan fully insures the life insurance benefits, accidental death and disability benefits, long-term disability benefits, long-term care benefits, short-term disability, vision and dental benefits. The Plan purchases annual contracts for these insured benefits. Premiums for insured benefits are paid from the assets of the trust. These payments are included in payments of premiums to insurance entities on the Statement of Changes in Net Assets Available for Benefits.

## Contributions

In addition to deductibles and co-payments, participants are generally required to contribute to the Plan to fund the cost of their health benefits on a weekly basis through payroll deductions. Amounts required to be contributed by participants are determined annually by the Company in accordance with the plan documents. The remainder of the funding required to pay benefits under the Plan is paid by the Company. The Company pays the full cost of fully insured benefits contracts and stop-loss insurance, other than dental and vision for dependents which is paid by participants through weekly payroll deductions.

## Stop-Loss Coverage

The Plan has a stop-loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop-loss coverage are paid from the assets of the trust and are included in payments of premiums to insurance entities on the Statement of Changes in Net Assets Available for Benefits.

## Self-Insured Benefits

The Plan self-insures medical and prescription drugs benefits. Claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative service only arrangement. The claims processor pays claims directly or on behalf of participants and is then reimbursed by the Plan's trust. Despite the Plan's utilization of a third-party claims' processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager which periodically makes refunds to the Plan based on the Plan's utilization pattern of specific drugs. These refunds are recorded as prescription drug rebates in the Statement of Changes in Net Assets Available for Benefits.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Interest-Bearing Cash

The Plan maintains interest-bearing checking accounts with a financial institution. Interest income related to the accounts is recorded in interest income on the Statement of Changes in Net Assets Available for Benefits.

### Payment of Benefits

Premiums paid by either the Company or the trust are recorded as payments of premiums to insurance entities in the accompanying Statement of Changes in Net Assets Available for Benefits.

Medical and prescription claim payments are recorded when paid by the third-party claims processor, and are included in self-insured claims paid, net in the accompanying Statement of Changes in Net Assets Available for Benefits. Amounts due to health claims processors that have yet to be reimbursed by the Plan are recorded as amounts due to claims processors on behalf of the Plan in the accompanying Statements of Net Assets Available for Benefits.

Hourly PTO program benefit distributions are recorded when paid by the trust are recorded as Hourly PTO program benefit distributions in the accompanying Statement of Changes in Net Assets Available for Benefits.

### Administrative Expenses

Substantially all administrative expenses of the Plan, that consist primarily of administrative fees to third-party administrative claims, are paid from plan assets. These expenses are recorded in the Statement of Changes in Net Assets Available for Benefits as administrative expenses. All other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

### Stop-Loss Refunds

Premiums for stop-loss insurance are included in payments of premiums to insurance entities in the Statement of Changes in Net Assets Available for Benefits. Net stop-loss refunds, which are recorded as a reduction in self-insured claims paid in the Statement of Changes in Net Assets Available for Benefits totaled \$843,009 during the year ended December 31, 2024, of which \$415,129 are recorded as a receivable on the accompanying Statements of Net Assets Available for Benefits at December 31, 2024.

### Benefit Obligations and Claims Incurred but not Reported

The Plan is self-insured for self-insured claims up to \$200,000 per claim. Stop-loss insurance coverage is maintained for claims in excess of this amount. The Plan's liability for claims incurred, but not reported is estimated by the Plan using historical data provided by the insurance providers who have been retained by the Company. Such estimated amounts are included in the accompanying Statements of Benefit Obligations.

As of December 31, 2024, the accrued hourly PTO benefit program balance represents the estimated amount of PTO earned by participants but not yet utilized or paid. The obligation is calculated based on participant service records and the applicable PTO accrual rates defined in the Plan document.

The accrued hourly PTO benefit program balance is included in the Statements of Benefit Obligations and totaled \$1,066,953 as of December 31, 2024.

The Plan's obligation for the accrued hourly PTO benefit program is not subject to actuarial valuation, as benefits are determinable and payable in the short term. The Plan does not provide for carryover or vesting of unused PTO over 160 hours as of the last day of the second week ending in December. Any accrued balance that exceeds 160 hours will be cashed out and paid in a lump sum, applicable to payroll withholdings.

## Subsequent Events

Subsequent events were evaluated through October 3, 2025, the date the financial statements were available to be issued.

## 3. Related-Party and Party in Interest Transactions

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are considered party in interest transactions under ERISA. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 4. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify benefits provided to, and contributions required of, participants or to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

## 5. Tax Status

The VEBA trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to 501(c)(9) of the Internal Revenue Code (IRC). The trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated May 15, 2010.

Management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 6. Risks and Uncertainties

Claims incurred but not reported are calculated based on historical trends of claims reported but not settled and claims that have been incurred but not reported. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

At December 31, 2024 and 2023, the Company maintained its interest-bearing cash at one financial institution, respectively.
