INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of CCG Services, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions and assets (held at year end) as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following description of the **CCG Services, Inc. Retirement Savings Plan** (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General** – The Plan is a defined contribution plan established for the benefit of employees of the subsidiaries and affiliates of CCG Services, Inc. (collectively referred to as the "Company") which includes: CCG Services, Inc.; CORE Construction Services of Illinois, Inc.; CORE Construction Services of Texas, Inc.; Sun Valley Masonry, Inc.; Glenn Allen Insurance and Surety Brokers, LLC; MediCORE, LLC; CORE Construction, Inc.; CORE West, Inc.; CORE Construction Services of Florida, LLC; CORE Building Group, LLC; and CORE Construction Indiana, LLC. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- B. Administration of Plan assets** – The Plan's assets, which consist of mutual funds, a stable value fund and a self-directed brokerage account, are held by Fidelity Management Trust Company, the trustee of the Plan. Fidelity Workplace Services, LLC, provides recordkeeping and other administrative services to the Plan.
- C. Eligibility** – Full-time and part-time, non-union employees of the Company are eligible to make elective deferrals, receive Company safe harbor matching contributions, and receive Company discretionary non-elective profit sharing contributions after attaining 21 years of age.
- D. Contributions** – Each year, participants can make contributions to the Plan. Pre-tax contributions can be made up to 80% of eligible compensation, subject to IRC limitations. The maximum elective deferral for the year ended December 31, 2024 was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. For the year ended December 31, 2024, the Company's safe harbor matching contribution was calculated as 100% of the first 3% of eligible compensation each participant contributed to the Plan, plus 50% of the next 2% of eligible compensation contributed to the Plan up to a maximum of 4% of each participant's eligible compensation.
- E. Participant accounts** – Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, the Company's discretionary non-elective profit sharing contribution, and an allocation of Plan earnings. Allocations of Plan earnings are based on participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- F. Vesting** – Participants are immediately vested in their elective deferrals and the Company's safe harbor matching contributions.
- G. Notes receivable from participants** – Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with prevailing rates at the time the loan is made as determined by the Plan administrator. Principal and interest are ratably paid each pay period through payroll deductions.

- H. Payment of benefits** – Participants may take distributions from the Plan under the following circumstances: (i) at age 59½, (ii) at age 55 with 6 years of service, (iii) upon termination of service, and (iv) at retirement, death or hardship as defined by government regulations and the Plan.
- I. Administrative expenses** – Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Certain expenses are paid by the Company and are not expected to be reimbursed by the Plan.
- J. Participants' investment options** – Upon enrollment in the Plan, a participant must direct deferrals and employer contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via direct phone or internet access.

(2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and uncertainties – The Plan provides for various investment fund options, which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Loans are secured by the vested balance in the participant's account and bear interest at a fixed rate commensurate with prevailing market rates at the time the loan is made as determined by the Plan administrator.

Payment of benefits – Benefits are recorded when paid.

Subsequent events – The Plan’s management has evaluated subsequent events through October 3, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Fair value measurement

The Financial Accounting Standards Board’s Accounting Standards Codification Topic 820, *Fair Value Measurement* (FASB ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or collaborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end that are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Self-directed brokerage account: The self-directed brokerage account consists of common stocks, mutual funds, and cash. Common stocks are stated at fair value, which is based on the closing price reported on the active market which the common stock is traded. Mutual funds are valued at the NAV of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Stable value fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Information certified by the Plan's trustee (continued)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(5) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(6) Tax status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

(7) Party-in-interest transactions

Plan investments are managed by Fidelity Management Trust Company; therefore, these transactions qualify as exempt party-in-interest transactions. The net administrative fee paid to Fidelity Management Trust Company was \$151,141 for the year ended December 31, 2024. The Company is the Plan Sponsor and provides all matching contributions to the Plan; consequently, these transactions also qualify as party-in-interest transactions.

(8) Excess contributions refundable

The Plan is required to return contributions received during the year in excess of the IRC limits. At December 31, 2024 and 2023, amounts refundable by the Plan to participants for contributions made in excess of amounts allowed totaled \$3,513 and \$2,296, respectively. The amounts have been reflected as excess contributions payable in the accompanying statements of net assets available for benefits and as a decrease to participant contributions in the accompanying statement of changes in net assets available for benefits.

(9) Nonexempt transactions

Plan management determined that certain participant contributions submitted by the Plan Sponsor during the 2023 Plan year were remitted late based upon guidelines established by the Department of Labor. These contributions totaled \$12,154 and Plan Management has submitted lost earnings during the 2024 Plan year, which are not material to the financial statements as a whole.

In addition, certain Plan contributions totaling \$12,954 were identified as late during 2024 and are reported in the accompanying supplement schedule. Management is in the process of funding and correcting lost earnings, which are de minimis.
