Opinion

We have audited the financial statements of Sheet Metal Workers Union Local 24 Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, information regarding the plan's net assets available for benefits as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1 – PLAN DESCRIPTION

Sheet Metal Workers Local Union 24 Columbus Area Retirement Savings Plan (the Plan) was created by a trust agreement, effective January 1, 2001, by and between the Sheet Metal Workers International Association, Local 24 (the Union), and the Sheet Metal Contractors of Central Ohio, Inc. (the Association) and a Board of Trustees consisting of six members, three from each the Union and Employers' groups. Employers contribute to the Plan at the rate established under a collective bargaining agreement. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution pension plan covering, in general, members of Sheet Metal Workers Local Union 24 who are employed in the trade by union employers subject to the collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The contributing employers are primarily located in the Central Ohio and surrounding areas therefore subjecting the Plan to the economic conditions of that region.

Eligibility

Eligible participants include employees covered by the collective bargaining agreement that are Journeymen, 3rd or 4th year Apprentices, or Classified and Industrial Workers. Eligible participants do not include pre-Apprentices, 1st or 2nd year Apprentices.

Contributions

Each month employers contribute to the Plan based on eligible hours worked at a rate determined by the collective bargaining agreement. No employer or union shall be liable for contributions required to be made by any other employer. Participants may contribute qualifying rollovers from other qualified plans.

Employer contributions are recorded and accrued based on hours worked during the year by covered employees.

Participant Accounts

The Plan is a participant directed plan. All investment decisions are made by the Plan's participants. The investment options offered to the participants are determined by the trustees with consultation from investment advisors. Each participant will have an employer contribution and rollover account. Each account will be credited with the appropriate contributions and an allocation of net earnings or losses at each valuation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The account balance of a participant will be fully vested in the employer contributions and earnings thereon at all times.

Participant Loans

The plan does not provide for participant loans.

Payment of Benefits

On termination of eligibility due to normal retirement (age 65), early retirement (age 55), total and permanent disability, death, or termination of membership (less than 500 hours of service in a plan year), the participant will receive his account balance in a lump-sum payment.

Effective February 1, 2018, the Plan document was amended to update the policies regarding automatic distributions for eligible participants. On and after February 1, 2018, if the value of a Participant's vested account balance does not exceed \$5,000 (\$1,000 effective March 28, 2005 but prior to February 1, 2018), and such a participant is entitled to an early distribution from the Plan, the Administrator may immediately distribute such benefit without such Participant's consent.

Effective January 1, 2020, the Plan document was amended to allow hardship distributions of any amount provided they meet the IRS regulations related to such distributions.

Effective January 1, 2023, anyone who attains age 72 after January 1, 2023, must begin receiving the required distributions no later than April 1st after the year in which he or she turns age 73. You may delay this date even further if you are still actively employed with a contributing employer past age 73. The applicable age increases to 75 for participants who reach age 74 after December 31, 2032.

2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management Review

Subsequent events were evaluated through the date of the auditor's report, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value approximates the total cost of the investment plus accrued interest and contributions less any distributions.

Purchases and sales of securities are recorded on a settlement-date basis. Pending transactions are adjusted through cash equivalents. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses on investments that were both bought and sold during each year are included in net appreciation in fair value.

Payment of Benefits

Regular benefit payments to participants are recorded upon distribution.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Allowance for Doubtful Accounts

The Plan's administration has evaluated employer contributions receivable and has determined that an allowance for doubtful accounts was not necessary as all amounts are deemed to be fully collectible.

3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset of liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's Trustees believe that the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

4 – GROUP ANNUITY CONTRACT WITH PRUDENTIAL RETIREMENT INSURANCE AND ANNUITY COMPANY (PRIAC)

In 2022, the Plan entered into a traditional fully benefit responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company (PRIAC). PRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by PRIAC, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsors or other sponsors events (for example, divestitures or spinoffs of a subsidiary), that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The issuer of the agreement allows them to terminate the agreement with 90 days notice if they determine the continued operation of the Guaranteed Income Fund is no longer economically desirable, the Plan materially breaches its operational requirements under the agreement or fails to pay the expenses associated with the agreement. In such instances of termination, monies held in this agreement may not be disbursed for up to 90 days post termination.

The contract value at December 31, 2024 and 2023, was \$370,882 and \$133,130, respectively.

5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a guaranteed investment product all held with the Plan's custodian Empower Retirement. These organizations acted as the custodians as defined by the Plan, and, therefore, transactions with them qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management services are included in the net investment income in the accompanying statements of changes in net assets available for benefits. In addition to custodial services, included in the statements of changes in net assets available for benefits are transactions with the following parties-in-interest: The Plan utilizes third party administrator services provided by American Benefit Corporation, legal services provided by Ledbetter Parisi, LLC, audit services provided by Gray, Griffith, and Mays, A.C., investment advisory services provided by Standard Valuations, Inc. and insurance coverage provided by Marquette Associates and Standard Valuations, Inc.

6 – PLAN TERMINATION

Although they have not expressed any intent to do so, the Union and the Association have the right, by joint resolution, to terminate the Plan by delivering to the Trustees written notice of such termination subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be fully vested in their accounts.

7 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated July 17, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

8 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
