Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Wenger Corporation Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established by Wenger Corporation (the “Company”, “Employer” or the “Plan Sponsor”) to provide retirement benefits for eligible employees. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Fidelity Workplace Services, LLC is the Plan Custodian and Trustee. The Custodian and Trustee are responsible for holding the investment assets of the Plan and for processing and approving Plan distributions in accordance with Plan provisions. Effective March 15, 2021, the Plan adopted the volume submitter defined contribution plan established by Fidelity Management & Research Company (“FMRC”). The provisions within the Plan’s amended and restated adoption agreement are consistent with the provisions outlined below.

Eligibility

All employees of the Company become eligible to participate in the Plan if they are 18 years of age and after completing 90 days of recognized employment. Any employees that are covered by a collective bargaining agreement are automatically ineligible to participate in the plan. Eligible employees can enter the Plan the first day of any payroll period, following meeting the service requirement. An employee of the Company will become eligible to receive a portion of the profit sharing contribution as of January 1, immediately preceding the date of completion of one year (and 1,000 hours) of recognized employment.

Funding Policy

Participants may elect to defer 1% - 50% of their eligible compensation per year, in the form of pre-tax and Roth deferrals, subject to limits established by law. In addition, participants may make rollover contributions to the Plan and participants satisfying certain criteria are permitted to make catch-up contributions, as stated in the Plan agreement. The Plan provides for Employer matching contributions (equal to 25% of the first 4% of compensation deferred), Employer profit sharing contributions, and qualified non-elective contributions (when needed to help the Plan satisfy nondiscrimination requirements). The Employer profit sharing contributions are established by the Board of Directors of the Company and are discretionary. For the years ended December 31, 2024 and 2023, the Employer made profit sharing contributions of \$3,224,209 and \$1,697,036, respectively.

Vesting

Participants shall be fully vested in all accounts at all times.

Investment Options

All funds of the Plan are participant-directed. Participants may direct their accounts to be invested in one or more of the investment options available in the Plan and may transfer assets in their accounts between funds on a daily basis, except for the participant loan fund. The Plan currently offers mutual funds and collective trust funds as investment options for participants. Notes receivable transactions are treated as transfers between the investment funds and participant loan funds. Notes receivable from participants are subject to certain restrictions and the loan policy as adopted by the Plan.

Participants' Accounts

Participants' accounts are credited with participant contributions (elective deferral, Roth, catch-up, and rollover), Employer matching contributions, Employer profit sharing contributions and an allocation of Plan earnings or losses. Allocations are based on participant compensation or account balances as defined in the Plan. The benefit that a participant is entitled to is the participant's vested account balance.

Benefits Paid to Participants

On termination of service, due to death, disability, termination of employment or retirement, the payment of benefits method depends on the participant's account balance. For termination of the participants whose account balance is less than \$5,000, the participant shall receive the account balance as a lump-sum distribution or rollover. If the participant does not elect a lump-sum distribution or rollover and the total value of his or her account balance exceeds \$1,000, but does not exceed \$5,000, the trustee is directed to pay the distribution as a direct rollover to an individual retirement account or annuity. If the participant's account balance is less than \$1,000 and no election was made, a single lump-sum distribution will be provided to the participant.

In-service withdrawals from a participant's Roth after-tax and rollover accounts are available in accordance with the Plan agreement.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have up to 2 outstanding notes receivable. Notes receivable must be repaid within five years, or ten years if for a purchase of a home, and shall bear interest at the prime rate plus 1%, as determined by the Plan Administrator. All notes receivable are collateralized by the borrower's account. Principal and interest payments are paid through equal payroll deductions, with payments to be made not less frequently than monthly over the term of the notes receivable.

Forfeitures

Forfeitures of excess deferrals receiving applicable matching contributions are used to reduce the Employer matching contributions or, if directed by the Plan Administrator, can be used to pay administrative expenses of the Plan. During the years ended December 31, 2024, and 2023, there were \$0 and \$3,863 of forfeitures used to reduce Employer matching contributions, respectively. At December 31, 2024 and 2023, there were no unallocated forfeitures.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments Valuation and Income Recognition

The Plan's investments are reported at fair value. See Note C for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded at the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

The cost of administering the Plan, including advisor fees, are paid by the Plan participants, except legal and auditing charges that are paid by the Plan Sponsor.

Net Appreciation in Fair Value of Investments

Net appreciation in the fair value of investments represents the net realized gains and losses plus the net unrealized appreciation of investments. Realized gains and losses are the difference between the proceeds received and either the cost of the investments sold, determined on an average cost basis, or the fair market value at the end of the previous year, whichever is applicable. Net unrealized appreciation is the change in the difference between fair market value and the cost of investments or the fair market value at the end of the previous year, whichever is applicable.

Benefits Paid to Participants

Benefits paid to participants are recorded by the Plan when paid.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan will be distributed to the participants based on each individual participant's account balance. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE C - INVESTMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means; and
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Shares of registered investment companies are valued at the net asset value (“NAV”) of shares, based on active market prices, held by the Plan at year end.

Collective trust funds: Shares of interest in the collective trust funds are valued at fair value as reported by the investment manager at year end, using NAV as a practical expedient.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INCOME TAX STATUS

Effective March 15, 2021, the Plan adopted the non-standardized pre-approved profit sharing plan document sponsored by FMRC. The pre-approved plan document sponsored by FMRC has received an advisory letter from the IRS dated June 30, 2020, which states that the pre-approved plan document is designed in accordance with the applicable sections of the IRC. The Plan has not received a separate determination letter since having adopted the FMRC pre-approved plan document. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RELATED-PARTY TRANSACTIONS

Certain administrative expenses of the Plan, including audit and legal fees, are paid by the Plan Sponsor. Also, certain employees of the Plan Sponsor provide administrative services to the Plan at no expense.

Certain assets are invested in funds managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.
