We have performed audits of the financial statements of the 401(k) Plan of Care Plus Bergen for Union Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of the Plan

The following brief description of the 401(k) Plan of Care Plus Bergen for Union Employees (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Care Plus Bergen, Inc. (the Employer or the Company), covering substantially all employees covered by collective-bargaining agreements. Employees are eligible to participate in the Plan immediately upon their date of hire. The Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Teachers Insurance and Annuity Association of America (TIAA) holds the Plan's investments and executes investment transactions.

Contributions

Participants may contribute up to 100% of their pre-tax compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Roth contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Contributions are subject to certain annual limitations, as imposed by the Internal Revenue Code (the Code). The Employer matches deferrals for employees who have completed one year of service, as defined in the Plan document. Participants will be credited with a year of service at the end of the 12-month period beginning on the date of hire if they have been credited with at least 1,000 hours of service during such period, as defined in the Plan document. For the Plan year ended December 31, 2024, the Employer matched 50% of each participant's deferral contributions, up to a maximum of the following:

Completed Years of Service	Employer Match
1 to 5	Up to 1.50% of eligible earnings
5 to 10	Up to 1.75% of eligible earnings
More than 10	Up to 2.00% of eligible earnings

Participants' Accounts

Each participant's account is credited with the participant's contributions, the participant's allocation of the Employer matching contributions, the participant's proportional allocation of the Plan's earnings, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in that portion of their account that represents their contributions plus actual earnings thereon. Vesting in the Employer matching contributions plus earnings thereon is based on vesting years of service.

The Company's matching contributions will vest to the participants as follows:

5 or more	100

Participants become 100% vested in the Employer's contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age.

Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. Forfeiture allocations may be used to pay administrative expenses or to reduce Company contributions, in accordance with the Plan document. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$32,420 and \$20,025, respectively. For the year ended December 31, 2024, the Employer used \$43 of forfeited non-vested accounts to pay Employer matching contributions.

Payment of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death, or other separation from service. Distribution may be taken in the form of a lump sum or installment payments. A participant may also request a hardship withdrawal.

Notes Receivable from Participants

Participants could borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must bear a reasonable rate of interest commensurate with local prevailing interest rates, as determined by the Plan administrator. Loans are collateralized by the participant's non-forfeitable interest in the Plan and are supported by a promissory note. Loans must be repaid over a period not to exceed five years, unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. No more than one loan may be outstanding at any time. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Investment Options

A participant may direct his or her contributions to any of the various investment options available to the Plan. Participants may change their investment options at any time.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and Note 5 for a discussion on contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses, respectively, on investments bought and sold, as well as held, during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses incurred in connection with the administration of the Plan, with the exception of transaction fees paid by participants in initiating the transactions, are paid by the Company. Expenses that were paid for by the Company are excluded from these financial statements.

3. Risks and Uncertainties

The Plan invests in various investment securities, that are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial

Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability and significant to the fair value measurement.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the unadjusted quoted price of shares held by the Plan at year-end. Management believes that the most appropriate classification for these investments is Level 1.

Fixed Annuity Contracts - The fixed annuity contracts are composed entirely of the TIAA Traditional Non-Benefit Responsive 2 (NBR2) annuity contract. The NBR2 contract is a fixed rate annuity contract that is fully and unconditionally guaranteed by TIAA. The NBR2 contract is reported at fair value using a discounted cash flow method, which is approximated by contract value. The NBR2 contract has liquidity restrictions (see Note 5).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024, total purchases and sales of fixed annuity contracts were \$239,938 and \$542,316, respectively.

5. Investment Contracts with Insurance Company

TIAA Traditional Annuity

The Plan has two fixed annuity contracts with TIAA, NBR2, and Traditional Benefit Responsive 2 (BR2). The guaranteed investment contract issuer is contractually obligated to repay the principal. The guaranteed rate is between 1% and 3%. Institutional withdrawals are allowed over a 60-month (five-year) period with 30-day advance notice from the institution. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The BR2 contract has no liquidity restrictions and is benefit responsive as contemplated by FASB ASC 962-325-35-5. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The NBR2 contract has liquidity restrictions and is non-benefit responsive. Participant withdrawals and transfers must be taken in 84 monthly installments, except that a lump-sum distribution is available in the 120-day period following termination of employment, subject to a 2.50% surrender charge.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

TIAA Stable Value

The contract provides a guaranteed minimum rate of interest between 1% and 3% (before deductions for contract fees) with the potential for crediting of additional interest above the guaranteed minimum if approved by the TIAA Board of Trustees. Additional amounts of interest are not guaranteed for periods other than the periods for which they are declared. TIAA Stable Value is immediately liquid to a participant for withdrawals and transfers and does not have withdrawal restrictions. TIAA Stable Value is a benefit-responsive contract and is recorded at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

6. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and College Retirement Equity Fund (CREF), qualified institutions.

7. Related Party and Party-in-Interest Transactions

Certain investments are managed by TIAA and CREF; therefore, the transactions related to these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

8. Tax Status

The Plan has adopted a prototype plan sponsored by TIAA. On October 7, 2020, the Internal Revenue Service (IRS) stated, in an advisory letter, that the prototype plan adopted by the Plan, as then

designed, was in compliance with applicable requirements of the Code. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code; therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant will become 100% vested.

10. Excess Contributions Payable

The Plan failed the Actual Deferral Percentage test for 2024 and 2023. Accordingly, the Plan has recorded a liability for \$41,951 and \$131,595 as of December 31, 2024 and 2023, respectively. Excess participant contributions were refunded subsequent to year-end.

12. Subsequent Events

The Plan's Committee reviewed the optional provisions of the SECURE Act 2.0 and approved the following amendments to the Plan:

- Effective January 1, 2025, participants ages 60-63 can take advantage of an enhanced catch-up limit, up to \$11,250.
- The small balance cash-out provision for separated participants will increase from \$5,000 to \$7,000.
- An automatic IRA rollover will occur for separated participants with account balances of \$7,000 or less, who do not take distribution action.
- Effective January 1, 2026, employees with earnings of \$145,000 and over in 2025 will be forced to direct catch-up contributions to Roth accounts.

The Plan management has performed subsequent events procedures through October 3, 2025, which is the date the financial statements were available to be issued. Other than the matters noted in Note 10 and above, there were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
