**NOTE 1 - PLAN DESCRIPTION**

The following description of the GTCR 401(k) Plan ("the Plan") provides only general information. Participants should refer to the plan document (including adoption agreement) for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering generally all employees of GTCR LLC ("the Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan's Board of Trustees is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

Contributions and Vesting: Participants may elect to defer to the Plan up to 75% of their eligible earnings up to the maximum allowed under Section 402(g) of the Internal Revenue Code ("IRC"). Participants may designate all or a portion of the deferral contributions as either pre-tax or after-tax contributions (Roth). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may contribute funds from another qualified plan as rollover contributions. The Company made a safe harbor nonelective contribution in 2025 relating to the year ended December 31, 2024 in the amount of \$1,416,740, which is equal to three percent of participant's eligible compensation, as defined by the plan document. In addition, the Company may contribute additional discretionary amounts. There were no discretionary company contributions approved for the Plan year 2024.

All participants are immediately 100% vested in employee and employer contributions.

Investment Options: Upon enrolling in the Plan, a participant may direct the investment of their accounts into any of the investment options offered by the Plan. Participants generally may change investment elections daily.

Participant's Accounts: Each participant's account is credited with the participant's contribution, an allocation of the employer contribution, and the Plan's earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's account.

Payment of Benefits: Benefits may be paid to the participant or beneficiary upon termination of service due to death, disability, retirement or other reasons. A participant may receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The Plan provides for normal retirement at the age of 65. In-service distributions are also allowed after the age of 59 1/2 years. In addition, the Plan allows for hardship distributions if certain criteria are met, as defined by the Plan document.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 03, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of input within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following describes the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Registered investment companies*: The fair values of investments in registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Collective trusts*: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. (Level 1 inputs).

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market and credit risks, as well as risks associated with global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' account balances.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and its related regulations. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Fidelity Management Trust Company is the trustee for the Plan. A significant portion of the Plan's investments are registered investment companies managed by Fidelity Investments (an affiliate of the Trustee) and, therefore, these transactions qualify as party-in-interest transactions. Investment management fees and expenses paid by the Plan, which are reported as a reduction in the investment returns of the specific investments held by the Plan, reflect party-in-interest transactions. Notes receivable from participants also reflects party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
