### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of OCE 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of OCE 401(K) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certification from Bank of Oklahoma Financial as of December 31, 2024, and for the period ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with the modified cash basis of accounting. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of OCE 401(K) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about OCE 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the OCE 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined-contribution plan covering qualified employees of Oil Capital Electric, LLC and OCE Mechanical, LLC (collectively known as the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended. The Plan is administered by the Company and Bank of Oklahoma, N.A serves as the trustee. Earnings and losses on investments are allocated to the participants' accounts.

***Effective Date***

The Plan's original effective date was April 1, 2003. The Plan has since been restated and amended effective July 1, 2021.

***Eligibility***

The Plan is a defined contribution plan. All employees of Oil Capital Electric, LLC and OCE mechanical, LLC are eligible to participate in the Plan if they have completed at least 90 days of service.

***Contributions***

Each year, participants may make salary deferral contributions up to 100% of their annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. The Plan allows Roth deferral contributions. The Plan provides for a Company discretionary matching of 50% up to a maximum of 4% of the employees' covered compensation. Employees are automatically enrolled at 4% unless they elect not to participate in the plan. The Company may also contribute 2% of the employee's compensation to the Plan as a non-discretionary contribution and a profit-sharing contribution.

***Participant Accounts***

Each participant's account is credited with the participant's deferrals and allocations of the Company's matching contribution and Plan earnings and is debited with Plan expenses. Allocations are based on eligible participant compensation or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Plan participants may direct their entire account balances in partial increments to any of the various investment options offered by the Plan. Participants may change their investment options on a daily basis. Participants should review each investment option's prospectus for a description of the investment objectives.

***Investment Options***

Upon enrollment in the Plan, a participant may direct deferrals and employer contributions to any of the funds offered by the Plan. Participants may change their investment options daily.

***Vesting***

Participants are immediately fully vested in their contributions, earnings and allocations thereon made to their account.

*Forfeitures*

Due to the immediate vesting option elected by the Plan, forfeitures are uncommon. These funds may be used to reduce future employer contributions or administrative expenses. At various times throughout 2024, one deposit was recorded from individual participants resulting from outstanding checks that were voided. The total dollar amount was \$247. At various times throughout 2023, eight deposits were recorded from individual participants resulting from outstanding checks that were voided. The total dollar amount was \$300.

*Participant Loans*

Participant loans are not permitted by the Plan.

*Payment of Benefits*

On termination of service, a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in their account. Participants with balances greater than \$7,000 may leave their vested interest in the Plan until required minimum distribution age is met.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The accompanying financial statements have been prepared on the modified cash basis, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles, and is an acceptable method of reporting under Department of Labor regulations. The modified cash basis of accounting utilizes the cash basis of accounting while carrying investments at fair value and recording investment income (loss) on the accrual basis. Consequently, contributions are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

*Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

***Investment Valuation and Income and Loss Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on those held at the end of the year.

***Reclassifications***

Certain prior year amounts have been reclassified to conform to the current year's presentation. The reclassifications had no effect on the previous reported change in net assets available for benefits.

***Plan Administrative Expenses***

Certain administrative expenses are paid by the Plan sponsor and accordingly are not reflected in the accompanying financial statements of the Plan. Certain transaction processing fees are charged to the participants and therefore, are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

***Subsequent Events***

During 2024, the Plan learned that employer and profit-sharing contributions were being contributed to the Plan incorrectly for the year ended December 31, 2024. The Plan worked with Bank of Oklahoma Financial and the Company to arrive at balances owed back to the Plan and participants. Contributions, along with lost income allocations, were corrected during the year ended December 31, 2025.

The Company has evaluated subsequent events October 1, 2025, which is the date the financial statements were available for issuance, and noted no events which require adjustments to, or disclosure, in the 2024 financial statements.

**NOTE 3 - INVESTMENTS - INFORMATION CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As of December 31, 2024, and for the year ended December 31, 2024, Bank of Oklahoma Financial held the Plan's investment assets and executed investment transactions.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures ("ASC 820") establishes a framework for measuring fair value. That framework provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in an active market that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are both unobservable and significant to the overall fair value measurement.

Fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used must maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** - Valued at fair value based on the NAV of the observable market prices of the underlying assets within that account less liabilities.

**Money Market** - Valued at the quoted NAV of shares held by the Plan at year end.

**Fixed Income** – Fixed income are bonds held in registered investment companies which are valued at the quoted NAV held by the Plan at year end.

**Cash Investments** – Cash investments are held in registered investment companies which are valued at the quoted NAV of shares held by the Plan at year end.

The methods previously described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 - RELATED PARTY TRANSACTIONS**

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employers or employee association or relatives of such persons.

Certain Plan investments are managed by Bank of Oklahoma, N.A., which is the asset custodian and trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants and the related interest income are also considered party-in-interest transactions. Certain fees and expenses of the Plan may be paid by the Company. These transactions qualify as party-in-interest transactions. The Plan is not required to repay expenses paid by the Company on its behalf.

The Plan paid \$3,042 and \$4,830 for investment management services for the years ended December 31, 2024 and 2023, respectively.

**NOTE 7 - TRANSACTIONS WITH PARTIES IN INTEREST**

Oil Capital Electric, LLC provides to the Plan certain accounting and administrative services for which no fees are charged. The Plan Sponsor representative is currently a participant in the OCE 401(k) Plan.

**NOTE 8 - INCOME TAX STATUS**

The Volume Submitter Plan obtained its opinion letter on January 31, 2006, in which the Internal Revenue Service stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Volume Submitter Plan's opinion letter has been relied upon by the Plan. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan will take all reasonable actions to maintain the Plan's qualified status.

**NOTE 8 - INCOME TAX STATUS (CONTINUED)**

The modified cash basis of accounting require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions and could be subject to income tax if certain issues were found by the Internal Revenue Service that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.
