### 1. DESCRIPTION OF PLAN

The following description of Symbotic LLC 401k Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution retirement plan covering all eligible employees of Symbotic LLC (the Plan Sponsor), Symbotic Holdings LLC and Warehouse Technologies, LLC, as participating employers. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### b. Eligibility

Employees become eligible to participate in the Plan immediately upon hire. Prior to January 1, 2024, full-time employees were eligible to receive the Plan Sponsor's safe harbor matching contribution after completing six months of service, and part-time employees, are eligible after completing one year of service. Effective January 1, 2024, employees must complete six months of service in order to be eligible to receive the Plan Sponsor's safe harbor matching contribution. Collective bargaining employees, non-resident aliens, and leased employees are excluded from participating in the Plan.

#### c. Contributions

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the plan document, up to the maximum amount allowed by the Internal Revenue Code (IRC). The Plan also allows for post-tax (Roth) contributions. Effective January 1, 2025, the Plan was amended to permit after-tax contributions and related in-plan Roth conversions pursuant to the provisions of SECURE Act 2.0. Participants who have attained age 50 before the end of the plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct their contributions into various investment options offered by the Plan. The Plan allows for auto-enrollment whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. There is no auto-escalation provision to increase these deferrals. Effective January 1, 2025, the Plan was amended to include an auto-escalation feature in which participant deferral rates are increased by 1% of annual compensation on a yearly basis, not to exceed 10% of annual compensation.

The Plan Sponsor matches employees' 401(k) contributions, 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation each pay period (safe harbor matching contributions). The Plan has a year-end true-up feature which ensures that participants who contribute unevenly during the year receive the full year's safe harbor matching contribution. For the year ended December 31, 2024, the Plan Sponsor's safe harbor matching contribution totaled \$5,569,944, which includes a true-up contribution of \$255,397 that was made to the Plan in 2025.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's safe harbor matching contributions, and plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant's earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their contributions and the Plan Sponsor safe harbor matching contributions, plus earnings or losses thereon.

#### f. Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan term cannot exceed five years, unless proceeds are used to purchase a primary residence, in which case the maximum repayment period is thirty years. A participant may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. Principal and interest are repaid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. There are also retirement benefits available upon disability or death. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account, installment payments, or partial withdrawals. The Plan requires balances up to \$1,000 be paid out to participants upon termination and allows for balances of \$1,000 to \$5,000 be rolled over to an individual retirement account (IRA). Effective January 1, 2024, the limit of involuntary cash-out distributions increased from \$5,000 to \$7,000 under the provisions of SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the IRC or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeitures

Forfeited amounts related to Plan Sponsor contributions are used to reduce future Plan Sponsor contributions or to pay plan expenses. Forfeited amounts not used to reduce future Plan Sponsor contributions or to pay plan expenses are reallocated to participant accounts as additional Plan Sponsor contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,073 and \$10, respectively, which are included in the guaranteed investment contract in the accompanying statements of net assets available for benefits. Forfeitures of \$29,918 were used to reduce Plan Sponsor safe harbor matching contributions during 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Shares of mutual funds are stated at quoted market prices on public exchanges, which represent the net asset value (NAV) of shares held by the Plan at year-end. Gains and losses are recognized as incurred upon sale or maturity of investments based on market value changes during the period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

Fixed annuity contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. There was \$47,478 of defaulted loans included as benefits paid to participants in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### **Contributions**

Contributions from plan participants and Plan Sponsor safe harbor matching contributions are recorded in the year which the contributions are withheld from compensation.

#### **Excess Contributions Payable**

The Plan's qualified institution recorded contributions for the plan year ended December 31, 2025 to participant accounts in 2024. The excess contribution amounts are recorded as a liability with corresponding reductions to participant and employer contributions.

#### **Payment of Benefits**

Benefits paid to participants are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions along with asset management fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### **Subsequent Events**

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued. Other than those disclosed in Note 1c, there were no other events noted that met the criteria for recognition for disclosure in the financial statements.

### **3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTIONS**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the qualified institutions, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institutions are considered party-in-interest transactions.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institutions for its administrative services to the Plan. During 2024, the Plan paid the qualified institutions administrative expenses totaling \$251,221, which is presented net of \$19,888 of the revenue sharing credit in the statement of changes in net assets available for benefits.

### 7. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in a number of investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with these investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the statements of net assets available for benefits.

### 9. FIXED ANNUITY CONTRACT

The Plan has a contract with Empower Annuity Insurance Company of America (the insurance company), which is called the Key Guaranteed Portfolio Fund. Contributions are maintained in a group annuity account by Empower Annuity Insurance Company of America. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is considered fully benefit-responsive and reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, there are certain events that limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) plan termination, (5) bankruptcy, and (6) early retirement incentives. The insurance company may not terminate the contract at any amount less than contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting.
