**Note 1. Description of the Plan**

The following description of the Royal United Mortgage LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

***General***

The Plan is a defined-contribution plan sponsored by Royal United Mortgage LLC (Company). The Plan allows employees to make salary deferrals and participate in employer contributions after attaining age 18 and three months.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Empower Trust Company, LLC and Empower Annuity Insurance Company of America serve as Plan custodians. Members of management serve as Plan trustee.

***Contributions***

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 90% of their annual compensation, subject to annual limitations, established by the Internal Revenue Service. Employee rollover and Roth contributions are permitted by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan has an automatic enrollment to defer 6% of eligible compensation, unless the participant made an affirmative election otherwise.

The Company made discretionary matching contributions of 20% of the participant's contribution up to the allowable IRS deferral amount for 2024 and 2023. In addition, there was \$20,800 and \$21,300 in discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023, respectively. A discretionary profit-sharing contribution of \$100 is provided to certain employees on their anniversary of employment date. Total Company contributions were approximately \$267,612 and \$239,060 for the years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Participants may direct the investment of their account balances into various investment options offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution made on their behalf and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their elective deferral and actual earnings thereon. Vesting in the Company's discretionary contributions and actual earnings thereon is based on years of continuous service. Participants vest at a rate of 25% for each year starting with year two of continuous service and become 100% vested in Company contributions after five years of credited service unless they meet certain requirements and elect a prior vesting schedule as described in the Plan Document. Participant accounts are distributed without regard to the vesting provisions in the event of death or permanent physical or mental disability.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant or a participant's beneficiary may elect to receive a lump-sum distribution equal to the vested balance of a participant's account or one of the other optional forms of benefit offered by the Plan. Hardship withdrawals are also allowed, as defined by the Plan. In-service distributions are only allowed from rollover accounts.

***Forfeited Accounts***

Forfeitures result from nonvested employer contributions and can be used to pay administrative expenses and to reduce future employer contributions. Forfeited nonvested accounts totaled approximately \$46,000 and \$40,000 for the years ended December 31, 2024 and 2023, respectively. Forfeitures of approximately \$41,000 and \$63,000 were used to reduce employer contributions during 2024 and 2023, respectively.

***Notes Receivable From Participants***

Participants may, under certain circumstances as defined by the Plan Document, borrow up to the lesser of \$50,000 or 50% of their vested account balance. Participants may have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at the prevailing rate charged by other lenders for similar notes. Interest rates on notes receivable range from 5.25% to 10.50% at December 31, 2024. The notes are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the note terms may be up to 15 years.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Method of Accounting***

The accompanying financial statements are prepared on the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Mutual funds are reported at fair value. Quoted market prices, if available, are used to value investments. The Plan's fully benefit-responsive insurance contracts are carried at contract value as determined by Empower (formerly Great-West) as described in Note 6.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Plan Tax Status***

The Plan operates under an adoption agreement in connection with a volume submitter defined-contribution plan document sponsored by Blue Benefits Consulting, Inc. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the volume submitter plan has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses and Revenue Credits***

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion. The Plan allows for revenue sharing which are credited to the Plan expense account. Administrative expenses are reported net of revenue credits in the statements of changes in net assets available for benefits.

**Note 3. Certification of Plan Custodians**

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Noninterest-bearing cash, investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended of December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. There are no Level 2 or Level 3 securities in the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy and include the stable value fund.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan's management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC, which is the custodian as defined by the Plan agreement. Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

The Plan paid \$123,981 and \$100,957 in fees for 2024 and 2023, respectively, including \$64,559 and \$51,888, respectively, to Empower Life & Annuity Insurance Company related to general administration and recordkeeping, and \$30,959 and \$14,750 to Blue Benefits Consulting, Inc. for contract administrator services. The Plan also paid \$28,463 and \$34,319 for group level processing and other fees in 2024 and 2023, respectively. Expenses paid to the Plan's investment advisor managers, through revenue sharing credits, for 2024 and 2023 were \$32,312 and \$37,973, respectively.

The Plan sponsor pays directly any other fees related to the Plan's operations. The Company provides certain administrative services at no cost to the Plan.

### **Note 6. Investment Contract With Insurance Company**

In 2017, the Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Subsequent Events**

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
