Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ImOn Communications Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 9 to the financial statements, the FiberComm 401(k) Plan was merged into the Plan in 2024. All plan assets were transferred to the control of the ImOn Communications Retirement Plan on January 4, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

Note 1. Plan Description

The following description of the ImOn Communications Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) plan covering all employees of ImOn Communications, LLC (the Company) who are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may make elective contributions up to the limit provided by law for this type of plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also roll over distributions from other qualified defined benefit or contribution plans. Effective January 1, 2024, the Company may make safe harbor matching contributions. In order to maintain safe harbor status, the Company makes a safe harbor matching contribution equal to 100% of participants' deferrals that do not exceed 3% of participants' compensation, plus 50% of participants' salary deferrals between 3% and 5% of participants' compensation. In 2023, the Company contributed to the Plan a discretionary amount as a matching contribution. For the year ended December 31, 2023, the Company matched 100% of the first 3% of employee deferral contributions. Additional amounts may be contributed by the Company at the discretion of the Company's Board of Directors. There were no additional discretionary Company contributions to the Plan for the years ended December 31, 2024 and 2023. The Company's matching contributions to the Plan for the years ended December 31, 2024 and 2023, were \$572,954 and \$302,102, respectively. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of (a) the Company's discretionary profit-sharing contribution, if any and (b) investment earnings and charged with payments of benefits and an allocation of administrative expenses. Allocations are based on participant contributions, account balances, or specific participant transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: Upon enrollment in the Plan, and on a daily basis thereafter, a participant may direct employee and employer contributions in any of the investment options offered by the Plan.

Vesting: Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the qualified nonelective contribution accounts and any matching contributions made by the Company in excess of safe harbor contributions is based on a four-year vesting schedule. Participants vest 25% per year for each year of service completed in which they work 1,000 hours. A participant becomes fully vested after four years of service or upon death or permanent disability. The safe harbor matching contributions are immediately 100% vested.

Forfeitures: Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' nonvested accounts shall be used to reduce the employer matching contributions. There were \$2,477 and \$0 available as of December 31, 2024 and 2023, respectively, and \$8,558 and \$4,704 of forfeitures used during the years ended December 31, 2024 and 2023, respectively.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their vested accounts amounts ranging from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance per Company policy. No participants may have more than one loan outstanding at any one time. Loan terms range from one to five years. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest. Outstanding loans were being charged interest at 4.25% to 10.50% at December 31, 2024, based on the interest rate on the date the loan was received. Principal and interest is paid ratably through biweekly payroll deductions. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payments of benefits: On termination of service due to death, disability or retirement, a participant may elect to receive benefits in the form of a lump-sum payment or as a direct rollover to another qualified plan. If a participant's eligible rollover distribution is more than \$1,000 and less than or equal to \$5,000, the payment will be distributed to the destination requested by the participant. If the participant's eligible distribution is less than \$1,000, a single lump-sum distribution is automatically made to the participant.

Administrative expenses: The Plan paid \$58,163 and \$40,513 of investment management fees for the years ended December 31, 2024 and 2023, respectively. All other administrative expenses were paid by the Company.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Note 2. Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits: Benefit payments to participants are recorded upon distribution.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 4. Income Tax Status

The Plan adopted a preapproved plan document sponsored by Hills Bank and Trust Company. The preapproved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

Note 6. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted market prices in the active markets on which they are traded.

Money market fund: This investment is a money market fund managed by Goldman Sachs whose unit value is determined by dividing the fund's net asset value (NAV) by the total of participating plans' units outstanding. The fund seeks to maintain a constant NAV of \$1 per unit. The NAV is used as a practical expedient to fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8. Nonexempt Transactions

During 2024, the Company inadvertently failed to deposit \$80 of participant contributions and loan repayments within the required time frame as stated by the DOL regulations. The Company deposited lost interest in the amount totaling \$1 to correct this failure in 2025. The Company intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction and any excise taxes, if applicable will be made from the Company's assets and not from assets of the Plan.

Note 9. Plan Merger

On March 31, 2023, the Company acquired FiberComm L.C. Employees of FiberComm L.C. continued to participate in their employer sponsored plan until January 1, 2024, when the Plan was amended to include employees of FiberComm L.C. into the Plan and eligible participants could begin participating in the Plan immediately. The former custodian's services were retained until January 2024 when net assets were liquidated, and legal control of the funds were transferred to the current custodian. As a result, participants' account balances totaling \$1,780,145 were transferred into the Plan's trust account on January 4, 2024.
