INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Bitzer US, Inc. 401(k) & Long Term Incentive Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Bitzer US, Inc. 401(k) & Long Term Incentive Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated and amended effective April 1, 2024. In this amendment, the Plan was renamed from the Bitzer US, Inc. 401(k) Plan to the Bitzer US, Inc. 401(k) & Long Term Incentive Plan.

Eligibility

The Plan is a defined contribution plan covering all employees, except leased employees, certain nonresident aliens, and certain members of a collective bargaining unit, of Bitzer US, Inc. (the Company or the Employer). Prior to April 1, 2024, employees who had attained age 18 or older were eligible to participate in the Plan following the completion of one month of service. Effective April 1, 2024, newly hired employees must fulfill a service requirement of 60 days before they are eligible to participate in the Plan. Additionally, the Plan includes an automatic enrollment feature for all eligible participants. The participants will be automatically enrolled at 4% of eligible compensation unless the participant signs a written statement to opt-out of Plan participation. Non-elective deferrals are allowed for certain employees.

Contributions

Each participant may elect to make pre-tax and/or Roth contributions of up to 90% of eligible compensation as defined by the Plan document, not to exceed \$23,000 in 2024, plus a catch-up contribution of up to \$7,500 for participants age 50 and older by the end of the 2024 Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company will make a safe harbor matching contribution equal to 100% of the participants' elective deferrals, not to exceed 4% of their annual eligible compensation. The Company may also make discretionary profit sharing contributions to eligible participants. Certain participants must complete 1,000 hours of service during the relevant eligibility computation period and all participants must be employed on the last day of the Plan year to receive discretionary profit sharing contributions. If a participant terminates before the last day of the Plan year, they are eligible to receive discretionary profit sharing contributions if termination was due to death, retirement, or disability. For the 2024 Plan year, the Company made \$767,409 in safe harbor matching contributions and \$2,363,569, which is net of \$219,745 in forfeitures, in discretionary profit sharing contributions. The Company makes various contributions throughout the year to partially fund the annual profit sharing contribution before the Plan's year end. As of December 31, 2024 and 2023, unallocated employer contributions of \$2,256,493 and \$767,991, respectively, are included in the Guaranteed Interest Account, and represent discretionary profit sharing contributions for the respective Plan years. The 2024 and 2023 discretionary profit

sharing contributions were fully funded and allocated to participant accounts in September 2025 and 2024, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings on the investments in their account, and is charged with withdrawals, losses on the investments in their account, and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions, rollovers, and the Company's safe harbor matching contributions plus earnings thereon. Discretionary profit sharing contributions and the related earnings thereon vest 20% per year of service beginning at the completion of two years of service and are fully vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account balance. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest, as defined by the Plan document. As of December 31, 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the notes receivable, not to exceed five years, unless used for the purchase of a personal residence. Principal and interest are paid through payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$219,745 and \$79,181, respectively. The forfeited non-vested account balance may be used to pay administrative expenses or to reduce Company contributions. The Plan used \$27,070 of forfeitures during 2024 to reduce the Company's discretionary profit sharing contribution and \$0 to pay administrative expenses.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their respective account in a lump sum distribution. The participant's vested account may also be withdrawn for in-service distributions upon reaching age 59½ or for certain hardship situations when certain conditions are met. If the

account balance is \$1,000 or less, the Plan could, upon termination of service, pay the benefits owed in a lump sum. Terminated participants' account balances between \$1,000 and \$5,000 could be automatically rolled over to an individual retirement account unless the participant directed otherwise.

Administrative Expenses

Certain transaction fees related to distributions are charged directly to the participant that initiated the transaction. The Plan document permits certain administrative expenses to be paid by the Plan. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. The Company pays all other expenses. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The employer discretionary profit sharing contributions are considered payable to the Plan after approval by the administrative committee and the participant has met the eligibility requirements for the contributions. Any unfunded participant or employer contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the Guaranteed Interest Account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net increase in fair value of investments includes interest, dividends, and realized and unrealized gains and losses, and fees charged for investment management and administrative services on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note receivable repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced, and a deemed distribution is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All investment information in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net increase in fair value and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America (collectively, Empower), the Plan's qualified institutions.

4. Investments

Certain Plan investments include a Guaranteed Interest Account (GIA), which is managed by Empower. Empower is a service provider to the Plan; therefore, transactions in this investment qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net increase in fair value or contract value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in an Empower Guaranteed Interest Account. The Guaranteed Interest Account is considered to be a fully-benefit responsive investment contract issued by Empower. The Guaranteed Interest Account is backed by the general account assets of Empower. The Plan's investment in this account is stated at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Contract value is the relevant measure for fully-benefit responsive contracts because contract value is the

amount participants would receive if they were to initiate permitted transactions under the terms of the contracts. Investment income of this account is presented on a contract value basis.

5. Income Tax Status

The Plan is operating under a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan document offered by Empower Retirement LLC (ERL), an affiliate of Empower. The Internal Revenue Service has determined and informed ERL by a letter dated November 14, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
