Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RETTEW Associates, Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF THE PLAN

The following description of the RETTEW Associates, Inc. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of RETTEW Associates, Inc., RETTEW Engineering and Surveying, P.C., RETTEW Field Services, Inc., RHC Contracting, LLC, and RHC Consulting, PLLC (collectively, the Company). The Plan was amended effective June 1, 2024 to include RHC Contracting and RHC Consulting as participating employers. An employee is eligible to make contributions and participate in the Plan on their date of hire or when they attain 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. In conjunction with the Company's 401(k) and Profit Sharing Plan Committee, the Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress. The CARES Act provides immediate and temporary relief for retirement plan sponsors and their participants with respect to employer contributions, distributions, and participant loans. The Plan adopted certain relief provisions included in the CARES Act, including those related to distributions and participant loans, which were effective through December 31, 2020. As permitted under the CARES Act and subsequent related regulations, the Plan was amended on August 7, 2023 to retroactively effectuate these changes.

Contributions

Each year, participants may defer up to 100% of compensation, not to exceed the annual maximum deferral amount as defined by law. Catch-up contributions are permitted for all eligible participants who have attained age 50 before the close of the calendar year. The Plan allows for Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated mutual fund until changed by the participant. The Plan also includes an auto-escalation

feature whereby any participant contributing less than 6% will have their deferral rate increased by 1% each year until they reach a deferral rate of 6% unless they elect out.

The Company may make discretionary matching contributions to be determined each year. For the years December 31, 2024 and 2023, the contribution was 25% of the participant's salary deferral up to a maximum of 6% of eligible compensation. The discretionary matching contribution was \$393,091 and \$347,963 for the years ended December 31, 2024 and 2023, respectively. All Plan participants who made elective deferrals during the year are eligible to receive discretionary matching contributions.

The Company may make discretionary employer profit sharing and qualified non-elective contributions. For the years ended December 31, 2024 and 2023, there were no discretionary employer profit sharing or qualified non-elective contributions. An employee must complete one year of service, which is defined as 1,000 hours of service, in order to receive the discretionary profit sharing contribution.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the participant's share of (a) the employer's matching and discretionary contributions, (b) an allocation of investment earnings or losses and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investments for their account.

Vesting and Forfeitures

A participant is 100% vested at all times in the participant's salary deferral amounts, rollovers, and discretionary employer's matching contribution, and employer's qualified nonelective contributions, plus any earnings thereon. The portions of the participant's account attributable to the discretionary employer's profit sharing contributions are on a vesting schedule as follows:

Regardless of the vesting schedule, participants become fully vested upon death or total and permanent disability. Forfeitures shall be used to reduce the employer's matching contribution or to offset plan administrative expenses. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and are limited to 5 years except for loans used to purchase a principal residence. Interest is charged at local prevailing rates. Loan repayments are made through payroll deductions. Loans are considered in default when they are not paid within the terms stated on the agreement, typically within 90 days. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. These loans satisfy the statutory exemption from the prohibited transaction rules.

Payment of Benefits

Upon termination of employment, a participant may elect to rollover all of their vested account balance or receive a lump-sum distribution of their entire vested account balance. Provisions are available to allow withdrawals of benefits prior to termination of employment as defined in the Plan document and in compliance with the Internal Revenue Code (IRC). Upon a participant's termination of service, a vested account balance that does not exceed \$5,000 is automatically distributed to the participant or rolled over to an individual retirement account, regardless of the consent of the participant.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are discussed in Note 4. The Plan's 401(k) and Profit Sharing Committee and Plan Administrator determine the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Any Company discretionary employer profit sharing contributions are recorded when the related participant compensation is paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. INVESTMENTS

Through June 30, 2023, Fulton Bank, N.A and Fulton Financial Advisors (collectively referred to as Fulton) served as the Plan's trustee and recordkeeper, respectively, and thus held the Plan's funds and maintained an individual account for each participant. Effective July 1, 2023, the Plan's trustee and recordkeeping services were transitioned to Matrix Trust Company (Matrix). Contributions made on a participant's behalf under the Plan are directly allocated to that participant's account and are invested, based on the participant's direction, in various money market funds and/or mutual funds.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end money market and mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

5. INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

As further described in Note 3, the Plan's trustee and recordkeeping services were transitioned from Fulton to Matrix during 2023. Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedule was obtained by Plan management and agreed to or derived from information certified as complete and accurate by Fulton for the period January 1, 2023 through June 30, 2023 and Matrix for the period July 1, 2023 through December 31, 2024:

- Information included in the accompanying schedule of assets (held at end of year).

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Should the Plan terminate at some future time, participants will become fully vested in any previously non-vested contributions.

7. PLAN TAX STATUS

The Company has adopted a pre-approved plan provided by Fulton Bank, N.A. The pre-approved plan received an opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. In addition, the opinion letter stated that an employer who adopts this pre-approved plan may rely on the opinion letter with respect to the qualification of its own plan under the IRC. Although the Plan has been amended since the pre-approved plan received the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Fulton and Matrix provide certain trust, administrative, recordkeeping, and investment consulting services to the Plan pursuant to a fee agreement with the Company. Fulton and Matrix are investment advisors and the trustee and recordkeeper, respectively, for the Plan; therefore, these transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules. All other transactions that may be considered party in interest transactions relate to normal Plan management and administrative services, and the related payment of fees.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later. Plan management is evaluating these provisions and will update the Plan's governance and operations.
