INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Landmark Global, Inc. 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Landmark Global, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Plan Description

The following description of the Landmark Global, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the adoption agreement and plan document for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 2007 by Landmark Global, Inc. (the Company or Plan Sponsor) as a defined contribution plan with 401(k) provisions for eligible employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is responsible for oversight of the Plan. The Plan was amended and restated effective January 1, 2023 to reflect Ascensus Trust Company (Ascensus) being appointed by the Plan Sponsor as the Plan's recordkeeper and trustee. The Plan was in a blackout period from December 30, 2022 until January 30, 2023, while Plan assets were transferred from Mid Atlantic Trust Company to Ascensus.

Eligibility: Employees are eligible to participate in the Plan immediately after employment and attaining 21 years of age. Eligible employees are permitted to enter the Plan on the payroll date coinciding with or following the date the employee has met eligibility requirements.

Contributions: Active participants may elect to contribute up to a maximum of \$23,000 during the plan year. Individuals who are at least 50 years of age are permitted to make catch-up contributions. Participants may elect to contribute between 0% and 96% of eligible compensation, as defined by the Plan. Effective January 2, 2017, the Plan Sponsor amended the Plan to exclude reimbursements, fringe benefits, moving expenses, deferred compensation, welfare benefits, holidays, gifts, elective deferrals and employer contributions from eligible compensation for both elective deferrals and employer matching and profit sharing contributions.

In 2015, the Plan adopted Actual Deferral Percentage (ADP) safe harbor contributions. Each pay period, the Company will make a matching contribution to each participant's account equal to 100% of the first 3% of compensation contributed, and 50% of the next 2% of compensation. Changes made fewer than three days before the payroll is submitted will be reflected in the contribution of the following pay period.

The Company has the option of making a year-end profit sharing contribution to the Plan. The contribution is made based on a discretionary formula and allocated pro rata to the individual participant accounts. No profit sharing contributions were made during the year ended December 31, 2024.

Total contributions to a participant's account in a given plan year may not exceed the lesser of \$69,000 (\$76,500 including catch-up contributions) or 100% of the participant's compensation for the plan year.

Investment elections: Participants direct the investment of their contributions into one or more of the investments offered by Ascensus. A participant may transfer funds from one investment option to another and obtain information about their account directly online, or by submitting a form to the human resources manager of the Plan Sponsor at any time during the plan year.

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, and Plan earnings. Allocations of investment earnings are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants may borrow from their fund accounts a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of the *Wall Street Journal* prime rate plus one. Interest rates range from 4.25% to 9.50% for outstanding loans at December 31, 2024, and mature through 2030. Principal and interest is paid ratably through bi-weekly payroll deductions for salaried employees, and weekly for hourly employees with an outstanding loan. Participant loans are reported at amortized costs.

Vesting: Participants' contributions and safe harbor contributions are fully vested at all times.

Profit sharing contributions are subject to vesting requirements, according to the following schedule:

Payment of benefits: The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of service, death, disability or retirement age, the participant may receive the value of the vested interest in their account in the form of a lump-sum distribution or installments for a specified term. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Participants may receive in-service distributions of their vested account balance when they attain age 59 ½.

Forfeitures: Forfeitures of the non-vested portion of terminated participant assets can be utilized to reduce Plan expenses for the plan year and to reduce Company Plan contributions. Forfeited non-vested accounts totaled \$-0- at December 31, 2024 and 2023.

Termination of Plan: Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all amounts credited to a participant's account become 100% vested.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America.

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for expected credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of benefits: Benefits are recorded as deductions when paid.

Administrative expenses: Certain expenses of the Plan are paid by the Company and are therefore excluded from these financial statements.

Subsequent events: Subsequent events have been evaluated through October 7, 2025, which is the date that the financial statements were available to be issued. The Plan has determined that there are no subsequent events pursuant to the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

Note 4. Fair Value Measurements of Investments

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The inputs used to measure fair value are classified into the following hierarchy:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) published daily in the *Wall Street Journal*.

Common collective trust: Valued using the practical expedient of the trust as reported by the trust managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a trust is calculated based on a compilation of primarily observable market information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by Ascensus, LLC. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Related Parties and Parties-In-Interest

The Plan issues loans to participants which are secured by vested balances. These transactions qualify as party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 9. Nonexempt Transactions

During 2023, the Plan Sponsor inadvertently failed to deposit \$48,946 of participant contributions and loan repayments within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor deposited lost interest in the amount totaling approximately \$105 to correct this failure in 2024. The correction will be made from the Plan Sponsor's assets and not from assets of the Plan.
