Note - 1 Description of Plan

The following description of Frederiksted Health Care, Inc. 403(b) Retirement Plan (the "Plan" provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is an Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of Frederiksted Health Care, Inc. (the "Company"). The Plan was originally effective from January 1, 2014. The Plan has been amended and restated effective March 1, 2023. Participants are eligible to make salary deferral contributions to the Plan immediately following their date of hire. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may make salary deferral contributions to the Plan equal to a percentage of their pre-tax annual compensation, as defined by the Plan. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to the Plan at the option of the Company's Board of Directors. For the year ended December 31, 2024, the Company's Board of Directors elected to make discretionary matching contributions equal to 100% of participant contributions up to a maximum of 6% of eligible compensation, as defined by the Plan. Eligible participants start receiving matching contributions on the first day of the month following the satisfaction of the Plan's eligibility requirements. Full-time temporary employees, contract workers, employees participating in the Government Employee Retirement System and employees less than 18 years of age are not eligible to receive discretionary matching contributions. Effective March 1, 2023, the Plan was amended to exclude employees who normally work fewer than 20 hours per week from receiving a discretionary matching contribution. Also effective March 1, 2023, the Plan was amended to add a 1,000 hour service requirement during the Plan year for purposes of eligibility for the discretionary matching contributions. Participants also direct the investment of any Company contributions. Contributions are subject to certain IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and any Company discretionary matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their salary deferral and any rollover contributions plus actual earnings thereon. In the event of termination due to death, disability or normal or early retirement, participants shall become 100% vested in the Company contribution portion of their account. For all other participants, vesting in the Company contribution portion of their account is based on years of service, as defined by the Plan, according to the following schedule:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at the prime rate published in The Wall Street Journal on the 14th business day of each month plus 2%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of benefits

On termination of service for any reason, participants will receive benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory distribution. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

Withdrawals from the salary deferral contribution portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants may request a distribution from the rollover portion of their account balance at any time.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$58,209 and \$42,982, respectively. These amounts will be used to reduce future employer contributions or to pay Plan expenses. For the year ended December 31, 2024, forfeited nonvested accounts of \$35,830 were utilized to pay Plan expenses.

Note - 2 Summary of Significant Accounting Policies

Basis of accounting

The preparation of these financial statements of the Plan and accompanying notes in conformity with United States of America Generally Accepted Accounting Principles requires management to make estimates and assumptions that affect the amounts reported. Actual results could differ from those estimates.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to recordkeeping, Plan administration, participant distributions, certain asset based investment advisory fees, and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 3 - Certified Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974 (ERISA). Investments and notes receivable from participants held at December 31, 2024 and 2023, investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, LLC, the custodian of the Plan.

Note 4 - Investments

The Plan applies the provisions of ASC No. 820, Fair Value Measurements, for fair value measurements of investments that are recognized and disclosed at fair value in the financial statements on a recurring basis. ASC No. 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC Topic 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs when measuring fair value. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions. The three levels of the fair value hierarchy are as follows:

Level 1 Quoted prices for identical assets or liabilities in active markets.

Level 2 Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; inputs other than quoted prices that are observable for the asset or liability; or market-corroborated inputs.

Level 3 Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

For the years ended December 31, 2024 and 2023, there were no transfers between levels.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 6 - Plan Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by Ascensus, LLC. Ascensus, LLC received an advisory letter dated January 1, 2018, in which the Internal Revenue Service ("IRS") stated that the volume submitter 403(b) plan document satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified and deemed to be tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Related party and party-in-interest transactions

Plan investments include a variety of mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Administrative expenses paid directly from Plan assets to the custodian totaled \$35,830 for the year ended December 31, 2024. Additional direct payments of \$2,340 were made to the Plan's investment advisor, also considered a party-in-interest, for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in-interest transactions.

Note 9 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The Plan is currently working with its third-party administrator to fully correct these late remittances.

Note 10 - Reconciliation to Form 5500

In reconciling the accompanying financial statements to Form 5500, certain immaterial variances were noted across financial statement line items, which have been incorporated to ensure consistency. In addition, a prior period adjustment of \$20,819 was recorded in the financial statements to correct beginning net assets. Because Form 5500 does not provide a separate line item for prior period adjustments, this amount has been included within "Other expenses" (line 2i(11)) on Schedule H of Form 5500.
