## Independent Auditor's Report

To the Plan Administrator of  
Greater Lawrence Family Health Center 403(b) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### 1. PLAN DESCRIPTION

The following description of Greater Lawrence Family Health Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution plan, qualifying under Section 403(b) of the Internal Revenue Code (IRC), covering substantially all employees of Greater Lawrence Family Health Center, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, appropriateness of the Plan's investment offerings, and monitoring investment performance.

#### b. Eligibility

All employees are eligible to participate in the Plan on the first day of employment with the Plan Sponsor. Employees are not eligible for discretionary matching contributions or discretionary non-elective contributions until they have completed twelve months of service (with at least 1,000 hours) with the Plan Sponsor.

#### c. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, subject to statutory limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows employees to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are automatically enrolled into the Plan at a contribution rate of 1% of eligible compensation as defined in the plan document, unless they elect otherwise.

The Plan Sponsor's discretionary matching and non-elective contributions, if any, are contributed at a rate subject to the Plan Sponsor's Board of Directors' approval. The Plan Sponsor provides for a discretionary matching contribution based on a percentage of the participants' compensation as determined by the Plan Sponsor. The Plan Sponsor contributed up to 1.5% of gross wages as a discretionary matching contribution for all eligible employees for the year ended December 31, 2024, which totaled \$637,500 as shown in the accompanying financial statements. There were no discretionary non-elective contributions made to the Plan for the year ended December 31, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan Sponsor's discretionary matching and non-elective contributions, if any, and an allocation of plan earnings, and is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The accounts are participant directed.

#### e. Vesting

Participants are immediately vested in all contributions and actual earnings thereon.

#### f. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of service due to death or disability, a participant receives either a lump-sum amount equal to the value of their account, annuity payments, or installment payments. The Plan requires balances less than \$5,000 to be distributed by the Plan Administrator upon the participant's termination, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover. Effective January 1, 2024, the limit of involuntary force-out distributions increased from \$5,000 to \$7,000 under the provisions of SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

#### g. Notes Receivable from Participants

The Plan does not allow for notes receivable from participants.

#### h. Forfeited Accounts

Forfeitures represent aged, uncashed checks forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor discretionary matching and non-elective contributions and pay plan expenses. The Plan had unallocated forfeitures of \$723 as of December 31, 2024, which are included in the guaranteed investment contract in the accompanying statement of net assets available for benefits. The Plan did not have any unallocated forfeitures as of December 31, 2023.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed investment contract, which is a fully benefit-responsive investment contract and is reported at contract value (see Note 8). The Plan Administrator determines the Plan's valuation policies utilizing information provided by Lincoln Financial Group Trust Company, Inc. (Lincoln), the qualified institution of the Plan. See Note 4 regarding fair value measurement.

#### **Investment Valuation and Income Recognition (Continued)**

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are recognized as incurred upon sale or maturity of investments or based on market value changes during the period. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Contributions**

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from compensation. Discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

The Plan's investment transaction fees, investment management fees, and third-party administrative fees are allocated to the individual participant accounts in accordance with the plan document. Investment-related expenses are included in net appreciation of investments. All other administrative expenses are paid by the Plan Sponsor and, accordingly, are not reflected in the accompanying statement of changes in net assets available for benefits.

#### **Subsequent Events**

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

### **3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, the qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use, based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated March 31, 2017, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by Lincoln are considered party-in-interest transactions.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institution for its administrative services to the Plan. During 2024, the Plan paid the qualified institution for administration of contracts, processing of distributions, and recordkeeping services of \$151,627, which is presented net of \$30,000 of the revenue sharing credit in the accompanying statement of changes in net assets available for benefits. The Plan has \$33 and \$19 of revenue sharing credits available as of December 31, 2024 and 2023, respectively.

### **8. GUARANTEED INVESTMENT CONTRACT**

The Plan has a fully benefit-responsive investment contract with Lincoln. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Lincoln. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The crediting interest rate is based on a formula agreed upon with the insurance company, but it may not be less than 3%. The guaranteed investment contract does not permit the Plan to terminate the agreement prior to the scheduled maturity date without an early termination fee.

### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with these investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
