Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Collaborative Support Programs 401(k) Profit Sharing Plan and Trust, ("Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, salary deferral plan that was originally established effective January 1, 1998, with subsequent amendments on March 1, 2004, January 1, 2008 and November 1, 2009, and July 1, 2013. The Plan covers all employees of Collaborative Support Programs of New Jersey, Inc., ("Company") and Community Enterprises Corporation (participating affiliate), who have obtained 18 years of age. Plan entry for salary deferrals is immediate with increases made only on the first of January and July and decreases to deferrals at any time. Employer matching and profit sharing requirements were amended to be 1 year of service (12 month wait), 1000 hours worked, and employment at December 31st. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA").

Employee and Employer Contributions

Participants may defer between 1% and up to 90% of their compensation, up to the maximum amount allowed by the IRS guidelines (\$23,000 in 2024 and \$22,500 in 2023). Participants over age 50 are allowed under the IRS catch-up contribution provision to contribute an additional amount above the maximum deferral amount allowed by IRS guidelines (\$7,500 in 2024 and 2023). All contributions are invested by the Plan's custodian in accordance with the options elected by the participants (i.e., all investments are participant-directed). Participants may elect to invest their contributions and the Plan's discretionary matching contribution in 1% increments in the pooled separate accounts.

The Plan allows for a matching contribution of 25% up to 100% on the first 4%, depending on the participant's years of service. There were matching contributions in the amount of \$127,470 and \$102,062 for the years ended December 31, 2024 and 2023, respectively.

For eligible participants, the Plan also allows for non-elective contributions (profit sharing), which is calculated on a non-integrated compensation to compensation formula. There were non-elective contributions declared in the amount of \$72,530 and \$97,938 for the years ended December 31, 2024 and 2023, respectively. These amounts were subsequently received (deposited into) the plan during 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of (a) the Company's matching and discretionary contribution and, (b) Plan earnings and charged with an allocation of administrative expenses paid by the Plan.

Allocations are based on participant's eligible compensation. The employer's matching contributions are allocated based on a percentage of contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants may elect to invest their contributions and the Company's discretionary matching contribution into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions, and rollover contributions accepted by the Plan and actual earnings and losses thereon. Participants vest in the Company's matching and non-elective (profit sharing) contribution portion of their accounts plus actual earnings and losses thereon.

A participant vests according to the following schedule:

Less than one year	0%
One year	20%
Two years	40%
Three years	60%
Four years	80%
Five years	100%

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of the fair value of their vested accounts. The participants' loans are repayable with interest (prime plus 1%) over a term not exceeding five years. The interest rate charged on the participant loans for the year ended December 31, 2024 ranged from 4.25% and 9.50%. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installment payments or a life annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

If a participant leaves the Company prior to fully vesting, the unvested portion of the employer's matching and discretionary contributions will be used first to offset the employer's matching contributions and then to pay for administrative expenses. The forfeiture balance amounted to \$42,902 and \$39,127, respectively, for the years ended December 31, 2024 and 2023. Monies in the forfeiture account are used to pay plan fees and expenses. Plan operating expenses of \$9,000 were accrued to be paid from forfeitures.

The Company will use \$30,000 in forfeitures to reduce employer contributions from \$230,000 to \$200,000 which applies to participants who are eligible for the employer contributions in 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except that benefits paid to Plan participants are recorded on a cash basis.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contract, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. The Investment Committee determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Investments that calculate net asset value per share (or its equivalent), but for which the practical expedient is not applied will be included in the fair value hierarchy along with the related required disclosures.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages in which the compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All Plan expenses are paid by the Company, unless directly paid by the Plan forfeitures. Amounts paid by the Company are excluded from these financial statements. Administrative expenses incurred by the Plan include fees totaling \$59,288 and \$33,803 for the years ended December 31, 2024 and 2023, respectively. See Note 7 for discussion of fees. Loan fees are charged directly to the participant's accounts and investment management fees are netted against investment returns. Investment related expenses are included in net appreciation of fair value of investments.

3. Information Prepared and Certified by Trust Company

Certain information related to investments and notes receivable from participants are disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan). The trustee did not certify the outstanding loan balance of \$53,114 and \$72,604 at December 31, 2024 and 2023, respectively.

4. Deferred Revenue

As of December 31, 2024, the Plan reported deferred revenue totaling \$12,651, which represents employee deferral contributions withheld from participant wages on December 31, 2024, but designated for the 2025 plan year. These amounts relate to participant compensation earned for the 2025 plan year and, in accordance with the Plan's accounting policies, will be recognized as additions to the Plan in the period in which the compensation is earned and the contribution becomes due.

5. Fair Value Measurements

Fair Value Measurements in accordance with current accounting standards, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

6. Investment Contract

The Plan has a benefit-responsive investment contract with Empower Trust Company, LLC. The product type is a general account product for participant initiated transactions. Empower maintains the contributions in a general account. The account is credited with deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. It is not fully benefit responsive due to limitation imposed in the plan. Adjustments to earnings, gains and losses will continue to be made as long as the assets remain in the fund or until distribution. This investment is included in mutual funds and recorded at fair value.

7. Party In Interest/Related-Party Transactions

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC and Empower Annuity Insurance Company. They are also the investment trustees, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Empower Annuity Insurance Company of America served as the Plan's recordkeeper. Empower is a party-in-interest as defined by ERISA. Accordingly, transactions involving Empower, including recordkeeping and administrative services, qualify as party-in-interest transactions. Fees for these services were paid by the Plan which amounted to \$15,653 and \$16,596 for the years ended December 31, 2024 and 2023, respectively.

7. Party In Interest/Related-Party Transactions (continued)

An affiliate of Empower provided investment management account services to participants during the year. For the years ended December 31, 2024 and 2023, fees amounted to \$2,557 and \$2,068, respectively.

The Plan engaged an independent public accounting firm to perform the annual audit required under ERISA. For the years ended December 31, 2024 and 2023, total fees paid to the independent public accounting firm were \$9,000 and \$9,000, respectively. The audit fees were paid by the Company in 2023. These transactions qualify as exempt party-in-interest transactions.

A Registered Investment Advisor (RIA) provided investment advisory services to the Plan for the years ended December 31, 2024 and 2023. These transactions qualify as party-in-interest transactions, however, they are exempt from the prohibited transactions rules under ERISA. Fees paid to the RIA amounted to \$22,025 and \$20,719 for the years ended December 31, 2024 and 2023, respectively.

The Plan engaged a contract administrator to provide plan management and administrative services pursuant to a service agreement with the Plan sponsor. Fees paid totaled \$10,053 and \$9,773 for the years ended December 31, 2024 and 2023, respectively, and were paid by the Plan.

An officer of the Company is a trustee of the Plan and a participant. The trustee is considered both a party-in-interest and a related party. The trustee does not receive compensation from the Plan for fiduciary services.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

9. Tax Status

Although the Plan has not obtained a determination letter from the IRS, The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan does not believe it has taken an uncertain tax position that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to this risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. Subsequent Events

Subsequent events were evaluated through September 26, 2025, the date the financial statements were available to be issued.
