### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Western Management, Inc. Profit Sharing & 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). 

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Western Management, Inc. Profit Sharing & 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Conrad’s Tire Service, Inc., Xpress Tire & Auto Supply, Inc., Conrad’s LaserWash Company, Inc., Western Management, Inc., S&H Industries, Inc., and Elyria Spring and Specialty, Inc. (the “Companies”) who have completed one year of service (defined as working a minimum of 1,000 hours in a year) and attained the age of 21 within the Plan. Effective January 17, 2025, the Plan was amended, in connection with the sale of Conrad’s Tire Service, Inc. and Xpress Tire & Auto Supply, Inc., to exclude their employees from participation.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Participants may make pre-tax contributions in 1% increments of their compensation as defined by the Plan or a flat dollar amount per pay period up to the maximum amount set by the law. Employees who become eligible to participate but do not enroll or opt out of the Plan are automatically enrolled to defer 3% of their compensation as defined by the Plan on a pre-tax basis. The Plan allows for catch-up contributions for participants who attain the age 50 before December 31. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2024, the plan was amended to allow Roth contributions.

The Companies may make discretionary employer matching contributions and profit-sharing contributions. During the year ended December 31, 2024, the Companies made discretionary matching contributions of 50% of participants’ contributions up to 7.50% of compensation for participants who were employees of Conrad’s Tire Service, Inc., Xpress Tire & Auto Supply, Inc., and Conrad’s LaserWash Company, Inc.; up to 6.00% of compensation for participants who were employees of Western Management, Inc.; and up to 4.50% of compensation for participants who were employees of Elyria Spring and Specialty, Inc. and S&H Industries, Inc. The Companies made discretionary profit sharing contributions of \$107,808 for the year ended December 31, 2023. The Companies used forfeitures of \$30,570 to offset the discretionary profit sharing contributions for the year ended December 31, 2023. There was no discretionary profit sharing contributions for the year ended December 31, 2024.

Effective January 1, 2025 the Companies updated the discretionary matching contributions to 50% of participants’ contributions up to 7.00% of compensation for participants who were employees of Conrad’s Tire Service, Inc., Xpress Tire & Auto Supply, Inc., and Conrad’s LaserWash Company, Inc., and up to 4.00% of compensation for participants who were employees of Elyria Spring and Specialty, Inc. and S&H Industries, Inc.

Vesting

Each participant has a 100% non-forfeitable vested interest in his or her elective deferral contributions. Vesting in the participant's share of the Companies' matching and profit-sharing contributions is based on years of continuous service on a six-year graduated scale. The participant will be 20% vested after two years of service and will vest an additional 20% for each year thereafter. A participant is 100% vested after six years of credited service or in the event of death, disability, or retirement.

Participant Accounts

Each participant's account is increased, or decreased as appropriate, with (a) the participant's contribution, (b) the Company's matching and discretionary profit-sharing contributions, (c) net investment earnings based on the participant's account balance and composition, (d) administrative expenses, (e) loan disbursements and repayments, and (f) distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative Expense

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Subject to certain limitations, the Plan permits loans to participants. The minimum loan amount is \$1,000. The maximum amount a participant may borrow is the lesser of (1) one-half of a participant's vested balance or (2) \$50,000. Participants may borrow from the value of their balances invested in any of the various investment funds at their discretion. The interest rate on the loans is equal to 1% plus the Prime lending rate at loan origination date. The terms of the loans are 1-5 years. A loan term may extend beyond 5 years if the loan is used for the purchase of a primary residence. Principal and interest are paid bi-weekly and monthly through payroll deductions.

Allocation of Forfeitures

The Companies have the option to use forfeited non-vested accounts to reduce employer discretionary contributions or to reallocate these funds to participants in the same manner as the Companies' profit sharing contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$64,561 and \$30,570, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Empower Trust Company, LLC ("Trustee") would value the trust and the shares of all participants as of the termination date and would distribute, as soon as possible, the balance of the accounts.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis.

Fair Value Measurements

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and a common collective trust are stated at fair value at December 31, 2024 and 2023. The Plan also has entered into a fully benefit-responsive contract with Great West Life Insurance Company. Information for this is summarized in Note 5.

Investment income consists of interest and dividend income and participant loan interest. The net appreciation in the fair value of investments consists of realized gains or losses and the unrealized appreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the basic financial statements and related notes to the financial statements. Actual results could differ from those estimates. The Plan utilizes various investment instruments, including mutual funds a common collective trust, and a stable value fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed.

Uncertain Tax Positions

Under the Income Taxes Topic of the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”), Plan management is required to identify potential uncertain tax positions taken, assess and quantify those positions and record reserves. As of December 31, 2024 and 2023 and for the year ended December 31, 2024, Plan management has identified no uncertain tax positions.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued. See Note 8.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan’s investments are participant-directed accounts that are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. The fair value amounts presented in the below tables are intended to permit reconciliation of the fair value hierarchy to total investments at fair value. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.
- Common collective trust: Value at the NAV of the underlying investments held by the funds. NAV is used as a practical expedient to estimate fair value.
- Stable value fund: Value at the NAV of the underlying investments held by the funds. NAV is used as a practical expedient to estimate fair value.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has an investment in Reliance MetLife Stable Value Fund (the Fund), which was a common/collective trust fund. During 2023, the Plan exchanged the series of the Fund into a stable value fund. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance within the Fund to noncompeting investments. The Fund requires a 60-day advance notice in the case of a full or partial withdrawal of Plan assets from the Fund due to actions directed by the Companies.

NOTE 5 – GUARANTEED INVESTMENT CONTRACT

The Plan has a traditional fully benefit-responsive stable value investment contract with Empower Annuity Insurance Company of America with a balance of \$1,040,217 and \$1,279,116 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with interest and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and interest credited to participants. The crediting rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Empower's ability to meet its financial obligations. Empower's ability to meet its financial obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower, such as partial or complete contract termination by the Plan. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

NOTE 6 – TAX STATUS

The Plan adopted a profit-sharing plan with cash or deferred arrangement, and obtained its determination letter as on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by Empower Annuity Insurance Company of America, therefore, these transactions qualify as party-in-interest transactions.

NOTE 8 – SUBSEQUENT EVENTS

As discussed in Note 1, the Plan was amended on January 17, 2025, in connection with the sale of two businesses to exclude employees of Conrad's Tire Service, Inc. and Xpress Tire & Auto Supply, Inc. from participation. The affected participants' account balances were transferred to another plan effective January 17, 2025.


