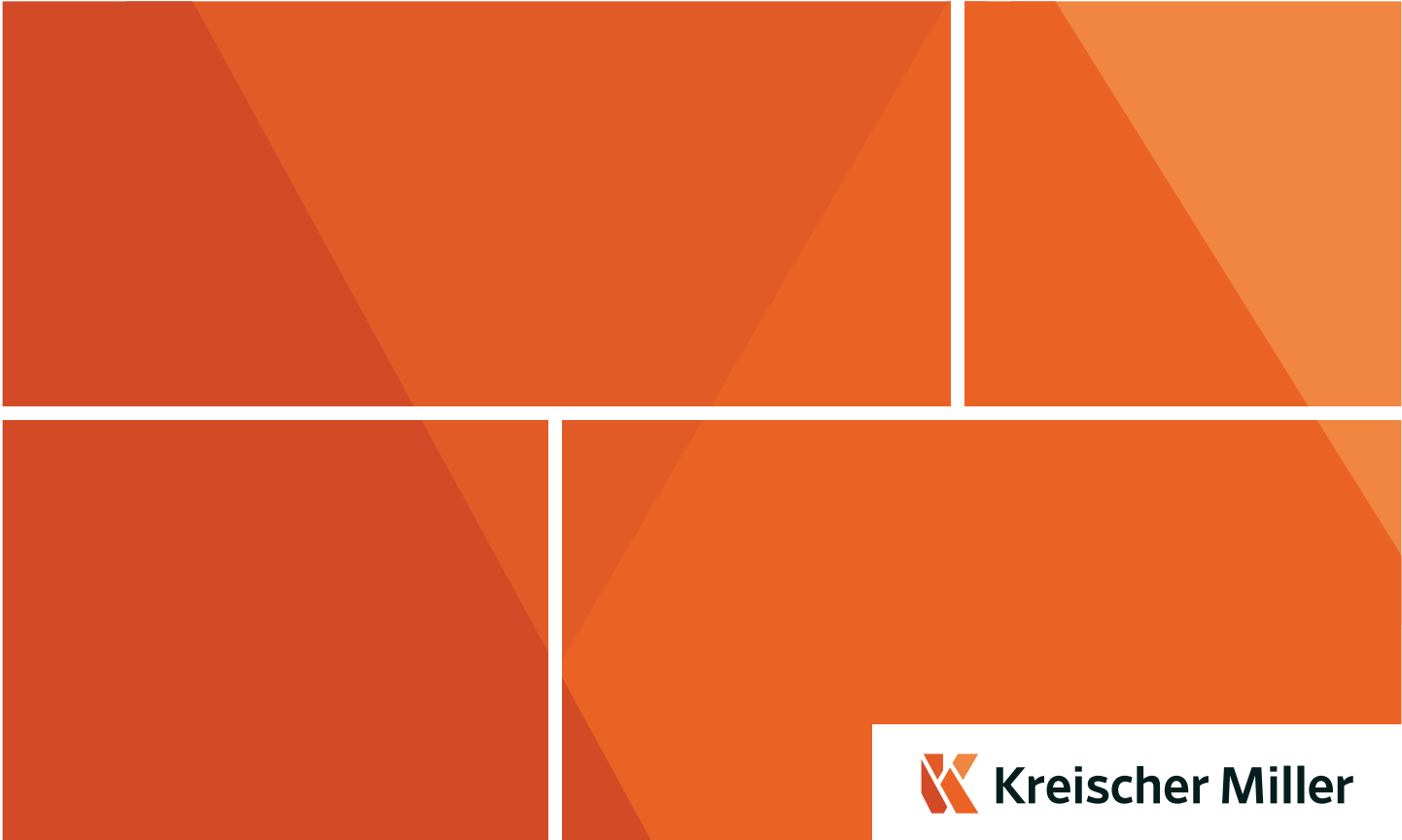

## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Building Inspection Underwriters, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

### (1) Description of Plan

The following brief description of Building Inspection Underwriters, Inc. Retirement Savings Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for more complete information.

#### *General*

The Plan is a defined contribution plan covering all employees of Building Inspection Underwriters, Inc. (the Company) who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, subject to certain limitations as prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover contributions representing distributions from other qualified plans. Participants direct the investments of their contributions into various options offered by the Plan.

The Company may provide matching and profit sharing contributions to eligible employees who have completed one year of service and are employed on the last day of the Plan year. During the year ended December 31, 2024, the Plan recognized a contribution receivable of \$30,000 for a profit sharing contribution as presented on the accompanying statement of net assets available for benefits.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company matching and profit sharing contributions as well as allocations of Plan earnings and losses. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions, plus actual earnings thereon. The Company's matching and profit sharing contribution and earnings will vest according to the following schedule:

Participants' accounts are fully vested upon death or disability.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 limitation is reduced by the highest principal balance on any other loans issued to the participant during the preceding year. Loan terms range from one to five years; however, terms may exceed five years for the purchase of primary residence. The outstanding loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1% at the date of loan issuance. The rate is to remain fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deductions.

#### *Contributions*

Contributions from plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

#### *Payment of Benefits*

Benefits are payable upon termination of a participant's employment, or termination of service due to death, disability, or retirement. Participants may make in-service withdrawals after attaining age 59 ½ or upon a hardship, in accordance with the terms of the Plan. The plan administrator may authorize lump-sum distributions for terminated participants with balances less than \$1,000.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,485 and \$6,970, respectively. These accounts may be used to pay plan administrative expenses or to reduce the employer contribution. During 2024, profit sharing contributions were reduced by \$6,998 from forfeited nonvested accounts.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant transactions are charged directly to participant accounts. Investment related expenses are included in net appreciation of investments.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

#### (3) Certified Investments

Certified information related to investments disclosed in the accompany financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and interest income on notes receivable from participants from the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as completed and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Empower Annuity), qualified institutions.

#### (4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market.

There were no significant transfers among investment levels during the years ended December 31, 2024 and 2023.

### (5) Investment Contracts with Insurance Company

The Plan invests in two fully benefit-responsive guaranteed investment contracts with Empower Annuity. Empower Annuity maintains the contributions in a general account. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than the Guaranteed Minimum Interest Rate. Such interest rates are reviewed and may be reset on a quarterly basis.

The annual crediting interest rate and average yield for the guaranteed interest account for the year ended December 31, 2024 was 4.00% for the Short Term Fund I and 1.41% for the Guaranteed Portfolio Fund.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity dates.

#### **(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

#### **(7) Tax Status**

The Plan is based on a volume submitter prototype plan which obtained its latest determination letter on March 31, 2014. The Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's custodians believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

#### **(9) Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments and other accounts are contracts with the custodians of the Plan and certain plan expenses are paid to the custodians, third party administrators, and other professionals providing services to the Plan, therefore, these transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.
