Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Legacy Pharmaceutical Packaging 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Legacy Pharmaceutical Packaging 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan is a defined contribution plan sponsored by Legacy Pharmaceutical Packaging (the "Company") for the benefit of its employees who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Standard Insurance Company ("The Standard") serves as the Plan's recordkeeper and custodian. A member of the Company's senior management serves as the Plan's trustee.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. Legacy Pharmaceutical Packaging, LLC, the Plan Sponsor, has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Contributions

Participants may make pre-tax or Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined by the Plan.

The Company provides Safe Harbor matching contributions equal to 100% up to the first 3% of base compensation that a participant contributes to the Plan and an additional 50% for deferrals that exceed 3%, but not do not exceed 5% of the participant's compensation. Participants become eligible for Safe Harbor matching contributions on the first of the month following three months of service.

Additional amounts may be contributed at the option of the Company in the form of profit-sharing contributions. Participants are eligible to receive discretionary profit-sharing contributions upon attaining 21 years of age and one year of service. No discretionary profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options

Participants direct the investments of all contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts and a guaranteed interest contract as investment options for participants.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their voluntary contributions plus actual earnings thereon and the Safe Harbor matching contributions made by the Company.

Vesting in the Company's employer match contribution portion of their accounts, as well as any discretionary profit-sharing contributions, is subject to the following schedule:

Participants also become fully vested in the Company's contributions upon attainment of normal retirement age or the termination of the plan.

Notes receivable from participants

Participants may borrow from certain designated accounts. The plan administrator determines the rules for participant loans, including the interest rate charged for the loans. The minimum loan amount is \$1,000, and the maximum loan amount is the lesser of \$50,000 or 50% of the participant's vested account balance. The notes receivable bear interest at current market rates. Interest is determined at the beginning of each quarter and is fixed for the loan term. Up to 50% of the participant's account balance collateralizes the participant's loan. Notes receivable must be paid back within five years, unless the loan is used to acquire the participant's principal residence. Participant loans are recorded at their unpaid principal balance plus accrued interest. Any outstanding balance of a prior loan must be repaid in full before a new loan may be approved, unless the existing loan is a principal resident loan. In the event of termination, the outstanding loan balance becomes due immediately. Outstanding participant loan balances at December 31, 2024 bear interest at annual rates from 3.25% to 8.50%, maturing through November 2029.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum equal to the value of the participant's vested interest in his or her account, or annual installments in the form of an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, if under \$5,000. If the vested account balance exceeds \$5,000, the participant must consent to the distribution and may be distributed in the form of an annuity or a lump sum.

In-service withdrawals are permitted if the participant is over 59 ½ years of age or for hardships.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts are to be used to reduce or pay plan expenses. There were no forfeitures utilized against plan expenses for the years ended December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions or repayments have been separated from a participant's pay by the Company, which is the pay date. The Company's contributions, if any, are recorded in the year earned to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the rollover contributions have been received by the Custodian.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Loan balances are secured by participant accounts.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements are available to be issued.

3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan's Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments, at fair value at December 31, 2024 and 2023
- Investments, at contract value at December 31, 2024 and 2023
- Notes receivable from participants at December 31, 2024 and 2023
- Net appreciation in fair value of investments for the years ended December 31, 2024 and 2023
- Interest on notes receivable from participants for the years ended December 31, 2024 and 2023
- Schedule of Assets (Held at End of Year) at December 31, 2024

The Plan's independent public auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based on the net asset value ("NAV") of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The pooled separate accounts are measured at NAV (or its equivalent) and have not been classified in the fair value hierarchy.

5. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive guaranteed investment account as part of a group annuity contract with The Standard. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the contract at December 31, 2024 and 2023, was \$289,282 and \$414,451, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan terminations, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investment in Group Annuity Contract is managed by The Standard. The Standard is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan to the custodian amounted to \$31,460 and \$29,246 for the years ended December 31, 2024 and 2023, respectively.

7. PLAN TERMINATION

As a result of a reduction of the Plan Sponsor's workforce which occurred during 2024, management determined that the plan underwent a partial plan termination. As a result of the partial plan termination, impacted participants of the Plan became fully vested in all applicable contributions and earnings.

7. PLAN TERMINATION (continued)

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS

The Plan's document is a non-standardized prototype agreement that received a favorable tax opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Although the Plan has been amended since receiving the tax opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
