Independent Auditor's Report

To the Plan Administrator of the Pennrose Management Company 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pennrose Management Company 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). Notes to Financial Statements December 31, 2024 and 2023

1. Description of Plan

The following description of the Pennrose Management Company 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Pennrose Companies LLC effective January 1, 2024, and previously Pennrose Management Company, (collectively the Company) who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for the oversight of the Plan. The Plan Administrator, based on guidance received from the Plan's investment manager, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants in the Plan may contribute up to 75% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or certain individual retirement accounts. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a Lifecycle Fund based upon the participant's age, until changed by the participant.

The Company may make discretionary matching and profit sharing contributions to the Plan on behalf of eligible participants. For 2024 the discretionary matching contribution was 50% of the first 6% of compensation that an eligible participant contributed to the Plan and there was no profit sharing contribution.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's discretionary profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their account, including earnings thereon, is based on years of service and a graduated vesting schedule, with 100% vesting after completion of four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest based on the prevailing rates at the time the loan was established. Principal and interest are paid ratably through payroll deductions. Effective October 28, 2024, if a participant with an outstanding loan balance terminates employment, their outstanding loan balance is no longer immediately due and can continue to be payable in accordance with the provisions of the loan note by the participant. Notwithstanding the foregoing, outstanding loan amounts are immediately due and payable for deceased participants.

Payment of Benefits

A participant may receive a lump-sum distribution of the vested portion of their account on separation from service with the Company. Effective October 28, 2024, partial withdrawals of any portion of a participant's vested balance is permitted after a participant has terminated employment. A participant whose vested balance is \$7,000 or less cannot defer receipt of their distribution. The Plan also provides for the following in-service withdrawals, subject to the Plan's provisions:

- Hardship withdrawals
- Withdrawals after age 59½
- Withdrawals after age 70½
- Withdrawals after normal retirement age
- Withdrawals of rollover contributions
- Active Military Distributions

Forfeited Accounts

There were no forfeited accounts at December 31, 2024 and forfeited accounts totaled \$60,744 at December 31, 2023. Forfeited accounts are used to reduce future employer contributions. In 2024, employer contributions were reduced by \$125,219 from forfeited accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by investment advisers and Fidelity Management Trust Company (Trustee). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are included in net appreciation of fair values of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025 the date the financial statements were available to be issued. Based on that evaluation, no events occurred that required disclosure.

3. Information Certified by Trustee and Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying Schedule H, Line 4i, schedule of assets (held at end of year) as of December 31, 2024

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money Market Fund and Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Administration of Plan Assets

The Plan's assets are administered under a service agreement with the Trustee. Contributions are held and managed by the Trustee, who invests cash received, interest and dividend income as directed by participant investment elections. The Trustee also makes distributions. Investment related fees paid on a basis point are deducted from the returns on the investments. Fees paid to the Trustee qualify as party-in-interest transactions. The fees paid to the Trustee were \$99,917 in 2024.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020 indicating that the Plan was acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees (Opinion Letter). Although the Plan has been amended since receiving the Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and the related trust is tax exempt.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan had investments of \$10,468,829 at December 31, 2024 and \$9,435,747, at December 31, 2023 concentrated in five investments.
