## Independent Auditor's Report

Audit Committee and Board of Directors

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the First International Bank & Trust 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Notes to Financial Statements

#### Note 1. Plan Description

The following description of the First International Bank & Trust 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering qualified employees of First International Bank & Trust (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Audit Committee is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Eligibility:** Employees are eligible to participate in the Plan once they have completed two months of service and have reached 21 years of age. Employees are eligible for the Company match if they have completed one year of service and have reached 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service.

**Entry date:** Employees may enter the Plan on the first day of the month following eligibility to make employee contributions and receive employer contributions.

**Contributions:** Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. The Company contributes a per-pay-period safe harbor match equal to 100% of the first 4%, and 50% of the next 2% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the discretion of the Company's Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans.

All newly hired employees are automatically enrolled in the Plan at 6% pretax deferral upon becoming eligible, unless elected otherwise by the employee. The funds will be held in the Vanguard Target Date Fund based on the participant's expected date of retirement, as preselected and approved by the Board of Directors Compensation Committee, until changed by the participant.

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, allocations of the Company's discretionary contribution (if any) and Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan investment losses. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of continuous service as follows:

**Investment options:** Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

**Forfeitures:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$22,800 and \$11,900, respectively. These accounts will be used to fund future employer contributions or to pay Plan expenses. During the year ended December 31, 2024, Plan expenses related to Quarterly Fees to Empower (TPA) were paid from forfeited nonvested accounts totaling \$14,407.

**Payment of benefits:** On termination of service due to death, permanent disability, retirement or severance of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, equal installments, or partial withdrawals as defined in the Plan document. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. A participant may elect to receive an in-service distribution upon attainment of age 59 ½ or completion of five years of participation in the Plan.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer discretionary contributions.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments brought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** The expenses of the Plan are paid by either the Company or the Plan as provided in the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, there are certain investment-related expenses that are included as an offset in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent events:** The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

#### Note 3. Fair Value Measurements

Accounting standards established the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are valued at daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common trust funds:** Common trust funds are valued at fair value based on the NAV of units held of the investment funds. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the funds are a readily determinable measure of their fair values and is the basis used by the funds for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no unfunded commitments for these funds at December 31, 2024 or 2023. The redemption notice period disclosed in the table above reflects the notice period required if the Plan withdraws from the investment. For individual participants who choose to withdraw from the investment, there is no redemption notice period required.

#### Note 4. Investment Contracts with Insurance Companies

The Plan holds a guaranteed investment contract issued by Standard Insurance Company that invests contributions in the guaranteed interest account. The contributions made under the contract are maintained in a general account. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Plan's total investment recorded at contract value was \$3,644,854 and \$647,351 as of December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract.

Examples of such events include the following:

1. The Plan's failure to qualify under section 401(a) of the IRC or the failure of the trust to be tax-exempt under section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

#### Note 6. Tax Status

The Plan uses a preapproved Plan document sponsored by Empower Retirement LLC, which received an advisory letter from the Internal Revenue Service (IRS) on November 14, 2022, stating that the document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS and has been amended from the version that received the advisory letter. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the IRC and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Related-Party Transactions and Party-in-Interest Transactions**

As described in Note 2, the Plan paid certain expenses for Plan operations and investment activity to the service providers. These transactions are exempt party-in-interest transactions under ERISA.

#### **Note 8. Risks and Uncertainties**

The Plan provides for investments in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is possible that changes in the values of the investments have occurred since December 31, 2024, and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
