Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Buildertrend Solutions, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Plan Description

The following description of Buildertrend Solutions, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, formed in 2008, covering all eligible employees of Buildertrend Solutions, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility: Employees are eligible to participate in the Plan upon attainment of age 21. Eligible employees may elect to become participants on the first day of the month following completion of eligibility requirements.

Contributions and investment options: The Plan permits eligible employees, through a salary deferral election, to contribute up to 100% of their eligible compensation, as defined by the Plan, provided the contribution does not exceed limits established by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions of distributions to participants from another qualified plan are permitted as defined in the Plan and are reflected as rollover contributions. Company safe harbor matching contributions are discretionary and are equal to a uniform percentage of the participants' salary deferral. During 2024, the Company made matching contributions of 100% of eligible employees' salary deferral amounts up to 4% of employees' eligible compensation, as defined by the Plan. Employees are eligible to receive matching contributions upon attainment of age 21 and one year of service, as defined by 1,000 hours of service.

Investment options: Each participant has the option of directing his or her contributions into any of the separate investment accounts offered by the Plan and may change the allocation daily.

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, if any, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon.

Payment of benefits: On termination of service due to retirement, disability or death, a participant may, if the participant's vested account balance exceeds \$7,000, elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly, quarterly or annual installments over a period not to exceed assumed life expectancy. If the participant's vested balance is less than \$1,000, the participant may only receive a lump sum payment. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. For vested account balances between \$1,000 and \$7,000, the participant receives the value of the vested interest in his or her account as a rollover into an IRA or a lump-sum distribution. Hardship distributions and other in-service distributions are paid out as permitted by the Plan. Participants are allowed to take an in-service withdrawal from his or her account upon the attainment of age 59½.

Note 1. Plan Description (Continued)

Notes receivable from participants: Effective January 1, 2023, the Plan was amended to permit new loans to participants. Participants may borrow from their vested account balance. A participant may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The interest rate is determined at the time the participant applies for a loan being 1% over the prime interest rate. Notes receivable interest rates at year-end range from 8.50% to 9.50%, and mature through 2044. Notes receivable must be paid back within five years, except if the note receivable is used to purchase a primary residence, in which case the note receivable must be repaid within 20 years. Principal and interest are paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements set forth below.

Basis of accounting: The accompanying financial statements have been prepared using the accrual method of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent and defaulted notes receivable are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Administrative expenses: Certain administrative expenses, primarily audit fees, are paid by the Company for the Plan and are not reflected in the Plan's financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Other reasonable expenses of administration, including contract administration, record-keeping fees and investment related expenses, are paid by the Plan and are included in administrative expenses.

Subsequent events: The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution:

Note 4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three-level valuation hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted prices in the active markets on which the funds are traded.

Pooled separate accounts: Pooled separate accounts invest primarily in domestic and international stocks, commercial paper and mutual funds. The net asset value (NAV) is used as a practical expedient to determine fair value for these accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Each pooled separate account provides for redemptions by the Plan at reported NAV per share, with little to no advance notice requirement.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers between Level 1, 2 or 3 assets.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan holds a guaranteed interest contract with Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Note 5. Fully Benefit-Responsive Investment Contract (Continued)

Principal Life Insurance Company, the contract issuer, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract, subject to a minimum crediting rate as defined by the contract. The crediting rate is reviewed on a semiannual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Company does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Either party to the guaranteed interest contract may terminate the contract by providing 12-month advance written notice to the other party. Upon termination by the Plan, a market value adjustment may apply.

Note 6. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Principal Trust Company, who is also the custodian of the Plan's assets as of December 31, 2024 and 2023, therefore, the transactions relating to those investments managed by Principal Trust Company qualify as party-in-interest transactions as defined by ERISA.

Administrative fees of the Plan paid to Principal Trust Company, the custodian, for the year ended December 31, 2024, were \$309,445. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Company also provides certain administrative expenses at no cost to the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8. Tax Status

The Plan adopted a nonstandardized form of a preapproved plan sponsored by Benefit Plans Inc. The preapproved plan provider received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the prototype plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the effective date; however, the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
