## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants  
Bob's Discount Furniture 401(k) Profit Sharing Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Bob's Discount Furniture 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Bob's Discount Furniture 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** – The Plan is a defined contribution plan established on January 1, 1995 covering all employees of Bob's Discount Furniture, LLC and Affiliates (the "Company") who have at least one month of service and have reached the age of eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Retirement Plan Committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

**Contributions** – Each year, participants may contribute up to 80% of compensation to the maximum allowed by the Internal Revenue Code (the "Code"). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to contribute. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, increasing 1% annually up to 10%, and their contributions invested in a designated balanced fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified retirement plans to the extent permitted by the Plan. The Company makes a non-discretionary matching contribution of 50% the participant's elective deferral contribution for the Plan year, up to 6% of the participant's eligible compensation. The Plan allows participants, who are projected to be age fifty or older by the end of the Plan year and who are making deferral contributions to the Plan, to make catch-up contributions. The Company may make additional contributions at the discretion of the Board of Directors. There were no additional discretionary contributions made to the Plan for the years ended December 31, 2024 and 2023. All contributions are subject to certain limitations imposed by the Plan and the Code.

**Participant Accounts** – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, related employer-matching contribution, an allocation of the Company's discretionary contributions, if any, and the participant's share of Plan's earnings and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options** – Participants may direct their contributions to a variety of options, including a common collective trust and mutual funds held at Fidelity Management Trust Company ("Fidelity"). These options offer various objectives and degrees of financial risk.

**Notes Receivable from Participants** – Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or one-half of their vested account balance. Note terms range from one to five years, except for notes issued to purchase a primary residence, which may be offered over a term of up to ten years. The notes are secured by the balance in the participant's account and bear interest at a rate, which professional lenders would charge, as determined by the Plan Administrator. The maximum amount of loans outstanding per participant at any one time is two. The outstanding notes currently bear interest at 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

## 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Vesting** – Participants are immediately vested in their deferral contributions and rollovers, including the earnings on these amounts. Participants are also fully vested upon reaching their normal retirement age, death or total disability. Vesting in the remainder of their accounts is based on years of continuous service, as follows:

**Payment of Benefits** – Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her account. The Plan also provides for in-service withdrawals for qualified participants. Distributions will be paid by lump sum or in installments over several years. Upon financial hardship, a participant may request an amount up to the value of any of his or her deferral accounts, but not the earnings thereon.

**Forfeited Accounts** – Forfeitures are used to reduce the Company’s administrative expenses or fund future employer contributions. The Plan allows the Company to offset Company contributions with participant forfeitures. Forfeitures in the amount of \$1,102,121 and \$870,076 were used to offset matching contributions for the years ended December 31, 2024 and 2023, respectively. Forfeited non-vested accounts totaled \$53,107 and \$138,517 as of December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, \$85,410 and \$78,695, respectively, of forfeited non-vested accounts were used to pay administrative expenses.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivables from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Administrative expense paid by the Plan to Fidelity or its affiliates totaled \$270,033 and \$182,452 for the years ended December 31, 2024 and 2023, respectively.

**Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

**Subsequent Events** – The Company has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits** – Benefit payments to participants are recorded when paid.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis

*Investment Valuation and Income Recognition* – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Retirement Committee determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Risk and Uncertainties* – The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term, and those changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

## 3. INFORMATION CERTIFIED AND PROVIDED BY FIDELITY MANAGEMENT TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

#### 4. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust* – composed primarily of a fully benefit-responsive investment contract that is valued at the net asset value of the units of the collective trust. The net asset value is based on the fair value of the underlying investment held by the fund less its liabilities and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no imposed redemption restrictions and the Plan does not have any contractual obligations to further invest in the trust.

#### 5. INCOME TAX STATUS

The Plan adopted a pre-approved defined contribution plan document effective September 2021. The Internal Revenue Service has determined and informed the Trustee by a favorable advisory letter dated June 30, 2020, that the pre-approved defined contribution plan is designed in accordance with the applicable sections of the Code. The pre-approved defined contribution plan's advisory letter is being relied on by the Plan. The Plan has since been amended. Despite the amendments, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.
