DECEMBER 31, 2024 AND 2023

A. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. BASIS OF PRESENTATION - The financial statements of the plan were prepared using the accrual method of accounting in conformity with generally accepted accounting principles.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

2. ESTIMATES - The preparation of financial statements in conformity with accounting principals generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities.. Accordingly, actual results may differ from those estimates.

3. INVESTMENT VALUATION AND INCOME RECOGNITION - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recognized when earned. Dividend income is recorded on the ex-dividend date. Realized gains and losses on investments are recognized upon the sale of the related investments and unrealized appreciation or depreciation is recognized at period end when the carrying values of the related investments are adjusted to their estimated fair market value. Purchase and sales of securities are reflected on a trade-date basis.

Earnings on investments are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances.

4. PAYMENT OF BENEFITS - Benefits are recorded when paid.
5. OPERATING EXPENSES - Administrative expenses incurred by the Plan include plan service fees and benefit distributions fees charged directly to the participants accounts and investment management and advisory fees charged against the Plan's investments. The plan sponser provides certain administrative and accounting services to the Plan at no cost.
6. CONCENTRATION OF CREDIT RISK - Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the Custodian maintains the Plan's investments with high credit quality institutions and attempts to limit credit exposure to any particular investment.
7. DATE OF MANAGEMENT'S REVIEW - Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

B. DESCRIPTION OF PLAN

The following description of TRC Staffing Services, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

1. GENERAL - The Plan is a defined contribution plan covering all Company employees, "Associates" and "Staffing" employees. Employees are required to have one year of service, defined as 1,000 hours of service within a 12 month period, and meet the plans eligibility requirements. To be eligible for the plan, employees must not be represented by a collective bargaining agreement related to retirement benefits, not be a nonresident alien, not be a leased employee, and not a highly compensated employee within the meaning of IRS code Section 414(q). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. CONTRIBUTIONS - Each year, participants may contribute the maximum percentage allowable of pretax annual compensation, as defined in the Plan. Participants may contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. The Company may, at its discretion, make elective matching contributions, qualified nonelective contributions, and/or discretionary profit sharing contributions to the Plan each year. The Company's Board of Directors determines the Company's matching contribution percentage for employees annually. During the year ended 2024 and 2023, the Company made a matching contribution equal to 50% of the first 6% of employee deferral for all employees still employed on December 31.
3. FUNDING POLICY - The Company's funding policy is to make weekly contributions to the Plan equal to the participant's salary deferral and to fund the employer matching contribution in the first quarter following the close of the Plan year.
4. INVESTMENT OPTIONS - Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via on-line access to Transamerica Life Insurance Company. Investments include a portfolio of diversified mutual funds and a common collective trust.
5. PARTICIPANT ACCOUNTS - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of management and administrative expenses. Allocation of the Company's matching contributions, if any, is based upon the participant's contribution. Allocation of the Company's qualified nonelective and discretionary profit sharing contribution, if any, is based upon the ratio of the participant's compensation to the total of such compensation of all participant's actively employed on the last day of the Plan year. Allocation of Plan earnings and administrative expenses is based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
6. PAYMENT OF BENEFITS - On termination of service due to death or retirement, a participant will receive a single lump-sum amount equal to the value of the participant's vested interest in his or her account.

7. VESTING - Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting of elective employer matching, qualified nonelective, and discretionary profit sharing contributions are 100% vested when made.
8. LOANS TO PARTICIPANTS - Participant may not borrow from their fund accounts.
9. FORFEITED ACCOUNTS - Forfeited nonvested accounts totaled \$41,043 at December 31, 2024 and \$40,661 at December 31, 2023. These amounts will be used to first pay administrative expenses and then to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$0 and \$0, respectively, from forfeited nonvested accounts. During 2024, \$524 of forfeitures were applied to reduce plan expenses.

C. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated January 12, 2009, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 2 Fair Value Measurements

The fair value of the BNYM Insight Stable Value and Transamerica Stable Value funds for which quoted market prices are not available are valued based on the market value of its underlying investments that comprise the accounts at year-end. The BNYM Insight Stable Value fund invests primarily in a diversified portfolio of fixed-income instruments. The Transamerica Stable Value fund is a cash equivalent account.

E. CONCENTRATION OF CREDIT RISK AND FINANCIAL RISK

All the Plan's investments are exposed to concentrations of credit risk. Special factors associated with mutual funds and retirement trust investments include market risk, liquidity risk, derivatives risk, options and futures risk, interest rate risk and foreign securities risk. Because these risks are within the various funds it is not practical to estimate the risk amount.

F. PARTY-IN-INTEREST TRANSACTIONS

Transamerica Financial Life Insurance Company is the administrator of the plan assets and, therefore, these transactions qualify as party-in-interest transactions. In addition to indirect fees consisting of sales commissions, sales loads, redemption charges, etc. Transamerica Financial Life Insurance Company receives direct administrative and investment advisory fees for services rendered on behalf of these accounts. Additional fees are paid to Service Providers for investment advisory and third party administrator fees. Net direct fees paid by the Plan for administrative services amounted to \$87,391 in 2024 and \$76,872 in 2023.
