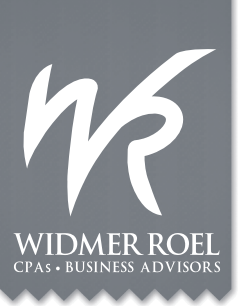

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Lakes Area Cooperative 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Lakes Area Cooperative 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **Lakes Area Cooperative 401(k) Plan's** ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the **Lakes Area Cooperative 401(k) Plan** (the “Plan”) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering qualified employees of Lakes Area Cooperative (the “Company”) Employees who have reached the age 21 and one year of eligibility service are eligible to make deferral contributions to the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participant

Each year, participants may contribute up to 50% annual compensation, as defined in the Plan, limited to Internal Revenue Code (IRC) limitations. Employees aged 50 or older by the end of the calendar year are entitled to an additional “catch up” contributions, subject to IRC limitations. Participant contributions may be made on a pre-tax or an after-tax (Roth) basis.

Employer Matching Contributions

The Company’s matching contribution equaled 25% of elective deferrals not exceeding 6.0% of payroll period compensation, for the year ended December 31, 2024.

Employer Basic Contribution

The Company’s basic matching contribution equaled 4.5% of eligible compensation for each eligible participant, for the year ended December 31, 2024.

Profit Sharing

The Company may elect to make a discretionary nonelective contribution that is determined on an annual basis for participants who have completed at least 1,000 hours of service during the plan year and are employed by the Company at the end of the plan year. For the year ended December 31, 2024, the Company did not make a discretionary nonelective contribution.

Rollover

The Plan allows rollover contributions into the Plan from another qualified plan.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Participant Accounts

Each eligible participant's account is credited with the participant's contribution, the Company's matching contribution and the Company's basic matching contribution, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant's earnings, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled are the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's employer contribution portion of their accounts is subject to a six year vesting period:

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of the offered investment options. Participants may change their investment options daily.

Notes Receivable from Participants

Loans may be made from the participants' accounts upon written application to the Plan administrator. Participants may borrow from the lesser of one-half of the fair market value of a participants vested account balance or \$50,000. The minimum loan amount that may be borrowed is \$1,000. Only one outstanding loan is permitted at any given time.

All loans are repaid by payroll deduction in equal amounts over the repayment term, which is generally five years or less except when loans are secured for the purchase of a principal residence in which case the borrower may repay the loan over a 15 year period. All loans will bear a commercially reasonable rate of interest, which the Company has determined to be the prime rate plus 1.0% at the time the loan application is made.

Payment of Benefits

On termination of service due to death, disability, or retirement, participants with vested account balances greater than \$1,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, or annual installments over a fixed number of years. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

If, upon termination of service due to death, disability, retirement, or any other reason, participants with a vested account balance less than \$1,000, then the vested account balance may only be distributed in a single lump-sum payment regardless of whether consent was given.

Upon attainment of 65 years, participants may withdraw all or any portion of their vested account balances. For participants whose age exceeds 73 years the Internal Revenue Service required minimum distribution rules may apply.

Participants may take hardship withdrawals to satisfy an immediate and heavy financial need subject to certain limitations as defined in the Plan.

Forfeited Accounts

Forfeiture occurs when a participant terminates employment and all or part of the participant's employer matching contributions are not vested. The non-vested portion is forfeited immediately if the participant either has no vested interest upon termination of employment or received a distribution of the entire vested interest when the participant terminates employment.

At December 31, 2024 and 2023, forfeitures totaling \$2,678 and \$1,129, respectively, were available to reduce future employer contributions and Plan expenses, as provided by the Plan. Any portion of a participant's account that is not fully vested upon distribution is forfeited. Forfeitures are used by the Company as an offset to the Company matching contributions. Forfeited amounts totaling \$18,655 were used in 2024, to reduce employer matching contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Measurement of Notes Receivable from Participants

Notes receivable from participants are measured at the loan's unpaid principal balance plus any accrued interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administration Expenses

The Plan's expenses are paid by either the Participant, Plan, or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

Management have evaluated subsequent events through the date of the independent auditor's report, which is the date the financial statements were available to be issued. With the exception of those matters discussed in Note 11, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by Charles Schwab Trust Bank.

The Plan trustee has certified its statement of accounts as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The statements of accounts included beginning and ending balances of investments held, notes receivable from participants, and detail of all transactions during the period, including investment earnings.

NOTE 4 – FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy in accordance with ASC 820 *Fair Value Measurements* are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active or inactive markets and inputs other than quoted prices that are observable for the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Funds – Valued at the net asset value (“NAV”) of units of investment contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Co-Op Stable Asset Fund seeks stability of principal and high current income. The fund invests in a variety of Guaranteed Investment Contracts (GIC), including traditional GICs, separate account GICs, and synthetic GICs. Participants may redeem units of the fund daily for purpose of funding a bona fide benefit payment, making a participant loan, honoring an employee-directed transfer of the employee's interest in the Plan to another investment election that is non-competing investment, or paying Trustee fees. Participants may make withdrawals from the fund for other purposes generally only upon 12 months' advance written notice to the Trustee.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 – TAX STATUS

The Plan uses a pre-approved plan document sponsored by Fox Rothschild, which received an advisory letter from the Internal Revenue Service, dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter; however, Plan's management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken.

NOTE 7 – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Company provides certain accounting and administrative services to the plan, for which no fees are charged. Certain trustee fees based on Plan assets are paid by the Company on behalf of the Plan. These fees would otherwise be paid by the Plan.

The Plan paid certain administrative expenses to parties-in-interest. These transactions are considered exempt party-in-interest transactions under ERISA.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$5,666,831 and \$6,320,815 which were concentrated in five funds, respectively.

NOTE 9 – NONEXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the plan as soon as it is administratively feasible for them to be segregated from the employer's general assets.

During the year ended December 31, 2024, employee deferrals of \$117,961 were withheld and were remitted within the 15-day requirement but not at the earliest day reasonably segregated (as defined by the Department of Labor "DOL") by the Plan Sponsor. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor has confirmed that all such deferrals have been deposited to the Plan. The Company is in the process of computing lost earnings on the 2024 deposits and subsequently making a contribution for lost earnings.

During the year ended December 31, 2023, employee deferrals of \$203,406 were withheld and were remitted within the 15-day requirement but not at the earliest day reasonably segregated (as defined by the Department of Labor "DOL") by the Plan Sponsor. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor has confirmed that all such deferrals, and lost earnings associated with such deferrals have been deposited to the Plan.

NOTE 11 – SUBSEQUENT EVENTS

Subsequent to December 31, 2024, the Plan was amended for the following provisions effective January 1, 2025:

- Increase 401(k) Employer Matching contributions to 100% of elective deferrals not exceeding 4.0% of payroll period compensation and 50% of elective deferrals not exceeding 4.0%-6.0% of payroll period compensation.
- Reduce Employer Basic Contribution to 1.5% of eligible compensation for each eligible participant.
- Provides for immediate 100% vesting of 401(k) Employer Matching contributions.
