Independent Auditor's Report

Plan Description

The following description of the 403(b) Thrift Plan for Area Office on Aging (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan covers all employees of the Area Office on Aging of Northwestern Ohio, Inc. (the Organization). Employees may enter the Plan on the day they are hired. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was effective as of April 1, 2015.

Contributions

Participants may contribute up to 100% of pre-tax annual compensation as defined in the Plan. The Plan also permits Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan has an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. The Organization contributes matching contributions equal to the lesser of 1% of annual compensation or 100% of the participant's deferral for the Plan year. Participants making deferrals become eligible to receive the Organization matching contributions after one year with at least 1,000 hours of service. The Organization also makes a base contribution equal to 2% of compensation for all employees who have completed one year of service. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Organization safe harbor matching contributions, as well as allocations of the Organization's non-elective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Description (continued)

Vesting

Participants are immediately vested in their contributions and the Organization's matching contributions plus actual earnings thereon. Vesting in the Organization's base contributions and the earnings thereon, is based on continuous years of service according to the following vesting schedule:

Years of Credited Service	Vested Percentage
Less than 1	0%
1	50%
2	75%
3 or more	100%

Investment Options

A participant may direct Organization and participant contributions in any of the various investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount permitted is \$1,000. There is no limit on the number of loans that a borrower may have outstanding under this Plan at one time. The loans are secured by the balance in the participant's account. The loan interest rate is determined on a per loan basis as defined in the Plan document. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to separation of service, disability or retirement, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or elect a partial withdrawal. For termination of service due to death of a participant, the beneficiary will receive a lump-sum distribution that will be equal to the participant's account. The participant's account will become fully vested upon the death of the participant or upon total permanent disability.

Forfeited Accounts

Forfeitures, if any, of Organization nonvested contributions shall be used to reduce the Organization's matching and base contributions. There were no forfeited Organization contributions at December 31, 2024 and 2023. There were no forfeitures utilized in 2024 and 2023.

Plan Description (continued)

SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There was no material impact to the Plan's 2024 or 2023 financial statements.

Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a settlement-date basis. However, differences between settlement-date and trade-date are immaterial. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from Plan participants and the Organization's contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The Plan's administrative expenses are paid by either the Plan or the Organization, as provided by the Plan agreement.

Information Prepared and Certified by the Custodians

Fair Value Measurements

U.S. GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

The level of the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Pooled Separate Accounts: Valued at fair value calculated based on the observable net assets value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Guaranteed Investment Contract

At December 31, 2023 the Plan held investments in the Mutual of America Interest Accumulation Account, which is a fully benefit-responsible guaranteed fixed annuity contract issued by MALIC which maintained the contributions in a general account. Coinciding with the change in third party administrator, the Mutual of America Interest Accumulation Account was liquidated into the Voya Fixed Account, which is a fully benefit-responsive investment contract that is available as an investment option to Plan participants. The contract is issued by VRIAC, which maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals. All guarantees are based on the financial strength and claims-paying ability of VRIAC and MALIC, which are solely responsible for all obligations under their contracts.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the investment contract. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings less participant withdrawals. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with VRIAC and MALIC, including (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No known events are probable of occurring that might limit the ability of the Plan to transact at contract value with VRIAC and MALIC and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow VRIAC and MALIC to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of VRIAC and MALIC.

Plan Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the participants' accounts will become fully vested.

Tax Status

Effective July 1, 2024 the Plan has adopted a volume submitter pre-approved 403(b) plan which has obtained its latest advisory letter on March 31, 2017, in which the Internal Revenue Service (IRS) stated that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Prior to July 1, 2024 the Plan had adopted a non-standardized pre-approved 403(b) plan which received a favorable opinion letter from the IRS dated March 31, 2017. The opinion letter stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan was qualified in the related trust was tax exempt as of December 31, 2024 and 2023, and no provision for taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees paid by the Plan to the custodians for administration and investment services approximated \$12,100 and \$900 during 2024 and 2023, respectively.

Change in Third Party Administrator

During 2024, the Plan transitioned from Mutual of America Life Insurance Company to Voya Retirement Insurance and Annuity Company as its third-party administrator effective July 1, 2024. The change was made due to a shift in service needs.

The Plan believes the change of administrator does not have a material effect on the measurement or presentation of plan net assets, participant accounts, or required disclosures in these financial statements.

Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.

Subsequent Events – Date of Management's Evaluation

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, the date the financial statements were available to be issued.
