### ***Opinion***

We have audited the financial statements of State Garden, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of the State Garden, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective August 1, 2021, the Plan was amended to change the name of the Plan to State Garden, Inc. 401(k) Retirement Plan. The Plan was formerly known as State Garden, Inc. 401(k) Profit Sharing Plan. The Plan was further amended and restated effective January 1, 2022.

The Plan is a defined contribution plan established to provide eligible employees of State Garden, Inc. (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

***Eligibility***

Prior to January 1, 2022, all Company employees, other than union employees, non-resident aliens, and leased employees are eligible to participate in the Plan if they have attained the age of 20½ and have completed three months of service. Immediately upon satisfying this requirement, employees will become automatically enrolled in the Plan at a deferral percent of 3%, increasing by 1%, annually, on the first day of the plan year until a deferral percent of 6% is reached.

Effective January 1, 2022, the Plan was amended to reduce the eligibility age and service requirements to 18 years and 2 months of service, respectively. Additionally, participants will be automatically enrolled in the Plan the first day of the month coinciding with or next following the date eligibility requirements are met.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Contributions***

Eligible participants may make voluntary contributions through salary reductions from 1% to 100% of their eligible annual compensation, as defined, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). The Plan also allows participants to defer funds as a "Roth 401(k) deferral." These deferrals are subject to federal income taxes and the maximum allowable contribution is \$23,000 combined between both the Roth and the pre-tax deferral. Participant rollover contributions are also permitted. Participants direct the investment of contributions made on their behalf into various investment options offered by the Plan. The Plan currently offers various mutual funds and common or collective trust funds as investment options for participants.

***Employer Contributions***

The Plan provides for a safe harbor contribution for all eligible participants. The safe harbor contribution is a non-elective contribution equal to 3% of a participants' eligible compensation, as defined.

The safe harbor non-elective contribution for the years ended December 31, 2024 and 2023 totaled \$614,434 and \$589,112, respectively, which was deposited into the Plan during the years ending December 31, 2025 and 2024. The Company may also make additional discretionary matching contributions and discretionary profit-sharing contributions including qualified non-elective contributions. There were no discretionary matching or profit-sharing contributions made for the year ended December 31, 2024.

Participants must have attained the age of 18 and completed one year of service to be eligible to receive safe harbor contributions, discretionary matching contributions, or discretionary profit-sharing contributions. Additionally, to receive discretionary profit-sharing contributions participants must be employed by the Company on the last day of the plan year.

**Participants’ Accounts**

Each participant’s account is credited with the participant’s contribution and its allocation of (a) the Company’s contributions, (b) plan earnings or losses, and (c) administrative expenses.

**Vesting**

Participants are immediately vested in their voluntary contributions and safe harbor non-elective contributions plus actual earnings thereon. Vesting in the Company’s discretionary contributions plus actual earnings thereon is based on the number of years of continuous service. Vesting begins after two years of service, as defined, with full vesting after six years of credited service as outlined in the table below:

In the event of death, disability, or attainment of age 65, participants’ accounts become fully vested.

**Payment of Benefits**

Upon termination of employment, retirement, attainment of age 59½, death or disability, the participant or the participant’s beneficiary is entitled to receive the vested portion of the participant’s account in a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special “hardship” reasons. Distributions to participants are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. All participant loans are subject to approval by the plan administrator and are limited to one loan at a time. Each loan bears interest at prime plus 1%. Loan terms generally may not exceed five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended up to ten years. Loans are secured by the balance in the participant’s account. Principal and interest is paid ratably through payroll deductions or an ACH agreement.

***Forfeitures***

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, may be used to pay administrative expenses of the Plan. The remaining forfeitures shall be used to reduce Company contributions. During the 2024 plan year, forfeitures of \$1,251 were used to pay administrative expenses. As of December 31, 2024 and 2023, the net forfeiture balance was \$6 and \$9, respectively.

***Cash Reserves and Other Income***

Certain mutual fund expenses, that are charged by the mutual fund companies to the individual participants (e.g., 12b-1, sub transfer agent), are recaptured by the Plan and held in a cash reserve account. These funds then benefit plan participants by paying for expenses of the Plan that are approved by the IRS, Department of Labor (DOL) and ERISA, such as administration and auditing fees. During the year ended December 31, 2024, these funds amounted to \$12, and are included as other income in the accompanying statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the balance in the cash reserve account was \$6 and \$35, respectively.

**Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed by the Plan.

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 7 for a discussion of fair value measurements.

Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Administrative Expenses***

The Company may, at its discretion, pay the expenses incident to administering the Plan. In the event that the Company does not pay the plan expenses, the expenses shall be paid by the Plan.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Contributions***

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the participant compensation is earned.

**Note 3. Tax Status**

The Plan uses a non-standardized pre-approved plan sponsored by the Sentinel Benefits Group, Inc. (Sentinel). Sentinel obtained its latest opinion letter dated November 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4. Risks and Uncertainties**

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 6. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such person.

Certain plan investments are shares of a mutual fund managed by Fidelity Brokerage Services LLC, the custodian of the Plan. In addition, certain plan investments are shares of common or collective trusts sub-advised by Sentinel Pension Advisors, Inc. (SPA), a division of Sentinel Benefits & Financial Group (SBFG). SBFG is the Plan's record-keeper, as defined by the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules, as defined by ERISA. Administrative expenses paid to third parties responsible for

financial advisory services were \$18,101 for the year ended December 31, 2024. Balances in the cash reserve held by a party-in-interest as of December 31, 2024 and 2023, amounted to \$6 and \$35, respectively.

**Note 7. Fair Value Measurements**

Accounting standards require that financial and non-financial assets and liabilities, recognized or disclosed in financial statements on a recurring basis (at least annually), be measured at fair value. These standards define fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

These standards also establish a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. These standards describe three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities that are accessible at the measurement date.
- Level 2** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for the assets or liabilities.
- Level 3** Unobservable inputs for the assets or liabilities that are significant to the fair value measurement. These inputs reflect the Plan's assumptions about the assumptions a market participant would use in pricing the asset or liability.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued based on the underlying unit value of the assets held. The trusts invest in listed equities and other investments that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to
