### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Employees' 401(k) Plan of RGC Resources, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Employees' 401(k) Plan of RGC Resources, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

### Note 1 – Plan Description

---

The following description of the Employees' 401(k) Plan of RGC Resources, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of RGC Resources, Inc. (the "Company") and its wholly owned subsidiaries (the "Plan Sponsor") who are at least 18 years of age and have completed at least two months of service. Temporary employees, seasonal employees, and interns are excluded from participating in the Plan unless they have completed 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2024, the Company changed its trustee from Principal Trust Company to Fidelity Management Trust Company. The Company also transitioned many of the individual investment choices within the fund to similarly situated Fidelity-managed funds. Once the transition was completed in July, participants had access to their Fidelity accounts.

#### *Contributions*

Each year, participants may contribute up to 50% of their annual eligible compensation on a pretax basis, as defined by the Plan subject to certain limitations. The Plan also allows Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

The Plan includes an automatic enrollment and automatic deferral increase feature. Automatic deferrals begin at 4% and increase 1% each year, to a maximum of 10%. The Employees may adjust or decline salary reduction contributions to the Plan at any time.

During 2024 and 2023, the Plan Sponsor made matching contributions of 100% of first 4% of eligible compensation; 50% of the next 2% of eligible compensation. Additional amounts may be contributed at the option of the Plan Sponsor's Board of Directors. For the years ended December 31, 2024 and 2023 the Plan Sponsor approved a 4% discretionary contribution, based on eligible compensation. This contribution is not applicable to key employees, officers, and those hired before January 1, 2017 and it requires employment on the last day of the year in which the contribution is made.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Plan Sponsor's matching and any additional contributions, allocations of earnings, and charged with an allocation of administrative expenses. Earnings are allocated by fund, based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are 100% vested in all contributions immediately upon entering the Plan.

### *Notes from Participants*

Participants may borrow from their accounts an amount greater than \$1,000 not to exceed the lesser of (1) \$50,000 reduced by the excess, if any, of the highest outstanding balance of the participant's loans during the one-year period before the loan over the outstanding balance of the participant's loans on the date of the loan; or (2) 50% of the participant's vested balance. Note terms range from one year to five years or up to ten years for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar notes as defined in the Plan. Interest rates on loans at December 31, 2024 were 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### *Payment of Benefits*

Distributions can be made due to retirement, death, disability, or termination of employment and are subject to the applicable provisions of the Plan agreement. Up to 100% of the participant's account balance can be paid in a lump sum, direct rollover to another qualified plan, or installments to the participant or their beneficiaries.

### *Administrative Expenses*

The Plan's administrative expenses, which include Trustee, investment management, and professional fees for services, are paid by either the Plan or the Plan Sponsor, as provided in the Plan agreement.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could

materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### *Benefit Payments*

Benefit payments are recorded when paid.

---

## **Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Galliard Stable Return Funds are collective investment trust funds owned at December 31, 2024 and 2023. These investments are composed primarily of investment contracts and security-backed contracts and are valued at the net asset value of units of the Galliard Stable Return Fund Core. The net asset value (NAV) is used as a practical expedient to estimate fair value.

This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is a twelve-month notice period if the Plan initiates a full redemption of the collective investment fund.

### Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

### Level 2 Fair Value Measurements

The fair values of collective investment funds have observable Level 2 pricing inputs and are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The collective investment funds invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the NAV of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

### **Note 4 – Investment Contracts**

The Plan has investments in the Galliard Stable Return Funds. Included in these funds are guaranteed investment contracts and certain wrapper contracts. These contracts are benefit-responsive and are required to be stated at fair value. The average yields for the funds are as follows:

The objectives of the Funds are to provide a moderate level of stable income without principal volatility.

### **Note 5 – Related Party Transactions**

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Principal Trust Company and Fidelity Management Trust company receive revenue from mutual fund and other investment fund service providers for services that they provide to the funds. Revenue sharing is remitted to participant accounts as a reduction of expenses or investment income, as defined in the Service Agreements. Administrative fees are charged ratably to all participant accounts, regardless of revenue sharing. Fees paid by the Plan for investment management and trust services amounted to \$22,262 and \$30,571 for the years ended December 31, 2024 and 2023, respectively. During 2024 and 2023, expense credits of \$3,854 and \$1,148 were used to reduce expenses. Administrative expenses are presented net of credits used.

### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

### Note 7 – Tax Status

---

The Company had adopted a prototype plan sponsored by Principal Trust Company. Effective July 1, 2024, the Plan document was restated to adopt a prototype plan sponsored by Fidelity Management Trust Company. The Internal Revenue Service (IRS) has determined by a letter dated June 30, 2020, that the prototype plans are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
