### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Continental Aerospace Technologies, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Continental Aerospace Technologies, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all salaried employees of Continental Aerospace Technologies, Inc. and its wholly-owned subsidiaries (the Company). It is a successor plan to the Teledyne Technologies Incorporated (Teledyne) 401(k) Plan and was created on April 21, 2011, the date of the sale of the Company to AVIC International Holdings Corporation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company's Administrative Committee (the Committee), which is a committee appointed by the board of directors of the Company. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Trustees.

#### **Contributions**

Each year, participants may elect to contribute up to 50% of their pre-tax annual compensation or make nondeductible (after-tax) contributions, as defined in the Plan, not to exceed the maximum amounts allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral percentage will increase by 1% per year up to a maximum of 6% of compensation unless changed by the participant.

## **NOTE 1 – DESCRIPTION OF THE PLAN (continued)**

### **Contributions (continued)**

For employees hired on or before December 31, 2010 who entered the Plan by May 30, 2011, the Company matches 100% of each participant's contribution (subject to an annual limit of \$8,250). Employees hired after December 31, 2010 or who has entered the Plan after May 30, 2011 receive a 50% Company match and are subject to the same annual limit (\$8,250). Effective August 1, 2024, for the employees receiving a 50% Company match, the Company's match calculation is also subject to a limitation of 10% of the employees' compensation. The employer may, at its discretion, make a Qualified Non-elective Employer Contribution for the Plan year in any amount it deems necessary for a permissible purpose.

Contributions are subject to certain IRS limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants hired on or before December 31, 2010 also vest 100% in employer matching contributions. For participants hired after December 31, 2010, employer matching contributions vest on a graduated service schedule which provides 20% vesting after one year of service and increases in equal annual increments until 100% vesting is reached after five years of service.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of the vested account balance or \$50,000. Fixed interest rates are charged on loans based on prevailing market rates at the date of the loan. Interest rates on participant loans as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are generally required in level amounts through payroll deductions on at least a quarterly basis. Loans are secured by the balance in the participant's account.

## **NOTE 1 – DESCRIPTION OF THE PLAN (continued)**

### **Payment of Benefits**

Upon retirement, termination, disability or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of time. Additionally, participants may take in-service distributions upon reaching age 59 ½. Upon termination, automatic distributions are required for balances of less than \$5,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Trustee. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 73. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

### **Forfeited Accounts**

If a participant is not fully vested on his or her termination date, the non-vested amount of the account is forfeited. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$152,371 and \$229,028 respectively. Forfeitures may be used to reduce the Company's matching contributions or to pay Plan expenses. During 2024 and 2023, the Company's matching contributions were reduced by \$122,331 and \$0 from forfeited non-vested accounts, respectively. Additionally, forfeitures of \$16,229 and \$12,035 were used to pay Plan expenses in 2024 and 2023, respectively.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

### **Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## **NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### NOTE 3 – FAIR VALUE MEASUREMENTS (continued)

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds are deemed to be actively traded.

*Stable value collective trust fund:* The stable value fund is composed primarily of fully benefit-responsive investment contracts valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments as of December 31, 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan). ## **NOTE 5 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fidelity Management Trust Company is the Trustee of the Plan and as such, holds the Plan's assets. Fidelity Trust Management is the third-party administrator of the Plan. Personalized financial planning and advice is offered to participants through Strategic Advisors, Inc., a subsidiary of Fidelity. Certain investments of the Plan are managed by Fidelity, as noted on the supplemental schedule on page 17. These relationships qualify as party-in-interest. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Regions Bank is the investment advisor to the Plan. The advisor is authorized to supervise and manage the Plan in accordance with the investment objectives set forth by the Plan sponsor. The advisor has full discretion with transactions involving the Plan's assets. The advisor's responsibilities also include advising individual participants regarding investment choices and objectives for their individual accounts. The advisor has fiduciary responsibility for investment advice for the Plan. This relationship qualifies as party-in-interest.

Smith, Dukes & Buckalew, LLP is the Plan's auditor. This relationship qualifies as party-in-interest.

Direct payments to parties-in-interest in 2024 and 2023 were \$68,761 and \$76,286, respectively.

The Plan sponsor paid directly any other fees related to the Plan's operations. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## **NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## **NOTE 7 – TAX STATUS**

The Company has adopted a non-standardized pre-approved profit sharing plan with CODA. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

## NOTE 7 – TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Company is aware of certain operational, plan document, or demographic issues that, if not properly corrected, could be treated by the IRS as qualification failures. Management is taking steps to correct these issues. If necessary, the tax qualification issues will be resolved directly with the IRS. Accordingly, management believes that the Plan will retain its tax-qualified status.

## NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## NOTE 9 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 5, 2025, the date at which the financial statements were available to be issued, and noted no material events requiring disclosure.
