## **Notes to Financial Statements December 31, 2024 and 2023**

---

### **Note 1: Description of Plan**

The following description of FordHarrison Associates & W-2 Partners 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan, originally established on April 1, 2020 and restated effective January 1, 2022, is a participant-directed defined contribution plan that includes all attorneys of Ford & Harrison, LLP (the Company or the Plan Sponsor) designated as associates, senior counsel, staff attorneys, Ford & Harrison Solutions Group consultants or W-2 partners and excludes leased employees, union employees, non-resident aliens, and all employees and self-employed individuals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Attorneys become eligible to participate in the Plan on the first payroll period following attainment of age 21 and 30 days of service. In addition, the Plan Sponsor elected an automatic contribution arrangement in which each attorney is automatically enrolled with a participant deferral contribution of 3% of eligible compensation, unless otherwise directed by the attorney.

#### **Transfers from/to Affiliated Plan**

During 2024, assets totaling \$1,252,502 were transferred from the FordHarrison Partner & Staff Profit Sharing Plan (the PS Plan) to the Plan and assets totaling \$2,680,227 were transferred to the PS Plan from the Plan. Asset transfers between the Plan and the PS Plan occur when a participant changes employment classification as described by the Plan's respective terms.

#### **Contributions**

Participants may make pre-tax and Roth 401(k) contributions to the Plan through payroll deductions up to 100% of their Plan compensation, as defined by the Plan Document, subject to the statutory limit set by the Internal Revenue Code (IRC). The limit for 2024 was \$23,000. Participants who have attained at least age 50 are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution was \$7,500 for 2024. Participants may also contribute amounts representing distributions or transfers from other qualified defined benefit or defined contribution plans (rollover contributions).

The Plan Sponsor may make discretionary matching contributions to the Plan. The discretionary matching contributions are made to all participants who are employed on the last day of the Plan year and who have completed 1,000 hours of service at the end of the 12-month period beginning with the first day of the participant's employment. During 2024 and 2023, the Plan Sponsor matched 50% of the participants' elective deferral contributions not in excess of 1.50% of eligible compensation. At December 31 2024 and 2023, discretionary matching contributions totaling \$253,635 and \$260,640, respectively, are reported as Plan Sponsor contribution receivable on the accompanying statements of net assets available for benefits.

The Plan Sponsor may also make a qualified non-elective contribution to the Plan. During 2024, the Plan Sponsor made qualified non-elective contributions totaling \$276.

## **Administration**

The Plan Sponsor serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. The Plan Administrator has engaged FuturePlan by Ascensus LLC and Transamerica Retirement Solutions, LLC (Transamerica) to assist in the administration of the Plan (Note 7).

Reliance Trust Company served as Custodian through June 30, 2024. Effective July 1, 2024, Transamerica Trust Company serves as Custodian of the Plan. State Street Bank and Trust Company served as Trustee through May 27, 2024. Effective May 28, 2024, Transamerica Trust Company serves as Trustee of the Plan. The Custodians receive all contributions made under the Plan, hold Plan assets, pay benefits to participants as directed by the Plan Administrator and assist in administration of the Plan. The Trustees serve as the intermediary for all asset purchases and redemptions and manage certain investment options of the Plan (see Notes 3 and 7).

## **Participant Accounts**

Each participant's account is credited with pretax, Roth and rollover contributions made by the participant and the participant's portion of Plan Sponsor contributions and actual Plan earnings thereon. The participant's account is also charged with withdrawals, applicable allocations of investment gains/losses and administrative expenses. Allocations are based on the participant's Plan compensation, account balances or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

## **Vesting**

Participants are immediately vested in their elective deferral contributions, rollover balances and investment performance thereon. Those attorneys who were previously participants in the FordHarrison Partner & Staff Profit Sharing Plan between January 1, 2017 and January 1, 2020 will vest at 25% per year until fully vested after four years. New entrants into the Plan after January 1, 2020 will vest in Plan Sponsor matching contributions and qualified non-elective contributions over a two to six year graded vesting scale.

## **Investment Options**

Participants are required to make participant-directed allocations of their accounts in increments totaling 100%, among various investment options offered by the Custodians and selected by the Plan Administrator. Participants may change their investment options daily.

## **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or the greater of 50% of their vested account balance up to \$100,000. Participants are limited to two outstanding loans at a time, secured by the participant's vested account balance and payable over a period not to exceed 5 years, unless for the purchase of the participant's primary residence. The interest rate on notes receivable from participants is a fixed rate based on the prime rate (as quoted in the Wall Street Journal) plus 1% on the day the loan is requested. Interest rates range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

## **Payment of Benefits**

Benefits are paid according to the vested interest in the account that the participant is entitled to upon retirement (age 65), termination, disability or death. Benefits are distributed to the participant or beneficiary in cash in a lump sum, as defined in the Plan Document.

In general, a participant may withdraw up to 100% of their vested accounts in the event of a participant's heavy and immediate financial hardship, as defined in the Plan Document. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant.

On termination of service due to death, disability, termination of employment or retirement, if the vested amount of the participant's account balance, including rollovers, does not exceed \$1,000 the participant's vested account balance will be distributed to the participant or their beneficiary directly in cash. If the vested amount of a participant's account balance is more than \$1,000 but less than \$5,000, the participant's vested account is distributed to the participant or their beneficiary either in cash, rolled over into an individual retirement account or rolled over into another qualified plan. If the vested amount of the participant's account exceeds \$5,000, the participant or their beneficiary has to consent to any distribution of the account.

The Plan Administrator will commence distribution of the participant's vested account balance without consent at the time that payments must begin under applicable federal law, generally the first of April following the later of the calendar year in which the participant attains age 73 (or 75 for those born in 1960 or later) or terminates employment. The Plan allows for in-service distributions on attainment of age 59 1/2.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service (IRS) penalties unless the distribution is transferred to another qualified plan or individual retirement account.

## **Forfeitures**

Separated participants who are not 100% vested forfeit the non-vested portion of their accounts at the end of the Plan year in which either their entire vested balance is distributed to them, or they experience five consecutive one-year breaks in service, whichever occurs first. The portion of forfeitures attributed to the discretionary matching contributions may be used to reduce Plan administrative expenses and/or future matching contributions. During the year ended December 31, 2024, forfeited non-vested accounts of \$3,667 were used to offset Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$41,338 and \$0 respectively.

## **Note 2: Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

## **Investment Valuation and Income Recognition**

Investments are reported at fair value, with the exception of the fully benefit-responsive investment contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4). Contract value represents contributions plus credited interest less participant withdrawals and fees (Note 5).

Purchases and sales of investments, including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes gains and losses on investments bought and sold during the year, as well as changes in unrealized appreciation and depreciation on investments held at year end.

## **Risks and Uncertainties**

The Plan's invested assets are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

## **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## **Payments of Benefits**

Benefit payments are recorded when paid by the Plan.

## **Administrative Expenses**

Administrative expenses of the Plan are liabilities of the Plan but may be paid by the Plan Sponsor. These expenses include, but are not limited to, legal, accounting and recordkeeping fees, and investment expenses. For administrative expenses not paid by the Plan Sponsor, a proportionate share of fees and expenses paid by the Plan is charged to each participant's account.

### Note 3: Information Certified by the Custodians (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the amounts for investment assets and transaction in those assets included in the accompanying financial statements and supplemental information and as outlined below as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was derived from information certified as complete and accurate by the Custodians in accordance with DOL regulations. As permitted under such election, the Plan's independent auditors did not perform any auditing procedures with respect to the following information certified by the Custodians, except for comparing such information certified by the Custodians to information included in the Plan's financial statements and supplemental information:

### Note 4: Fair Value Measurements

The accounting standard for fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes to the methodologies used at December 31 2024 and 2023.

- *Mutual funds and personal choice retirement accounts* – Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Note 5: Investment Contract

The Transamerica Stable Value Strategy Account held with Transamerica Life Insurance Company (TLIC) is a traditional investment contract. This contract meets the benefit-responsive investment contract criteria and therefore is reported at contract value. In accordance with Accounting Standards Update (ASU) 2015-12, contract value is the only relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The contract value of the Transamerica Stable Value Strategy Account represents contributions plus earnings, less participant withdrawals and administrative expenses. The contract issuer, TLIC, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The Transamerica Stable Value Strategy Account guarantees principal and two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently six months. The guaranteed minimum floor rate may change after the defined period, but it will not change for the six month period which it is effective.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events such as plan termination or a plan merger initiated by the Plan Sponsor may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable.

#### **Note 6: Income Tax Status**

The Plan Sponsor entered into a standard adoption agreement with Transamerica Retirement Solutions for a Volume Submitter Profit Sharing Plan with CODA (the Prototype Plan). The Prototype Plan received a favorable opinion letter from the IRS dated March 31, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

The Plan has not received an individual determination letter. However, the Plan Administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax exempt as of December 31, 2024.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 7: Party-in-Interest Transactions**

The Custodians, Trustees and Transamerica perform services for, sell products to, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. Transactions with these providers qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$65,897 for the year ended December 31, 2024, which are included as administrative expenses in the accompany statement of changes in net assets available for benefits. In addition, notes receivable from participants also qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subjected to the provisions of ERISA. In event of partial or full termination of the Plan, affected participants will become 100% vested in their accounts.

**Note 9: Subsequent Events**

The Plan Sponsor has evaluated subsequent events between December 31, 2024, the date of the statements of net assets available for benefits, and the report date, which is the date these financial statements were available for issuance and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
