NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Sightline Commercial Solutions 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a defined contribution plan which was established on January 1, 2023 and was last amended and restated effective November 1, 2023. The Plan covers substantially all employees (other than employees covered by a collective bargaining agreement, leased employees, non-resident aliens with no U.S. source income and project employees who do not meet other eligibility criteria and only work for the Company periodically) of Sightline Commercial Solutions, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions

Each year, participants may contribute up to the maximum allowable not to exceed the limits of Internal Revenue Code (IRC), as defined in the Plan. Employee deferral contributions may be made on a pre-tax or post-tax (Roth) basis. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. The Plan has an automatic contribution arrangement whereby newly eligible employees who have not made an affirmative election regarding Plan participation are automatically entered into the Plan at a 3% deferral rate. The 3% deferral rate will remain in effect until the participant makes an affirmative election to increase or decrease their contribution rate. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions (Continued)

The Company may contribute to the Plan discretionary matching and/or profit sharing contributions. Matching contributions, if any, are determined annually and may be a percentage of compensation or a fixed dollar amount. In addition, each year the Company may contribute a profit sharing contribution to the Plan. The Company's profit sharing contribution, if any, is allocated to participants using a pro rata allocation formula based on the ratio of each participants' compensation to total compensation for all qualifying participants. Participants direct the investment of their allocation of Company contributions, into various investment options offered by the Plan. Company contributions do not exceed the maximum amount deductible by the Company under the regulation of the IRC.

Participant Accounts

Each participant's account, which is valued daily, is credited with the participant elective deferrals, discretionary matching and profit-sharing contributions (if any) and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts (except for the Roth elective deferral portion of their accounts) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the participant's highest outstanding loan balance in the previous twelve months and the existing loan balance. Participants may only have one loan outstanding at any one time. Loan terms range from one to five years for general purpose loans or five to fifteen years for loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate of 1% over the Wall Street Journal Prime Rate of interest at the time of the loan. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document. Principal and interest is paid ratably through payroll deductions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested in their matching portion of their account after 2 years of service, upon reaching age 65, upon death or upon permanent disability. A participant is fully vested in their profit sharing portion of their account after 3 years of service, upon reaching age 65, upon death or upon permanent disability.

Termination of employment before any of the above occurs activates the following vesting schedule for the matching portions of their accounts:

Forfeited Accounts

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are first used to pay plan expenses with any excess forfeitures may be used by the employer to reduce profit sharing or matching contributions. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,531 and \$462, respectively. Forfeitures in the amount of and \$2,570 and \$474 were used to pay plan administrative expenses in 2024 and 2023, respectively. There were no forfeitures used to reduce employer contributions in 2024 and 2023. As of December 31, 2024 and 2023, there were no forfeited non-vested amounts available to pay plan expenses or reduce future employer match contributions.

Payment of Benefits

Upon termination of employment, death, disability or reaching normal retirement age (65), participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment, or in the form of non-recurring partial payments; or if the balance exceeds \$5,000, may elect to defer the distribution in accordance with Plan guidelines. If the participants' vested account balance is less than \$1,000, the Plan will distribute the participant's vested account balance in a lump-sum payment, with or without the participant's consent. If a terminated participant's balance is between \$1,000 and \$5,000, the Plan will distribute the participant's balance to an IRA setup for the benefit of the participant, absent any other direction from the participant.

The Plan allows for hardship withdrawals from the employee elective deferral, rollover, matching and profit sharing portions of the participant's account. The Plan allows for in-service distributions of participants' accounts upon the participant's attainment of age 59 ½ or normal retirement age (age 65). In-service distributions of rollover account balances are allowed at any time. Benefit payments are recorded upon distribution to participants.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. Dividends are recorded on the ex-dividend date. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Distribution processing fees as well as participant loan setup and maintenance fees are deducted from the benefits paid to participants and are shown as plan expenses in the statements of changes in net assets available for benefits along with certain recordkeeping and investment related expenses.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

The Board of Directors has appointed Ascensus Trust Company as Trustee of the Plan's assets. Ascensus Trust Company has supplied the Plan Administrator with certifications as to the completeness and accuracy of Plan investments and notes receivable from participants aggregating \$11,286,849 and \$8,772,815 as of December 31, 2024 and 2023, respectively, and the related investment income of \$1,280,496 and \$830,813, and interest on notes receivable from participants of \$12,407 and \$6,944 for the years ended December 31, 2024 and 2023, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on the certifications from Ascensus Trust Company.

Under the terms of the trust agreement, the Trustee manages investment funds on behalf of the Plan. The Trustee has been granted nondiscretionary authority concerning the purchases and sales of the Plan's investments. Therefore, the Trustee has been instructed on all purchases and sales of Plan investments by either the Company or each individual Plan participant when decisions affect their personal account balance and investments.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observed market-based inputs or unobserved inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

General Account investments: Fair value represents the value the Plan would receive if the various contracts were terminated, which is book value less any early withdrawal charges.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. Fair Value Measurements (Continued)

The methods described on the previous page may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants or their beneficiaries become 100% vested in all accounts and are entitled to a distribution of 100% of their account balances in all funds.

5. Plan Tax Status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for three years.

6. Concentration Risk

Individual investments representing 20% or more of the total investments subject the Plan to potential concentration risk. As of December 31, 2024 and 2023, investments over the 20% threshold were as follows:

7. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-in-interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Ascensus, LLC manages certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
