## Independent Auditors' Report

To the Employee Benefits Committee of the  
AGC Flat Glass North America, Inc. Employees Savings and Investment Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the AGC Flat Glass North America, Inc. Employees Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

**(1) Description of plan**

The following description of the AGC Flat Glass North America, Inc. Employees Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a defined contribution plan allowing eligible participants to direct their contributions and employer contributions to various investment options. Employees of AGC Flat Glass North America, Inc. and subsidiaries ("AGC", "Plan Sponsor" or "Employer") who are not subject to a collective bargaining agreement with AGC are eligible for participation in the Plan on their first date of employment ("participants"), subject to the requirements in the Plan with respect to the timing of any election of salary deferral contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Employer entered into an agreement to sell certain assets of its building glass division in August 2021. As a result of this transaction, certain participants were no longer employed by the Employer, and thus were no longer eligible to make contributions to the Plan, after September 30, 2021.

**(b) Contributions**

Employees electing to participate in the Plan may contribute pursuant to a salary deferral arrangement from 1% to 25% of their compensation. Salary deferral contributions are made through payroll deductions and are subject to the provisions of section 401(k) of the Internal Revenue Code ("IRC").

Annual additions to a participant's account may not exceed the maximum amount deductible for federal income tax purposes.

AGC currently matches 100% of participant contributions up to 3% of the participant's compensation and 50% of participant contributions greater than 3% but equal to or less than 5% of the participant's compensation. The AGC contribution is also limited to the maximum allowable deduction under the IRC and related regulations.

**(c) Participant accounts**

Each participant's account is credited (charged) with the participant's contributions, employer matching contributions, investment earnings (losses), and administrative expenses allocable to such participants. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(d) Vesting and forfeitures**

Participants are immediately vested in their contributions, employer contributions, and any allocated earnings and losses thereon. However, participants that transfer from other plans maintained by the Employer vest in the employer contributions and any allocated earnings and losses thereon that were received while participating in another plan according to the vesting schedule related to that plan. Upon termination, any amount in which the participant is not vested is forfeited and used to reduce AGC's contributions in succeeding plan years.

**(e) Participant notes receivable**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the respective balances in the participants' accounts and bear interest at fixed rates ranging from 4.25% to 9.50% as of December 31, 2024, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are collected ratably through payroll deductions.

**(f) Benefits**

Distributions of benefits are normally made in single lump-sum payments to participants upon severance from service, retirement or to designated beneficiaries in the event of death.

**(g) Allocation of trust income**

Daily income or loss is allocated to the individual participant's account based on that portion of net investment income or loss of each such fund in accordance with the applicable daily valuation date.

**(h) Hardship withdrawals**

The Plan permits distributions in the event of a hardship as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account.

**(i) Administrative expenses**

Administrative expenses are generally paid by the Plan and are reflected in the financial statements. Investment management expenses are included in Plan interest in Master Trust investment income.

**(j) Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The account balance of each affected participant will continue to be held in trust until the participant is entitled to a distribution under the Plan.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**(b) Investment valuation and income recognition**

The fair value of the Plan's interest in the AGC Flat Glass North America, Inc. Savings and Investment Master Plan Trust (the "Master Trust") is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and investment income less actual distributions, investment losses and allocated administrative expenses.

Investments are reported at fair value in the statements of net assets available for benefits. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) Participant notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

**(d) Payment of benefits**

Benefits are recorded when paid.

**(e) Use of estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(f) Events occurring after reporting date**

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and September 4, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

**(3) Certified Information**

AGC maintains a Master Trust, which includes assets for certain defined contribution plans. The Plan's and Master Trust's fair value of investments and participant notes receivable held at December 31, 2024 and 2023, and Plan interest in Master Trust investment income, and interest from participant notes receivable for the year ended December 31, 2024 have been certified by Fidelity Management Trust Company ("Fidelity"), as being complete and accurate in accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity has also certified the investments and investment activity shown in Notes (4) and (5) which present required disclosures of the Master Trust.

**(4) Fair value measurements**

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued at the net asset value ("NAV") of shares held by the Master Trust at year end in an active market.

Each participating defined contribution plan has a specific interest in the Master Trust. The assets of the Master Trust are held by Fidelity. Investment income is credited to each plan according to its specific interest in the investments in the Master Trust. Administrative expenses relating to the Master Trust are allocated to the individual plans based upon its proportionate share in the net assets of the Master Trust. All investments are participant directed.

**(6) Income tax status**

The Plan obtained a determination letter on November 15, 2017, in which the Internal Revenue Service ("IRS") stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since obtaining the determination letter. However, the plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable provisions of the IRC and is therefore qualified and exempt from taxation. The Plan is required to operate in conformity with the IRC to maintain its qualification.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) Related party and party-in-interest transactions**

Certain plan investments are shares of mutual funds and a collective trust fund managed by Fidelity and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note (1), the Plan paid expenses to various service providers which also qualify as party-in-interest transactions. The Plan also holds participant notes receivable, which also qualify as party-in-interest transactions.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the AGC Flat Glass North America, Inc. Employees Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**(1) Description of plan**

The following description of the AGC Flat Glass North America, Inc. Employees Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a defined contribution plan allowing eligible participants to direct their contributions and employer contributions to various investment options. Employees of AGC Flat Glass North America, Inc. and subsidiaries ("AGC", "Plan Sponsor" or "Employer") who are not subject to a collective bargaining agreement with AGC are eligible for participation in the Plan on their first date of employment ("participants"), subject to the requirements in the Plan with respect to the timing of any election of salary deferral contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Employer entered into an agreement to sell certain assets of its building glass division in August 2021. As a result of this transaction, certain participants were no longer employed by the Employer, and thus were no longer eligible to make contributions to the Plan, after September 30, 2021.

**(b) Contributions**

Employees electing to participate in the Plan may contribute pursuant to a salary deferral arrangement from 1% to 25% of their compensation. Salary deferral contributions are made through payroll deductions and are subject to the provisions of section 401(k) of the Internal Revenue Code ("IRC").

Annual additions to a participant's account may not exceed the maximum amount deductible for federal income tax purposes.

AGC currently matches 100% of participant contributions up to 3% of the participant's compensation and 50% of participant contributions greater than 3% but equal to or less than 5% of the participant's compensation. The AGC contribution is also limited to the maximum allowable deduction under the IRC and related regulations.

**(c) Participant accounts**

Each participant's account is credited (charged) with the participant's contributions, employer matching contributions, investment earnings (losses), and administrative expenses allocable to such participants. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(d) Vesting and forfeitures**

Participants are immediately vested in their contributions, employer contributions, and any allocated earnings and losses thereon. However, participants that transfer from other plans maintained by the Employer vest in the employer contributions and any allocated earnings and losses thereon that were received while participating in another plan according to the vesting schedule related to that plan. Upon termination, any amount in which the participant is not vested is forfeited and used to reduce AGC's contributions in succeeding plan years.

**(e) Participant notes receivable**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the respective balances in the participants' accounts and bear interest at fixed rates ranging from 4.25% to 9.50% as of December 31, 2024, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are collected ratably through payroll deductions.

**(f) Benefits**

Distributions of benefits are normally made in single lump-sum payments to participants upon severance from service, retirement or to designated beneficiaries in the event of death.

**(g) Allocation of trust income**

Daily income or loss is allocated to the individual participant's account based on that portion of net investment income or loss of each such fund in accordance with the applicable daily valuation date.

**(h) Hardship withdrawals**

The Plan permits distributions in the event of a hardship as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account.

**(i) Administrative expenses**

Administrative expenses are generally paid by the Plan and are reflected in the financial statements. Investment management expenses are included in Plan interest in Master Trust investment income.

**(j) Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The account balance of each affected participant will continue to be held in trust until the participant is entitled to a distribution under the Plan.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**(b) Investment valuation and income recognition**

The fair value of the Plan's interest in the AGC Flat Glass North America, Inc. Savings and Investment Master Plan Trust (the "Master Trust") is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and investment income less actual distributions, investment losses and allocated administrative expenses.

Investments are reported at fair value in the statements of net assets available for benefits. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) Participant notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

**(d) Payment of benefits**

Benefits are recorded when paid.

**(e) Use of estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(f) Events occurring after reporting date**

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and September 4, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

**(3) Certified Information**

AGC maintains a Master Trust, which includes assets for certain defined contribution plans. The Plan's and Master Trust's fair value of investments and participant notes receivable held at December 31, 2024 and 2023, and Plan interest in Master Trust investment income, and interest from participant notes receivable for the year ended December 31, 2024 have been certified by Fidelity Management Trust Company ("Fidelity"), as being complete and accurate in accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity has also certified the investments and investment activity shown in Notes (4) and (5) which present required disclosures of the Master Trust.

**(4) Fair value measurements**

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued at the net asset value ("NAV") of shares held by the Master Trust at year end in an active market.

**(5) Investments in Master Trust**

**(6) Income tax status**

The Plan obtained a determination letter on November 15, 2017, in which the Internal Revenue Service ("IRS") stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since obtaining the determination letter. However, the plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable provisions of the IRC and is therefore qualified and exempt from taxation. The Plan is required to operate in conformity with the IRC to maintain its qualification.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) Related party and party-in-interest transactions**

Certain plan investments are shares of mutual funds and a collective trust fund managed by Fidelity and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note (1), the Plan paid expenses to various service providers which also qualify as party-in-interest transactions. The Plan also holds participant notes receivable, which also qualify as party-in-interest transactions.
