Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements WW Healthcare Consultants, LLC 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

NOTE 1: PLAN DESCRIPTION

WW Healthcare Consultants, LLC (the Sponsor) established a 401(k) plan and related trust effective January 1, 2017. The following description of the WW Healthcare Consultants, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan available to substantially all employees of WW Healthcare Consultants, LLC and Affiliates, who are age 21 or older. The Plan excludes collectively bargained employees, leased employees, and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document. The Plan also allows Roth contributions, which are made on an after-tax basis. Annual pre-tax and Roth participant contributions are limited by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Sponsor may make a discretionary non-elective contribution to the Plan. There were no discretionary non-elective contributions for the years ended December 31, 2024 and 2023. In order to receive a non-elective Sponsor contribution, the participant must be employed on the last day of the Plan year. Contributions are subject to certain limitations.

Investment Options: Participants direct the investment of their contributions and the Sponsor's contributions into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, allocations of the Sponsor's contributions, and plan investment earnings. Participant accounts are charged with benefit payments, expenses, and plan investment losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's matching and discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes from Participants: Through August 19, 2019, participants were able to borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less, subject to certain restrictions. The loans are secured by the balance in the participant's account and bear interest at rates from 6.00% to 6.50%, which is commensurate with local prevailing rates as determined periodically by the plan administrator. Principal and interest is paid ratably through payroll deductions. The plan was amended effective August 20, 2019 to remove loans from the Plan. All outstanding loans have been paid in full during the year ended December 31, 2024. No new loans will be issued.

NOTE 1: PLAN DESCRIPTION (continued)

Payment of Benefits: On termination of service due to death, disability, retirement or any other reason, a participant may elect to receive the value of the participant's vested interest in his or her account in a lump sum or installment payments. The Plan allows for in-service distributions if a participant reaches age 59½. Roth in-plan rollovers and hardship distributions are available subject to Plan provisions. Upon termination of service, a participant with an account balance of less than \$5,000 will receive a lump sum distribution of their vested account balance without requiring the participant's consent.

Administrative Expenses: The Plan's administrative expenses primarily include investment management and professional fees for services provided by parties-in-interest. Certain administrative expenses are paid by the Plan as provided in the plan document. Certain additional administrative expenses are paid by the Sponsor.

Forfeitures: Forfeitures may be used to reduce Sponsor contributions into the plan or pay reasonable plan expenses. Forfeited non-vested accounts were \$34,337 and \$34,636 at December 31, 2024 and 2023, respectively. No amounts were used to reduce Sponsor contributions or to pay Plan expenses for the years ended December 31, 2024 or 2023.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan agreement.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 3 for discussion of fair value measurements.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Management has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued, and determined that, except as disclosed below, there were no subsequent events requiring disclosure.

Effective July 23, 2025 and October 1, 2025, the Plan was amended to allow certain employees of Companies acquired by the Plan Sponsor to participate in the Plan.

NOTE 3: FAIR VALUE MEASUREMENTS

The Plan's money market and mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

NOTE 4: PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

NOTE 5: INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by DST Retirement Solutions LLC. The Internal Revenue Service has determined and informed the Company, by a letter dated June 30, 2020, that the plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and therefore believes the Plan is qualified and the related trust is tax-exempt.

NOTE 5: INCOME TAX STATUS *(continued)*

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 7: RELATED-PARTY TRANSACTIONS

Certain Plan investments are funds managed by Reliance Trust Company (an FIS Company), the Custodian and T. Rowe Price Retirement Plan Services, the Recordkeeper. As the Custodian and the Recordkeeper of the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services were \$21,310 and \$22,015 for the years ended December 31, 2024 and 2023, respectively, to the Custodian and the Recordkeeper.

Certain administrative functions are performed by employees of the Sponsor. These employees are also Plan participants. No such employee receives compensation from the Plan.

NOTE 8: NONEXEMPT TRANSACTIONS

As of December 31, 2024, certain employee contributions and loan repayments the Sponsor failed to timely remit of \$16,288, \$831, \$3,242, \$7,722, and \$7,644 remain uncorrected for the years ended December 31, 2022, 2020, 2019, 2018 and 2017, respectively. These are deemed Prohibited Transactions in accordance with ERISA and the IRC. The Sponsor should correct the Prohibited Transactions by depositing lost earnings for impacted participants. There were no untimely employee contributions noted in 2024.
