We have performed audits of the accompanying financial statements of The Q Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets (deficit) available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available from benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Q Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of Plan

The following description of The Q Plan (the Plan) is provided for general information purposes only. For a more complete description of the Plan and plan investments, participants should refer to the summary plan description and individual investment prospectuses. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

General

The Plan is a defined contribution plan sponsored by QPS Employment Group, Inc. (the Sponsor) under Section 401(k) of the Internal Revenue Code (IRC). The Sponsor is the plan administrator.

Eligibility

Employees who customarily perform a majority of their services at the Sponsor's office are eligible to participate in the Plan. Highly compensated, leased, and temporary employees are not eligible to participate in the Plan. Employees age 18 and older who have completed 2 months of service in which at least 160 hours are worked, are eligible to participate in the Plan and receive discretionary matching contributions, if any. Participants must complete one year of service and 1,000 hours to be eligible to receive discretionary profit sharing contributions, if any. Employees are automatically enrolled at 1% pre-tax contribution rate after becoming eligible and each January 1st, the automatic participant deferral increases 1% per year up to a maximum of 6%, unless the participant elects to opt out of the increase.

Contributions

Each year participants may contribute up to 90% of their compensation, as defined by the Plan, not to exceed the maximum allowable under the Internal Revenue Service (IRS). Participants may also contribute distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor may elect to make discretionary matching contributions. The discretionary matching contribution for 2024 was 50% of the participant's contributions, up to 6% of eligible compensation. The Sponsor may also elect to make a discretionary profit sharing contribution. No profit sharing contribution was made for the 2024 Plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and an allocation of the Plan's investment earnings (losses) thereon and plan expenses. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan. The benefit to which a participant is entitled is the vested balance that can be provided from the participant's account.

Funding

The Sponsor remits participant elective contributions and Sponsor matching contributions to the Plan as soon as practical after the participant contributions have been withheld from participant wages. Sponsor profit sharing contributions, if any, are remitted annually.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon.

Vesting in the Sponsor's contribution portion of their accounts, plus actual earnings (losses) thereon, is based on the number of years of continuous service as shown by the following:

<i>Years of Service</i>	Vesting %
Less than 2 years	0 %
2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 or more years	100 %

Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during the Plan year. Upon termination of service due to death, disability, or retirement (age 65), participants become fully vested in their account balances.

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of the Sponsor's contributions may be used to reduce future Sponsor contributions or pay administrative expenses. Forfeitures of \$79,116 were used to reduce Sponsor contributions in 2024. Unallocated forfeitures as of December 31, 2024 and 2023, were \$1,209 and \$3,188, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan interest is determined at the time the loan is taken out and is paid back to the participants' accounts. Notes are secured by the balance in the participant's account and bear interest between 4.25% and 9.50% at December 31, 2024. Loans are immediately due upon the participant's termination. Loans must be fully repaid through payroll deductions within 5 years, unless it is used to acquire a primary residence. A participant can only have two loans at any given time.

Payment of Benefits

Upon termination of employment, death, disability, or retirement (age 65), a participant or designated beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance. In-service distributions may be made to participants who have not terminated employment if they have attained age 59 ½. Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes) from their account balance.

Secure 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from beginning effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the option provisions to elect in the future. The Plan is required to be amended in regards to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the accompanying financial statements and notes. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are stated at fair value, except for fully benefit responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2: Summary of Significant Accounting Policies (Continued)

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Administrative expenses directly attributable to a participant's transaction are deducted from that participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used in 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units held by the Plan at year-end. The NAV, as provided by the Custodians, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets of the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Fully Benefit-Responsive Investment Contract

The Plan maintains a fully benefit responsive investment in the Key Guaranteed Portfolio Fund through a guaranteed investment contract (GIC) with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on investments and charged for participant withdrawals and administration expenses. Empower is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The investment is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average crediting rate is approximately 1.41% for the year ended December 31, 2024. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Empower to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Custodians of the Plan.

Note 6: Income Tax Status

The Plan received a determination letter from the IRS stating that the Plan, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and, accordingly, the income of the Plan is tax exempt.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their account balances.

Note 8: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 9: Party-In-Interest Transactions

Transactions involving funds administered by the plan Custodians and administrative expenses are considered party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
