#### Note 1 – Plan Description

The following is a brief description of the Edge Technology Services, Inc. 401(k) Profit Sharing Plan (the “Plan”). Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution pension plan covering employees of Edge Technology Services, Inc. and Edge Employment Services (the “Company”), except per diem employees and employees covered by a collective bargaining agreement. Employees become eligible upon attaining age 21 and may enroll during the first open enrollment period after employment. Open enrollment is defined as the January 1, April 1, July 1 and October 1 immediately following the date of hire. The Plan provides for an automatic deferral election of three percent of Plan compensation, unless the participant completes a salary reduction agreement electing a zero deferral rate. The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Contributions

Each year, participants may make voluntary, pre-tax contributions of a percentage of annual compensation, as determined by the administrator, as defined in the Plan. Effective July 1, 2010, the Plan was amended to allow the salary deferrals as Roth deferrals. Participants may elect to defer up to 100% of any bonus paid during the year. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans at the discretion of the administrator. The maximum voluntary combination of pre-tax and after-tax contributions permitted by law was \$23,000 and \$22,500 for 2024 and 2023, respectively, per participant. Participants, who are at least age 50 by the end of the year, were allowed to contribute an additional \$7,500 in 2024 and in 2023, per participant. The Plan includes various tests required under ERISA, which has the effect of limiting contributions of highly paid employees.

The Company may elect to make a discretionary matching contribution equal to a uniform percentage of the amount of the salary reduction that employees defer. The Company may make a qualified, non-elective employer contribution on behalf of the non-highly compensated participants and non-key employees equal to a uniform percentage (to be determined annually by the Company) of compensation. Participants are eligible to receive the discretionary matching contributions if they have worked 1,000 hours in the respective plan year. To date, no discretionary matching or non-elective contributions have been made to the Plan.

The Company may make a discretionary profit sharing contribution. Participants must complete a year of service during the Plan year and be actively employed on the last day of the year in order to share in the discretionary profit sharing contribution. For 2024 and 2023, there were no discretionary profit sharing contributions made to the Plan.

#### Participant Accounts and Vesting

Each participant's account is credited with the participant's contribution and rollover contribution, the allocation of the Company's contribution and Plan earnings, and charged with certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in their contributions and the qualified non-elective contribution portions of their accounts, plus actual earnings, at all times and shall not be subject to forfeiture for any reason. Participants vest in the Company's matching contribution and discretionary profit sharing contribution 100% after completion of three years of service.

#### Notes Receivable From Participants

Subject to terms and conditions imposed by applicable tax regulations, participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Loan terms range from one to five years, or for a longer period if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable interest rate. Loan repayments are made through a payroll deduction. A loan default resulting in a taxable distribution (and early withdrawal penalties) will occur if payment is not made by the end of the calendar quarter following the calendar quarter in which the payment was missed.

#### Retirement

Normal retirement is defined as age 65. Early retirement is available at age 59½. The participant may elect to receive the retirement benefits in a lump sum, or alternate form of payment, as permitted in the Plan.

#### Payment of Benefit

Upon retirement, hardship or termination, or for termination of service for other reasons, vested benefits can be distributed in either a lump sum benefit or an alternative form of payment, as permitted under the Plan. If the participant's vested benefit does not exceed \$5,000, the plan administrator may direct the custodians to distribute, in a lump sum payment, the participant's vested benefits.

#### Corrective Distributions

In accordance with the requirements of the Internal Revenue Service (IRS), the Plan is subject to compliance tests. These tests are designed to ensure that the Plan is in compliance with IRS regulations, which limit the amount of contributions and additions permitted in a participant account during the Plan year and also limit the contributions of highly compensated employees (HCEs).

For the Plan years ended December 31, 2024 and 2023, the Plan was determined to have passed the average deferral compliance test and, therefore, no liability was recorded on December 31, 2024 or 2023.

**Forfeited Accounts**

As of December 31, 2024, and 2023, forfeited nonvested accounts totaled \$1,386 and \$1,338, respectively. Nonvested amounts treated as forfeitures are to be first applied to pay Plan expenses and then to reduce future Company contributions.

**Investment Options**

Contributions are invested according to the options elected by the participants among the then available investment options. The investment options include various mutual funds and a stable value common collective trust, which provides participants the opportunity to select from various returns on investment alternatives.

**Subsequent Events**

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting, prescribed by the Department of Labor's Rules and Regulations for Reporting and Disclosure Under ERISA.

**Estimates**

The preparation of the Plan's financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

All expenses of maintaining the Plan are paid by the Company, except for participant-generated transaction fees and investment management services.

**Note Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as an administrative expense and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Note 4 – Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual Funds*

The fair value of mutual funds is based on the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust*

The fair value of common collective trusts is based on the Net Asset Value practical expedient, which is based on the fair value of the underlying assets held in the Common Collective Trust. Unit Value of the Common Collective Trust is determined by dividing the fund's net assets at fair value by its units outstanding at the valuation date.

#### **Note 5 – Related Party Transactions and Party-in-interest Transactions**

Certain plan investments are shares in mutual funds managed by Fidelity Investments, which is an affiliate of the trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment.

#### **Note 6 – Plan Tax Status**

The Plan obtained its latest determination letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. Plan management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 7 – Plan Terminations**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

#### **Note 8 – Risks and Uncertainties**

The Plan's investments are concentrated in funds that invest in marketable equity securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 9 – Reconciliation of Financial Statements to IRS Form 5500**

There were no material differences between the accompanying statements of net assets available for benefits and changes in net assets available for benefits and IRS Form 5500, Annual Return/Report of Employee Benefit Plan, filed with the U.S. Department of Labor and the Internal Revenue Service.
