NOTE A. DESCRIPTION OF THE PLAN

The following description of the Matson Lumber Company 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor 401(k) profit sharing plan covering all employees of Matson Lumber Company and Matson Industries, Inc. (collectively, the Company) who have at least one year of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The administrative committee oversees governance of the Plan. The Plan’s investment committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s administrative committee.

Contributions

The Plan is funded through employer contributions and both pre-tax and Roth employee payroll deductions. Each year participants can elect to defer a percentage of their annual compensation to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The participant can also elect to defer up to 100% of any bonuses paid to them during the year. The total amount a participant may defer in any tax year is limited to a maximum dollar amount as determined annually by the Internal Revenue Service.

In addition, the Company will make a matching contribution for all eligible participants. This matching contribution will be equal to 100% of the participant’s salary deferrals that do not exceed 3% of compensation plus 50% of all deferrals between 3% and 5% of compensation. The Company may also make a discretionary profit sharing contribution each year for participants employed on the last day of the plan year. There was no profit sharing contribution in 2024.

Effective October 31, 2023, the Plan allows for In-Plan Roth conversions where participants can be converted from a pre-tax basis to a Roth tax basis. The participant will be taxed on the amount converted in the year the conversion is made.

Participant Accounts

Each participant's account is credited with the participant's respective deferral and allocations of the Company's basic match contribution, profit sharing contribution, and plan earnings. Participant accounts are charged with an allocation of certain investment and administrative expenses that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In addition, their accounts are credited with the change in cash surrender value of the participants' individual life insurance policies less annual renewal fees for the policies held within the Plan.

Vesting

Participants are immediately 100% vested in amounts attributable to salary deferrals and basic Company match contribution. A participant is 100% vested in their discretionary profit sharing contribution after six years of credited service.

Payment of Benefits

Upon termination of service, if a participant's vested benefit in the Plan does not exceed \$5,000, the participant's benefit will be distributed in a single lump sum payment. If the vested benefit in the Plan exceeds \$5,000, then the participant must consent to the distribution before it may be made. The participant may elect to receive a distribution in either a single lump sum payment in cash or installments over a period of not more than an assumed life expectancy (or the assumed life expectancies of the participant and his or her beneficiary). Effective April 30, 2024, if a participant makes no election, the amount will be automatically rolled over to an IRA provided the amount is at least \$75.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used by the Plan for several purposes such as the payment of Plan expenses. Any remaining forfeitures will be allocated in the same proportion that each participant's compensation bears to the total compensation of all participants. At December 31, 2024 and 2023, forfeited and non-vested accounts totaled \$448 and \$458, respectively.

There were no forfeitures used to offset administrative expenses or employer contributions in 2024.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Effective January 1, 2020, the Plan was amended to implement hardship distribution provisions of the Bipartisan Budget Act of 2018 and no longer requires elective deferrals to be suspended following a hardship withdrawal.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Investments in life insurance contracts are valued at estimated cash surrender value as provided by the insurance carrier.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Reclassification

Amounts in the prior period's financial statements are reclassified wherever necessary to conform to current period presentations.

Date of Management's Review

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

NOTE C. CERTIFICATION OF FINANCIAL INFORMATION

Charles Schwab Trust Bank, the trustee of the Plan, has certified that the investment information related to cash, mutual funds, and common collective trust summarized in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, is complete and accurate.

NOTE D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The administrative committee, in conjunction with the Plan's investment advisor (Schneider Downs Wealth Management Advisors), determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority.

NOTE D. FAIR VALUE MEASUREMENTS (CONTINUED)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Mutual funds are public investment vehicles values using the NAV provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

The cash surrender value of life insurance contracts with an insurance company is not actively traded and significant other observable inputs are not available. Thus, the fair value of the cash surrender value of life insurance contracts is the cash value of the policy that is redeemable if cancelled prior to maturity as determined by the insurance company and is classified within Level 3 of the fair value hierarchy.

The fair value of the stable value collective trust fund is measured at the NAV of each account on the last day of the plan year. The NAV is based on the market value of the underlying assets.

NOTE F. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The plan sponsor, Matson Lumber Company, provides the Plan with certain accounting and administrative services for which no fees are charged. In addition, the Plan has a money market fund with Charles Schwab Trust Bank, the trustee, as defined by the Plan. Fees paid by the Plan for investment and administrative services amounted to \$58,498.

Members of the management team are currently participants in the Plan and one member serves as the plan administrator. In addition, Matson Lumber Company directly pays certain administrative expenses for the Plan.

All of these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE G. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE H. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated August 1, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

NOTE H. TAX STATUS (CONTINUED)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE J. LIFE INSURANCE POLICIES

In prior years, the Plan purchased whole life, flexible premium insurance policies as investment options for the benefit of certain individual participants. All premiums were paid from the appropriate participant's 401(k) account. All of the insurance policies were purchased through a related party and qualify as party-in-interest transactions. The Plan no longer provides for participants to purchase life insurance policies.
