The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Tri-State Memorial Hospital, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Internal Revenue Code (the "Code") Section 403(b) covering all employees of Tri-State Memorial Hospital, Inc. (the "Hospital") who are in a covered employment classification. There are no minimum age and service requirements to make salary reduction contributions. Employer contributions are made for eligible employees who have attained age 18, and have completed one year of service. As of March 1, 2019, there are no exclusions of employment classifications for deferrals. An employee must be 18 years of age to be eligible for the Hospital discretionary match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans ("rollovers"). The Hospital contributes a matching contribution that is based on the participant's total compensation. See the following table for employer match detail. Additional discretionary amounts may be contributed at the option of the Hospital's Board of Directors. The Hospital may not make a contribution to the Plan for any Plan year to the extent the contributions would exceed the participant's maximum permissible amount. For the Plan year ended December 31, 2024, the Hospital's employer matching contributions were \$1,919,080. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants hired prior to January 1, 2011 receive Hospital matching contributions based on employee deferrals of (1) 1% employee contribution results in 1% Hospital match, (2) 2% employee contribution results in 5% Hospital match, (3) 3% employee contribution results in 6% Hospital match, and (4) 4% employee contribution or more results in 8% Hospital match.

Note 1: Description of Plan (Continued)

Contributions (Continued)

Participants hired after January 1, 2011 receive Hospital matching contributions based on employee deferrals and years of service of (1) a participant with less than 1 year of service will receive Hospital matching contributions equal to 100% of salary deferrals not to exceed 1% of plan compensation, (2) a participant with 1 year of service but less than 2 years of service will receive Hospital matching contribution equal to 100% of salary deferral that do not exceed 2% of plan compensation, (3) a participant with 2 years of service but less than 3 years of service will receive Hospital matching contribution equal to 100% of salary deferrals that do not exceed 3% of plan compensation, (4) a participant with 3 years of service but less than 4 years of service will receive Hospital matching contribution equal to 100% of salary deferrals that do not exceed 4% of plan compensation, (5) a participant with 4 years of service but less than 5 years of service will receive Hospital matching contributions equal to 100% of salary deferrals that do not exceed 5% of plan compensation, (6) a participant with 5 or more years of service will receive matching contributions equal to 100% of salary deferrals that do not exceed 6% of plan compensation.

Investment Options

Participant contributions and Hospital's matching and discretionary contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Hospital's contributions, and charged with an allocation of Plan earnings (losses) and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All investments of the Plan are participant-directed. Participants have the option of directing their account balance to one or more different investment options, which cover a wide range of fund objectives and risk.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Participants vest in their matching contributions at a rate of 33% per year. Participants become fully vested after three years of service.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

A participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the greater of \$10,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate determined by the plan administrator based on prevailing market conditions. Principal and interest are paid ratably through quarterly payments.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments, if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for in-service distributions upon attaining age 65.

Administrative Expenses

Certain administrative fees are absorbed by the Hospital and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Hospital before becoming 100% vested in the Hospital's contributions. These forfeitures may be used to pay administrative expenses or reduce employer matching or discretionary contributions in accordance with the plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,889 and \$937, respectively. Forfeitures were used to reduce employer contributions for the year ended December 31, 2024, in the amount of \$19,172.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and custodians. See Note 4 for discussion of fair value measurements.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

The Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Lincoln National Life Insurance Company and Lincoln Financial Trust Company, Inc., the custodians of the Plan.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Fair value is estimated using the net asset value (NAV) per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Fair Value Measurements (Continued)

The pooled separate accounts are designed to deliver a return consistent with the mutual funds in which they invest. The NAV of each of the separate accounts is calculated in a manner consistent with GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. Several of the separate accounts invest in publicly quoted mutual funds or actively managed stock. Some of the separate accounts also invest in fixed income securities. The fair value of the underlying mutual funds or stock and of the underlying securities, which is based on quoted prices of similar assets, is used to determine the NAV of the separate account which is not publicly quoted. There are currently no redemption notice requirements and no redemption restrictions on these investments. The separate accounts allow for immediate redemption for participant transactions. The separate accounts do not have an unfunded commitment.

Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan has one fully benefit-responsive guaranteed investment contract (GIC) with The Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a pooled account which is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with Lincoln and is based on the individual contracts in place.

Such interest rates are reviewed on a quarterly basis depending on the contract for resetting, with guaranteed minimum interest rate credited daily and not less than the guaranteed minimum interest rate. The minimum guaranteed rates on the contract range from 1% to 3%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all of their Hospital contributions.

Note 7: Tax Status

The Sponsor adopted a Volume Submitter Plan which is based on a pre-approved plan document to be in compliance with applicable sections of the IRC. The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and no provision for income tax has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments including the guaranteed investment contract and pooled separate accounts are managed by The Lincoln National Life Insurance Company. The Lincoln National Life Insurance Company is a custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$129,224 for the year ended December 31, 2024. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment.

Certain Plan decisions are managed by D.A. Davidson & Co. D.A. Davidson & Co. provides consultant services for the Plan and is defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for consultant services amounted to \$69,848 for the year ended December 31, 2024.

The plan administrator is also a participant. There are no transactions with this party other than in the ordinary course of business.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.
