Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Griffin Masonry Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

1. DESCRIPTION OF PLAN

The Griffin Masonry, Inc. Retirement Savings Plan (the Plan) is sponsored by Griffin Masonry, Inc. (Company). The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401 of the Internal Revenue Code. The Plan covers substantially all employees of the Company who have one year of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Employees may defer up to 100% of their compensation, as defined by the Plan, up to limited amounts prescribed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Effective November 3, 2023, the Plan allows for after tax contributions. The Company makes matching contributions of a maximum of 2% of a participant's eligible compensation. The Company may also make discretionary matching contributions.

Forfeited Accounts

Forfeited non-vested amounts are used to reduce administrative expenses or Company contributions to the Plan. Forfeited non-vested accounts as of December 31, 2024 and 2023 totaled \$7,216 and \$13,095, respectively. Plan fees of \$10,296 were paid with forfeited funds during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, net earnings or losses associated with their investments and an allocation of Plan expenses. Allocated earnings and expenses are based on participant account balances or earnings, as defined by the Plan. Participants may direct the investment of their account as allowed by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime plus 1 percent, which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. Principal and interest is paid ratably through payroll deductions over a term not to exceed 5 years; however, terms may exceed five years for the purchase of a primary residence. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

1. DESCRIPTION OF PLAN, CONCLUDED

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or retirement (defined as reaching age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump-sum distribution. Partial withdrawals are permitted for participants who must receive required minimum distributions. Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

Investment Options

Participants are afforded several investment options covering a wide range of investment objectives and risks. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time. All investments are participant directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of certain contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONCLUDED

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are recorded when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Interest rates range from 4.25%-9.5% at December 31, 2024.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through the date of the audit report which was the date the financial statements were available to be issued.

3. INVESTMENTS

The Plan's investments were held in trust and administered by the trustee, Fidelity Management Trust Company for the years ended December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

4. FAIR VALUE MEASUREMENTS

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:
quoted prices for similar assets or liabilities in active markets;
quoted prices for identical or similar assets or liabilities in inactive markets;
inputs other than quoted prices that are observable for the asset or liability;
inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS, CONCLUDED

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund

The Plan invests in the Fidelity Advisor Stable Value Fund, a common/collective trust (CCT) fund. This CCT invests in fully benefit-responsive investment contracts issued by insurance companies and other financial institutions. Guaranteed investment contracts (GIC) are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The GIC is considered an indirect investment in FBRICs which is carried at fair value using net asset value practical expedient. Therefore, it is not carried at contract value in the statements of net assets and is not categorized within the fair value hierarchy.

The fund had no unfunded commitments at December 31, 2024 and 2023. Participant level transactions take place daily; typically, the liquidation would be processed one business day after requested. Plan level liquidations require notice to Fidelity and could result in the Plan's investment in the stable value fund being placed into an investment only account for up to 12 months.

5. EXCESS PARTICIPANT CONTRIBUTIONS PAYABLE

The Plan did not pass the Average Deferral Percentage (ADP) Test for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$23,027 and \$31,624 plus earnings of \$2,469 and \$4,421 on those contributions were recorded as a liability in the accompanying statements of net assets available for benefits at December 31, 2024 and 2023, respectively. These excess contributions were refunded to highly compensated employees in accordance with the applicable federal regulations in 2025 and 2024, respectively.

The Company adopted a non-standardized plan prototype. This prototype plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service states that the Plan as designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC), and is therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if it has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator feels the Plan had no such positions at December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by Fidelity Management Trust Company (FMTC), the trustee of the Plan and also provides recordkeeping services; therefore, these transactions qualify as party-in-interest. Fees paid to FMTC in 2024 was \$3,646.

The Plan sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. The Plan sponsor also pays for some administrative expenses for the Plan for which no reimbursement is received from the Plan.
