## Notes to the Financial Statements

---

### A. Description of the Plan

The following brief description of the Brothers Produce 401(k) Plan (plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

#### General

The plan is a defined contribution plan covering all employees of Brothers Produce (the “company”) except union employees, nonresident aliens or leased employees, who have completed at least three months of service, and are age eighteen or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### Contributions

Participants may contribute up to the maximum amount allowed by law. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All employees who are eligible to make elective deferrals under this plan and who have attained the age of 50 before the close of the plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the Code.

The company may also make discretionary matching and profit-sharing contributions. The company’s discretionary matching and non elective contributions will be allocated among all eligible participants on a pro rata basis using a fraction calculated by dividing each participant’s compensation by the total compensation for all eligible participants. The plan provides a traditional automatic enrollment at 2% of compensation increasing by 1% per year up to a maximum of 5% of compensation. The increase will take effect as of the first day of each plan year.

#### Participant’s accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the company’s contribution and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are 100% vested in the their contributions to the plan plus actual earnings thereon. Vesting in the discretionary company matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants not fully vested receive rights to the company’s contributions as follows:

##### **Payment of benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

##### **Notes receivable from participants**

The plan does not currently permit loans to participants.

##### **Forfeitures**

Accumulated forfeitures are available to fund company contributions or pay reasonable plan expenses. Accumulated forfeitures are \$108,908 and \$40,972 for 2024 and 2023, respectively. No forfeitures were used during 2024.

#### **B. Summary of Significant Accounting and Reporting Policies**

##### **Basis of accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note C for a discussion of fair value measurements.

##### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Operating expenses**

Certain administrative expenses of maintaining the plan are paid by the company. Contract administrative fees are paid by the plan.

##### **Subsequent events**

The plan has evaluated subsequent events through October 02, 2025, the date the financial statements were available to be issued.

##### **Notes receivable from participants**

The plan does not currently permit loans to participants.

#### **C. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Variable annuities:* Valued at the net asset value (NAV), as determine by quoted prices of a comparable asset in an active market.

#### **D. Guaranteed Interest Account**

The plan entered into a traditional fully benefit-responsive investment with Empower Trust Company totaling \$136,508 at December 31, 2024 and \$88,465 at December 31, 2023. Empower Trust Company maintains the Plan contributions in this investment in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the plan. Accordingly, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. For example, premature termination of the contracts by the Plan, Plan termination, bankruptcy, mergers, and failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any event which would limit the Plan's ability to transact at contract value with participants is probable of occurring.

#### **E. Related Party and Party In Interest Transactions**

During 2024, the plan investments were managed by Empower Trust Company. Empower Trust Company is the custodian as defined by the plan and, therefore, these transactions qualify as party in interest transactions.

#### **F. Plan Termination**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

#### **G. Tax Status**

On June 30, 2020, the IRS stated that the prototype adopted by the plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan's tax counsel believe that the plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements.

#### **G. Tax Status – Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **H. Risks and Uncertainties**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **I. Custodial Certification**

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Empower Trust Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a.* Total investments as shown in the accompanying statements of net assets available for benefits of \$2,966,636 as of December 31, 2024, and \$2,554,888 as of December 31, 2023.
- b.* Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$259,254 for the year ended December 31, 2024.
