Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Plan Description

The following description of the CPAP 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering eligible employees of US Expeditors, LLC, dba CPAP.com (the Company) and was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 2015 and had since been amended and restated. The Company served as the plan administrator and, among other matters, was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings and monitored investment performance. For the period from April 18, 2024 through December 13, 2024, Ascensus Trust Company, LLC served as the Plan's trustee. Prior to April 18, 2024, Newport Trust Company, LLC served as the Plan's trustee.

Plan Merger

Effective December 1, 2024, the Company elected to merge the Plan into The Standard Pooled Employer Plan (The Standard PEP). Concurrently, the Plan was amended and restated effective December 1, 2024 to facilitate the merger. Plan assets totaling approximately \$4,028,000 were transferred to The Standard PEP, with the final transfer taking place on December 13, 2024.

Eligibility

The Plan was provided for all eligible employees of the Company who had completed six consecutive months of service and were age 18 or older. If an employee did not complete six consecutive months of service, he/she was eligible upon completion of one year of service, defined as a 12-month period with at least 1,000 hours of service. Leased employees were not eligible to participate in the Plan. Participants could enter the Plan on the first day of the month after satisfaction of the eligibility requirements. The Plan included a savings feature designed to permit the employee and the Company to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Employees could elect to defer up to 100% of their compensation, as defined, as either pre-tax or Roth 401(k) deferrals, subject to amounts allowed under the IRC. Eligible employees who had attained age 50 before the end of the plan year were eligible to make catch-up contributions subject to limitations of the IRC. Rollover contributions were permitted from qualified retirement plans and certain individual retirement accounts.

Employees automatically began deferring 3% of their compensation for each payroll period after meeting the eligibility requirements, unless an affirmative election not to contribute or to contribute at a different percentage was made by the employee. The initial automatic deferral percentage would also increase by 1% on the first day of each year up to a maximum of 6%. The contributions were made on a pre-tax basis unless the employee affirmatively designated that any portion or all the contributions be treated as Roth contributions.

The Company could make discretionary matching contributions on behalf of eligible employees. During 2024, the Company matched 100% of each employee's deferrals up to 1% of eligible compensation and matched an additional 30% of each employee's deferrals in excess of 1% of eligible compensation, up to a maximum of 4%.

Vesting

Participants were immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Vesting in Company contributions was based on years of service. A participant's interest in Company contributions began at 20% after two years of service and increased 20% for each additional year of service until the employee was 100% vested after six years. Regardless of the vesting schedule, participants became fully vested upon death, normal retirement age or total and permanent disability.

Forfeitures

Forfeitures attributable to non-vested employer contributions could be used to pay administrative expenses and/or reduce future employer contributions. There were \$38,776 of unallocated forfeitures available at December 31, 2023. No forfeitures were utilized to offset employer matching contributions or pay administrative expenses during 2024. During December 2024, the forfeiture balance of \$44,807 was transferred to The Standard PEP.

Participant Accounts

Upon enrollment in the Plan, a participant could direct the investment of his or her account balance. Participants could change their investment options at any time.

Under the Plan, each participant's account was credited with the participant's contribution, the Company's matching contribution, and plan earnings and losses, and charged with certain transactional fees.

Benefit Payments

Distributions could be made to participants or their beneficiaries upon termination of employment, retirement, disability or death. In-service distributions were permitted for participants who had reached the age of 59½ or normal retirement age, as defined. Additionally, hardship withdrawals could be made to active participants who had demonstrated financial need, subject to the provisions of the Plan.

Upon termination, participants with an account balance of \$5,000 or less had their funds automatically rolled over to an individual retirement account. Withdrawals from the Plan could be subject to income taxes on contributions and income earned.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments of the Plan were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation in the fair value of investments included realized gains or losses on investments sold during the year, as well as unrealized gains or losses on investments held at the end of the year.

Benefit Payments

Benefits paid to participants or beneficiaries were recorded when paid.

Administrative Expenses

Certain transactional fees were paid by the participants. All other administrative costs were paid by the Plan, unless paid by the Company at its discretion. Investment-related expenses were included in net appreciation in the fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with GAAP required the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could have differed from those estimates.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Subsequent Events

The plan administrator evaluated events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual Funds: These funds were valued daily based upon their quoted market prices.

Common/Collective Trust Fund: This fund was valued at its net asset value (NAV) as determined by the issuer based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV was used as a practical expedient to estimate fair value. The practical expedient was not used when it is determined to be probable that the investment would be sold for an amount different than the reported NAV.

Note 4 - Information Certified by the Plan's Trustees

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Ascensus, LLC (on behalf of Ascensus Trust Company and Newport Trust Company, LLC) as of December 13, 2024, and for the period from April 18, 2024 through December 13, 2024, and from Newport Trust Company, LLC as of December 31, 2023, and for the period from January 1, 2024 through April 17, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and the accompanying notes to the financial statements as to investments and investment income is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the accompanying notes to the financial statements.

Note 5 - Plan Termination

Prior to the merger into The Standard PEP, the Company had the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Federal Income Tax

The pre-approved plan document adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan document had been amended since receiving its IRS letter; however, the plan administrator believed that the Plan continued to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
